Flue Stack material

The applicant has submitted a reasoning for the material that is proposed which is summarised below:

The stack is an integral part of the structure of the building and been designed accordingly. It contains 4 no. separate flues enveloped by a staircase required for maintenance and future sample testing of emissions. A number of materials, textures and colours with particular regard to ensuring a cohesive solution to the buildings appearance and its visual impact on the existing sensitive environment.

A number of colours were considered including varying shades of blue, white, off-white, light grey and dark grey with the intent to blend in with the skyscape whilst also investigating the possibility of using shades of green, particularly at lower level to tie in with the landscape. Fundamentally it was intentional to incorporate the stack within the design ethos of the main building. Other materials were contemplated including steel mesh, perforated metal cladding and stainless steel. It is noted that during consultation the suggestion of a stainless steel stack was raised. This was discounted primarily from a visual impact point of view. Although the finish would reflect the sky it would also reflect everything else, particularly the sun, causing glare for, in clear conditions, the whole day. This would 'circle' the stack and without question impact upon Flag Fen. A stainless steel stack would give a more industrial appearance, again, not felt to be in keeping with the heritage asset close by and would detract from the carefully considered elevational treatment of the main building. The design solution offered for the stack has been arrived at following detailed analysis to ensure that it blends in to its environ whilst also remaining in character with the rest of the proposals.

Officer response – Having considered the applicants response, it is concluded that the proposed flue colour (grey white) is acceptable.
