#### 1. PURPOSE OF REPORT

1.1 To consider and determine an application made by Cambridgeshire Constabulary for an expedited summary review of a Premises Licence under Section 53A of the Licensing Act 2003 for the above premises. A summary review is applicable for premises experiencing serious crime or disorder.

# 2. BACKGROUND INFORMATION

- 2.1 On the 9<sup>th</sup> August 2005 an application was made to Peterborough City Council to convert an existing justice's licence to a premises licence under 'grandfather rights' for The Solstice / Tara Suite which is situated at Northminster, Peterborough, PE1 1YN. The original name of the premises was The Solstice / Tara Suite and this was subsequently later changed to The Solstice / Radius. As no representations were received from any of the responsible authorities or from any interested party, the premises licence was granted on the 5<sup>th</sup> September 2005. At that time the premises licence was granted the premises licence holders were 'Woodglen Leisure Limited'.
- 2.2 Between the initial grant of the premises licence and the service of the expedited review on 3<sup>rd</sup> April 2014 there have been three variations to the premises licence. Two concerned the addition and subsequent plan change of an external garden area and the third variation was to allow all licensable activities to finish at 4.30am and to remove all outdated conditions and replace them with an up to date manageable set of conditions. This variation was granted on 18<sup>th</sup> May 2011 after receiving no representations from any of the responsible authorities nor interested parties. A copy of this current premises licence is attached at **Appendix B Page 9**.

# 3. APPLICATION

- 3.1 In accordance with section 53A of the Licensing Act 2003 following the submission of an application for a summary review of the premises licence and the certificate signed by a superintendant from Cambridgeshire Constabulary, the licensing authority must consider if it is necessary to take interim steps within 48 hours.
- 3.2 A consideration hearing took place via email on the 11<sup>th</sup> March 2014 where the licensing sub committee determined the interim steps to be applied as per section 53B of the Act. The sub committee's decision was to restrict the licensable hours back to 2am and to impose additional licence conditions. A copy of the decision of the Licensing Committee 2003 Sub Committee can be found at **Appendix B Page 26**.
- 3.3 A copy of the application for summary review and the accompanying certificate under section 53A, which was received at these offices on 10<sup>th</sup> March 2014 is attached at **Appendix B Page 29.**
- 3.4 A 'Notice' was displayed on the premises in accordance with Part 5 no. 38 of Statutory Instruments 2005 No. 42 The Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005 (as amended by the Violent Crime Act 2006 and Statutory Instruments 2007 No 2502).

# 4. Summary of issues raised by Cambridgeshire Constabulary

4.1 The summary review has regard to an incident of serious disorder occurring on the 9<sup>th</sup> March 2014, involving a member of the public and four SIA registered door supervisors employed by Woodglen Leisure Limited who are the premises licence holders of the Solstice / Radius. A detailed account of the incident can be found in the summary review application which is attached at **Appendix B Page 29**. Both the Police and Local Authority have on numerous occasions over the previous 12 months of the incident been in contact with the management of the premises. The Police and Local Authority had been concerned with the apparent ineffectiveness of the door supervisors employed at the premises and there were also a number of accusations of excessive force made against the door staff.

# 5. MEDIATION

5.1 Mediation has taken place between all parties since the service of the expedited review and is currently ongoing. It is anticipated that before the date of the review hearing an agreement to a set of conditions and licensable hours will be agreed upon by all parties. The committee will be sent this mediated agreement prior to the hearing date for their consideration.

# 7. LEGAL OFFICER'S COMMENTS

- 7.1 The Licensing Authority (hereafter referred to as "the Council) is charged with implementing the provisions of the Licensing Act 2003. This is an application for a summary review of a premises licence following the application by Cambridgeshire Constabulary (Responsible Authority) to review the premises licence made under section 53A of the Licensing Act 2003.
- 7.2 In this case, the application was received at these offices on 10<sup>th</sup> March 2014.
- 7.3 The application before this committee will consider:
  - (i) The application to review the licence,
  - (ii) Any relevant representations
- 7.4 The committee will take such of the steps as it considers that action is necessary for the promotion of the licensing objectives. The steps are:
  - (a) to modify the conditions of the premises licence
  - (b) to exclude a licensable activity from the scope of the licence
  - (c) to remove the designated premises supervisor from the licence
  - (d) to suspend the licence for a period not exceeding three months, or
  - (e) to revoke the licence.

and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added

# LICENSING ACT 2003 GLOSSARY OF TERMS

Note: In this document, the following definitions are included to provide an explanation of certain terms included in the Act. In some cases they are an abbreviation of what is stated in the Licensing Act 2003 or an interpretation of those terms. For a full definition of the terms used, the reader must refer to the Licensing Act 2003.

#### 'Child'

- (a) means an individual aged under 16
- (b) a child is unaccompanied if he is not in the company of an individual aged 18 years or over

**DCMS**: Department for Culture Media and Sport

**'Designated Premises Supervisor'** means the person (who must be a Personal Licence Holder), in the case of premises selling alcohol, who will normally have been given the day to day responsibility for running the premises by the holder of the Premises Licence or will be the Premises Licence holder.

#### 'Other Persons':

- persons who live, or are involved in a business, in the relevant licensing Authorities area and who are likely to be affected by the application and are not a Responsible Authority.

**'Late Night Refreshment'** means the supply of hot food or hot drink to members of the public (whether for consumption on or off the premises) between the hours of 11.00 pm and 5.00 am.

#### 'Licensable Activities' means: -

- · The sale by retail of alcohol
- The supply of alcohol by or on behalf of a club to, or to the order of, a member of the club
- The provision of Regulated Entertainment
- The provision of Late Night Refreshment

'Licensing Authority': - is the licensing function of Peterborough City Council

'Licensed Premises' includes club premises and events unless the context otherwise requires.

# 'Licensing Objectives'

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

'Operating Schedule' means a document containing a statement of the following matters (and any others that may be prescribed): -

- The relevant Licensable Activities
- The times at which the Licensable Activities are to take place and any other times when premises are open to the public
- Information regarding the person who will be specified in the Premises Licence as the Premises Supervisor
- Where the Licensable Activities involve the supply of alcohol, whether it is for the supply on and/or off the premises
- The steps being taken to promote the Licensing Objectives

'Rateable Value': as regards a premises, is the value for the time being in force for the premises entered in the local non-domestic rating list for the purposes of Part III of the Local Government Finance Act 1988(b).

# 'Regulated Entertainment' (Schedule 1 of the Act) means: -

- A performance of a play
- · An exhibition of a film
- An indoor sporting event
- A boxing or wrestling entertainment
- A performance of live music
- Any playing of recorded music
- A performance of dance

Or entertainment of a similar description falling within the last three of the categories listed above, where the entertainment takes place in the presence of and for the purposes of entertaining that audience or spectators.

# **Or** the provision of entertainment facilities:

Facilities for enabling persons to take part in entertainment of the following description for the purpose or purposes, which include the purpose of being entertained:

- making music
- dancing
- entertainment of a similar description

**'Relevant Licensing Authority':** is the Authority in the area the premises are situated.

# 'Responsible Authority' means any of the following: -

# 'Supply of alcohol':

- the sale by retail of alcohol, or
- the supply of alcohol by or on behalf of a club to, or to the order of, a member of the club.

**'Temporary Event Notice'** means a Permitted Temporary Activity involving one or more Licensable Activities subject to the following various conditions and limitations: -

- Duration they are limited to events lasting for up to 168 hours (7 days);
- Scale they cannot involve the presence of more than 499 people at any one time;
- Use of the same premises the same premises cannot be used on more than 12 occasions in a calendar year, but are subject to the overall aggregate of 21 days irrespective of the number of occasions on which they have been used; and

 The number of notices given by an individual within a given period of time – a Personal Licence Holder is limited to 50 notices in one year and another person to 5 notices in a similar period.

(In any other circumstances, a full Premises Licence or Club Premises Certificate will be required for the period of the event).

# **Annex 1 - Mandatory conditions**

Licensees should note that the under enclosed Mandatory conditions should be read in conjunction with the granted licence and these conditions shall be enforceable where relevant to the operation of the premise and its activities.

# Supply of alcohol (Premises Licence)

This registration authorises the supply of alcohol subject to the following conditions:

- 1. No supply of alcohol may be made at a time when
  - (a) there is no designated premises supervisor in respect of the premises licence, or
  - (b) when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.
- 2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.
- 3. The responsible person shall take all reasonable steps to ensure that staff on relevant premises do not carry out, arrange or participate in any irresponsible promotions in relation to the premises.

An irresponsible promotion means any one or more of the following activities, or substantially similar activities, carried on for the purpose of encouraging the sale or supply of alcohol for consumption on the premises in a manner which carries a significant risk of leading or contributing to crime and disorder, prejudice to public safety, public nuisance, or harm to children—

Games or other activities which require or encourage, or are designed to require or encourage, individuals to—

Drink a quantity of alcohol within a time limit (other than to drink alcohol sold or supplied on the premises before the cessation of the period in which the responsible person is authorised to sell or supply alcohol), or

Drink as much alcohol as possible (whether within a time limit or otherwise);

Provision of unlimited or unspecified quantities of alcohol free or for a fixed or discounted fee to the public or to a group defined by a particular characteristic (other than any promotion or discount available to an individual in respect of alcohol for consumption at a table meal, as defined in section 159 of the Act);

Provision of free or discounted alcohol or any other thing as a prize to encourage or reward the purchase and consumption of alcohol over a period of 24 hours or less;

Provision of free or discounted alcohol in relation to the viewing on the premises of a sporting event, where that provision is dependent on—

The outcome of a race, competition or other event or process, or

The likelihood of anything occurring or not occurring;

Selling or supplying alcohol in association with promotional posters or flyers on, or in the vicinity of, the premises which can reasonably be considered to condone, encourage or glamorise anti-social behaviour or to refer to the effects of drunkenness in any favourable manner.

- 4. The responsible person shall ensure that no alcohol is dispensed directly by one person into the mouth of another (other than where that other person is unable to drink without assistance by reason of a disability).
- 5. The responsible person shall ensure that free tap water is provided on request to customers where it is reasonably available.
- 6. The premises licence holder or club premises certificate holder shall ensure that an age verification policy applies to the premises in relation to the sale or supply of alcohol.

(The policy must require individuals who appear to the responsible person to be under 18 years of age (or such older age as may be specified in the policy) to produce on request, before being served alcohol, identification bearing their photograph, date of birth and a holographic mark

- 7. The responsible person shall ensure that—
  - (a) where any of the following alcoholic drinks is sold or supplied for consumption on the premises (other than alcoholic drinks sold or supplied having been made up in advance ready for sale or supply in a securely closed container) it is available to customers in the following measures—
  - (i) beer or cider: ½ pint;
  - (ii) gin, rum, vodka or whisky: 25 ml or 35 ml; and
  - (iii) still wine in a glass: 125 ml; and
  - (b) customers are made aware of the availability of these measures.

# Annex 2 - Conditions consistent with the Operating Schedule

# All Licensing Objectives

# 8. Noise Control – Garden Area

All entertainment activities in the garden area will cease at 02.00.

# Crime and Disorder

- 9. An authorised person will be available at all times on the premises to show CCTV images immediately or to an authorised officer on demand.
- 10. CCTV images will be clear ad comprehensible
- 11. CCTV will cover the entire garden area
- 12. Video/CCTV equipment will be set to record all licensed areas from the time that the premises open to the public until the premises closes and all members of the public have left.
- 13. Video/CCTV equipment shall be installed inside/outside the premises and maintained in working order.
- 14. Video/CCTV equipment will be set to record from the time that the premises open to the public until the premises close and all members of the public have left.
- Monitoring tapes shall be retained for at least thirty one days and shall be produced to an authorised officer on demand.

# 16. Garden Area

At least one SIA staff member will monitor the outside garden area from 20.00hrs Thursday to Saturday or on an any Major sporting event.

# 17. Person in Charge

The Holder of the Premises Licence, or responsible person over the age of 18 years nominated by them in writing, shall be in charge of and remain at the Licensed Premises during the whole time the premises are open to the public. The person in charge shall not be engaged in any duties that will prevent them from exercising general supervision of the premises. They shall be responsible for maintaining good rule and order within the premises under this licence, taking charge of emergency situations and the summoning of emergency services.

# 18. Conduct on Premises

No conduct or behaviour which is obscene, indecent, offensive, disgusting or shocking or of demoralising character or which in any way offends against recognised standards or propriety or is injurious to the public shall take place on the Licensed Premises.

# 19. Powers of Entry

An 'Authorised Person' representing the Licensing Authority or any of the Responsible Authorities whether in uniform or not shall upon production of written identification have free access to any place in respect of which a premise licence or club premise certificate is in force at all reasonable times and shall be permitted by the holder of the premises licence upon request, to examine any books or records required to be kept by the holder of the premises licence and to examine and test any furniture, equipment, fittings and the like.

20. Whilst in existence subscribe to the "city safe"

# 21. Numbers Admitted

An electronic/mechanical counting device shall be installed at the entrance of the premises to record accurately the total number of persons admitted to the premises at all times. The information is to be supplied on demand to an 'Authorised Person'.

# 22. Video Monitoring Equipment

Video surveillance equipment must be installed both inside and outside the premises to the satisfaction of the Licensing Authority. Such equipment to be operational at least one hour before the advertised start time of any event and remain so until a least one hour after the advertised closing time or the premises has closed, whichever is the later.

# 23. <u>Video Monitoring Equipment</u>

Digital images must be used and be retained by the Holder of the premises licence **one month** or such longer period as may be specified by the Licensing Authority.

# 24. Video Monitoring Equipment

Monitoring media are to be produced to an 'authorised person' on request where they are required for examination in relation to incidents that have occurred on or outside the Licensed Premises.

# **Public Safety**

25. No customers will be admitted, or permitted to leave when carrying opened containers.

# 26. Log Book

A logbook shall be provided in which shall be kept accurate records of tests required in these conditions, visits by 'authorised persons' and incidents as required in these conditions. The logbook shall be produced to an 'authorised person' for inspection on request.

27.	Staff/Stewards
	The Licensing Authority reserves the right to increase the number of stewards required, when in its opinion, a particular event, or audience necessitates additional stewarding.

# 28. Special Effects

No special effects equipment shall be used in the premises under the terms of the licence, unless prior written consent is given by the Licensing Authority. This includes the use of firearms, weapons other firearms, strobe lights, equipment that uses a heat source to produce effects, i.e. real flame, smoking, smoke capsules, pyrotechnics, and generators; lasers and holographs.

# 29. Floor Coverings

Mats or other floor coverings shall be so secured that they are not in any way liable to rucking, or to be a source of danger to the public, and no drapings shall trail on the floor. New floor coverings must comply with BS5287 and BS4790.

# 30. <u>Provision for People with Disabilities</u>

On those occasions where people with disabilities are present on the Licensed Premises such special arrangements as may be necessary in the circumstances shall be made so as to enable all persons to leave the premises safely in the event of fire.

# 31. Provision of Sanitary Accommodation

Adequate provision should be made in female accommodation for the disposal of sanitary dressings.

# 32. Provision of Sanitary Accommodation

Wash hand basins must be provided with hot and cold water or hot water at a suitably controlled temperature, soap and suitable and sufficient hand drying facilities.

# 33. <u>Provision of Sanitary Accommodation</u>

The entrance door to every toilet or block of toilets shall be clearly labelled to indicate the sex for which they are provided.

# 34. First Aid

A first aider is to be provided on the Licensed Premises during opening hours to the following scale:-

Above 500 Extra 1 for every 500 or part thereof.

# 35. <u>First Aid</u>

Any person who is seriously unwell including those affected by drugs or alcohol, must be seen by the trained first aider, who shall:-

- a) Give first aid
- b) If necessary, seek medical assistance.

# 36. Numbers Admitted to Licensing Premises

The Licensee must ensure that the permitted numbers for the Licensed Premises are not exceeded at any time.

# 37. Condition 5 - Toilet and Washing Facilities

The following sanitary accommodation and washing facilities will be provided:

# 38. <u>Noise Control – Garden Area</u>

All entertainment activities in the garden area will cease at 02.00.

# 39. Noise Control – Garden Area

Entertainment will be at a background level, with the exception of 12 specific event days per year. The Council will be notified of these events 7 working days before any specified event

# 40. Noise Control

The holder of the premises licence or responsible person shall ensure that no noise shall emanate from the Licensed Premises nor vibration be transmitted through the structure of the premises which gives rise to a nuisance or unreasonable disturbance to the occupiers of premises in the vicinity of the Licensed Premises.

# 41. Noise Control

Requests made by the Licensing Authority shall be complied with as soon as practicable. In addition any restriction specified in the Operating Schedule to the licence the holder of the premises licence shall implement regarding control to be exercised over music or responsible person at all times when the premises are open to the public.

# 42. Noise Control

The holder of the premises licence or responsible person nominated by them in writing, shall take all reasonable steps to prevent and control noise nuisance caused by persons using the Licensed Premises and also ensure patrons and visitors arrive at and depart from the premises in a manner which will not cause annoyance to nearby occupants.

# 43. Noise Control

If instructed by the Licensing Authority a "noise limiting device" shall be used on all specified equipment including juke boxes in or about the Licensed Premises.

# **Protection of Children from Harm**

- 44. A proof of age policy, 'Challenge 25' shall be implemented.
- 45. The premises licence holder shall take all reasonable steps to prohibit the use of gaming machines to under aged persons.
- 46. Signage will be prominently placed within the premises advertising the fact that the premises operates the Challenge 25 initiative.

- 3. A minimum of 8 SIA registered door supervisors will be employed at all times a licensable activity takes place from 21:00 hours on each Friday and Saturday night. A minimum of 2 SIA door supervisors will be employed where capacity is expected to exceed 100 on any other night. They will be employed on the main access door and at strategic points around the venue to:
  - a. Prevent the admission of drunk and disorderly persons.
  - b. Maintain an orderly queue outside the venue
  - c. Count those entering and leaving the premises to ensure building capacity is not breached.
  - d. Assist customers leaving the venue to ensure they leave in a quiet and orderly fashion.
  - e. To keep out excluded persons circulated via the NightSafe Pub Watch Scheme.
  - f. Search and exclude those persons suspected of carrying illegal drugs or offensive weapons.
  - g. Maintain effective communication via City Link Radio, or other means with Peterborough CCTV or the Police when requesting assistance.

- 4. All door staff shall be trained in the requirements of the Challenge 25 policy, the identification & recognition of drunks and the correct procedures to be followed when refusing service.
- 5. The premises licence holder and / or the designated premises supervisor shall ensure door supervisors are properly briefed and trained to manage queues in a safe and efficient manner.
- 6. All door supervisors employed at the entrance / exit of the licensed premises will wear high visibility clothing and display their SIA badge in an arm badge holder.
- 7. All door staff engaged in searching persons (as a condition of entry) shall be fully trained in the use of their powers to do so.
- 8. Where a licensed premises engages in searching persons, the premises licence holder and / or designated premises supervisor shall ensure that door supervisors of both sexes are on duty.
- 9. The premises licence holder and / or designated premises supervisor shall ensure that the following details for each door supervisor are contemporaneously entered into a bound register kept for that purpose :

# **OUTLINE OF FINDINGS OF FACT**

1. The Sub-Committee considered representations made by the police contained within the application and certificate in support of the expedited review. The representation detailed an incident which took place on 9<sup>th</sup> March 2014 between the hours of 02:30am and 2:50am:

- 2. Due to the seriousness of the incident, the Sub-Committee contacted by telephone the Police Licensing Officer, PC Robinson, to seek reassurances that the proposed interim conditions would be effective; and
- 3. The Sub-Committee were satisfied that they had sufficient information to make a decision.

# **CONSIDERATIONS BY THE SUB-COMMITTEE**

- 4. The Sub-Committee considered whether in the light of the representations made by the police, if it was necessary to take interim steps to address the immediate problems with the premises.
- 5. The Sub-committee considered paragraph 3 of the Home office guidance and the powers available to it under Section 53A of the Licensing Act 2003 namely:
  - The modification of the conditions of the premises licence;
  - The exclusion of the sale of alcohol (or other licensable activities) from the scope of the licence;
  - The removal of the designated premises supervisor; and
  - The suspension of the licence.
- 6. The Sub-Committee considered that the interim step of modifying the conditions of the premises licence was necessary to prevent the likelihood of further serious disorder and that the hours of operation for licensable activities should be curtailed and that further conditions surrounding the management of door supervisors should be attached to the licence as recommended by the Police.

# REPRESENTATIONS BY THE PREMISES LICENCE HOLDER UNDER SECTION 53(B)(6) OF THE ACT

7. The premises licence holder is entitled to make representations on the interim steps taken. If representations are made, the licensing authority must hold a hearing within 48 hours of receipt (excluding non-working days). At the hearing the licensing authority must consider if the interim steps taken are necessary for the promotion of the licensing objectives and determine whether to withdraw or modify the steps taken.

The head doorman has moved towards the customer in an aggressive fighting stance and a full on fist fight has taken place at the front of the premises on the road. The customer appears to subdue the doorman and after being pulled away by a friend, has made off towards Cattlemarket. Four doormen (including the head doorman) from the Solstice are seen on Town CCTV to pursue the customer to the grounds of Peterborough Cathedral where they continue to assault the lone male. Two Police Officers attended the scene and had to break up the assault with the use of baton strikes to some of the doormen. 5 males were arrested at the scene for affray and there is now a protracted investigation in place.

The Solstice normally employs up to 8 SIA registered door supervisors on a Friday and Saturday night to maintain the licensing objectives at the premises. These door supervisors are employed 'In House' (employed directly by a manager (the DPS) at the venue who holds an SIA badge), and are not employed directly from a registered Security Company. However all door supervisors at the Solstice hold valid SIA door badges. There are no specific conditions on the Premises License that pertain to the employment of door staff, and the venue employs them subject to any Risk Assessment that they may have in place. In January 2014 the Constabulary conducted two training days for SIA door supervisors and Licensees. The training was 4 hours long and specific to Communication Skills and Conflict Resolution refresher following on from a recent spate of complaints against door staff around the City, employed during the Night Time Economy, for excessive force and abusive language towards customers. All Solstice SIA door supervisors attended this course.

The Police and Local Licensing Authority have, on numerous occassions over the last 12 months, had to speak both formally and informally to management at the Solstice in relation to the apparent ineffectiveness of the door supervisors employed at the venue and the allegations of excessive force and abuse. There have been a number of accusations against the door staff both from members of the public and Police Officers for being aggressive and using excessive force, and there is CCTV evidence of door staff employed at the venue kicking / punching customers at the venue on separate past occassions.

- 8. Where a licensed premises engages in searching persons, the premises licence holder and / or designated premises supervisor shall ensure that door supervisors of both sexes are on duty.
- 9. The premises licence holder and / or designated premises supervisor shall ensure that the following details for each door supervisor are contemporaneously entered into a bound register kept for that purpose:

Full Name
SIA badge number in full
The time they begun duty
The time they completed their duty
The full details of any agency through which they have been allocated work at the premises.

- 10. The premises licence holder and / or designated premises supervisor or in their absence another responsible person to keep an 'incident report register' in a bound book in which full details of all incidents are recorded. This shall be completed as soon as possible and in any case no later than the close of business on the day of the incident. The time and date when the register was completed, and by whom, is to form part of the entry. The register is to be kept on the premises at all times and shall be produced to an authorised officer of the Licensing Authority or Police Officer (inc any Licensing PCSO) when required. The register should be retained for a minimum of 12 months.
- 11. All door supervisors shall be capable of communicating instantly with one another by way of radio or other simultaneous system of communication.
