### **BACKGROUND TO THE REVIEW**

### 1. INTRODUCTION

- 1.1 The Electoral Administration Act 2006 introduced a duty for every local authority to review all polling districts and polling places by the end of 2007.
- 1.2 Local authorities are required to divide their area into polling districts for the purpose of Parliamentary Elections, to designate polling places for these polling districts, and to keep them under review. By conducting this statutory review of polling places, local authorities must demonstrate that they have, as far as is practicable, met the following criteria set out in legislation:
  - (a) Sought to ensure that all the electors in the constituency have such reasonable facilities for voting as are practicable in the circumstances
  - (b) Sought to ensure that so far as is reasonable and practicable, the polling places they are responsible for are accessible to all electors, including those who are disabled, and when considering the designation of a polling place, must have regard to the accessibility needs of disabled purposes.
- 1.3 Ideally Council would have a choice of a range of fully accessible buildings, conveniently located for electors in the area. However, in practice, there may be little choice available. If it is necessary to use a place where the access is not ideal then every reasonable adjustment must be undertaken to provide access for all electors.

### 2. PREVIOUS POLLING REVIEWS

2.1 A comprehensive review of the polling districts of the Peterborough City Council Area was last undertaken in 2003 and changes were brought into effect for the Register of Electors published on 1 December 2003. This has provided a sound basis for the current review process reducing the backlog of issues that have required examination.

### 3. FIRST AND SUBSEQUENT REVIEWS

- 3.1 Under the new legislation, every local authority must have undertaken and completed a review of all polling districts and polling places in its area by 31 December 2007.
- 3.2 The Council must then complete a further review before the end of the period of 4 years starting with the completion of the first review.
- 3.3 It should be noted that the review is exclusively of polling districts and polling places within electoral wards and that the final decision on these matters rests with the Council.

### 1. COMMENCEMENT OF REVIEW

1.1 Notice of the review was published on 17 September 2007 and representations invited by 19 October 2007. Notice was given on the Council's website and letters sent out to Consultees. The list of Consultees was submitted to the Polling Review Working Group for approval, to ensure that a wide-ranging consultation process was adopted.

### 1. REPRESENTATIONS FROM INITIAL CONSULTATION

1.1 The period of consultation drew the following representations:-

### 2. ROLE OF POLLING REVIEW WORKING GROUP

- 2.1 A Polling Review Working Group was established comprising Group Leaders which met on 6 November 2007. The purpose of the meeting was to consider progress with the review regarding the access audit and consultation that had been undertaken.
- 2.2 It was reported to the Working Group that all Polling Stations had been inspected and some changes needed to be made because some premises did not meet the requirements of the Disability Discrimination Act. The other premises, although needing minor adaptation in some cases, were all accessible to all electors, including those who were disabled. It was noted that the managers of premises had been receptive to the advice given by the Access Officer. No works were required to be undertaken to satisfy polling requirements alone and where major works were necessary, the Returning Officer had sought to relocate the premises.
- 2.3 It was felt that no changes were necessary to polling districts but that further consultation should be undertaken in respect of some polling stations. The Working Group agreed that this should be undertaken through a process of consultation with Ward Councillors.

### 3. REPRESENTATIONS FROM CONSULTATION WITH WARD COUNCILLORS

3.1 A provisional list of proposals were submitted to Ward Councillors (and Group Leaders) in respect of Polling Stations where the current accommodation was unavailable or unusable without major adaptations. In all cases where minor adaptations were possible, every effort was made to retain the existing polling arrangements.

Response from one Ward Councillor (Councillor Fitzgerald) supporting the proposal.

### **Outcome of Consultations and Access Audit:**

Relocation to Heltwate Special School.

### **Proposals of Returning Officer:**

- Polling District to remain unaltered.
- Polling Place and Polling Station to Heltwate Special School.

### **Polling District: DOG2**

Current Polling Station: Don Bosco Centre

### **Issues Arising from Access Audit:**

Ramp and steps into Centre substantially non-compliant suggest use of main Church building.

### **Representations Received:**

Responses received from 3 Ward Councillors (Councillors Ash, Miners and Saltmarsh). Summary of responses:

- Preference to remain in Cedar Road.
- Preference to retain the existing number of polling stations.
- Objection to merger with another polling district.
- Preference that main Church building be used
- Alternative venue of John Mansfield Centre to be considered.

### **Outcome of Consultations and Access Audit:**

- Agreement obtained from Church for use of large foyer in main Church building.
- Standby alternative of Drama Centre at John Mansfield Centre subject to completion of demolition of surplus parts of building.

### **Proposals of Returning Officer:**

- Polling District and Polling Place to remain unaltered.
- Polling Station to relocate to main Church building.

### **Polling District: EAS1**

**Current Polling Station:** Abbotsmede Primary School.

### **Issues Arising from Access Audit:**

Substantial objection from School for its use for polling purposes. Use of Saxon Community Centre suggested.

### Representations Received:

### Outcome of Consultations and Access Audit:

Proposal to use Saxon Community Centre.

### **Proposals of Returning Officer:**

Polling District to remain unaltered.

Polling Place and Polling Station to relocate to Saxon Community Centre.

### **Polling District: EAS3**

Current Polling Station: Hereward Community College

### **Issues Arising from Access Audit:**

Building due for demolition and alternatives to be considered.

### Representations Received:

Responses received from 2 Ward Councillors (Councillors Collins and Todd).

No objections to Saxon Community Centre but other options identified have been Greengate Court Community Centre and Main Hall at St John Fisher School.

Some reservations expressed at combining EAS1 and EAS3 Polling Districts at the Saxon Community Centre in view of need to manage a large number of electors on polling day

### **Outcome of Consultations and Access Audit:**

Use of Greengate Court Community School would provide 2 polling stations across the road from one another (when also using Saxon Community Centre).

Proposal to relocate to Saxon Community Centre but St John Fisher School Main Hall and other alternatives to be further examined.

### **Proposals of Returning Officer:**

Polling District to remain unaltered.
Polling Place to relocate to Saxon Community Centre.

**Polling District: FLE4** 

**Current Polling Station:** Nene Valley Primary School

### **Issues Arising from Access Audit:**

Unsatisfactory access from curtilege to school and current accommodation would require all school to close on polling day.

### **Representations Received:**

Response from one Ward Councillor (Councillor Lee) agreeing with relocation within existing building and use of Community Centre to be examined in the future.

### **Outcome of Consultations and Access Audit:**

Consensus to relocate to rear of school with reserved access of 20 parking bays on polling day.

### **Proposals of Returning Officer:**

- Polling District and Polling Place to remain unaltered.
- Polling Station to relocate to Pupil Referral Unit within Nene Valley Primary School.

**Polling District: STC3** 

Current Polling Station: Oakdale Primary School

### **Issues Arising from Access Audit:**

- Poor lighting.
- Long walk to rear of premises.
- No alternative room at school without closing down whole school on polling day.
- Proposal to use Stanground College Study Room.

### **Representations Received:**

Responses received from 3 Ward Councillors (Councillors Cereste, Rush and Walsh) with no consensus achieved over use of Stanground College and preference for using Mace Road or a different part of Oakdale Primary School. Objections received to use of rear of school as at present.

### **Outcome of Consultations and Access Audit:**

Options investigated included Mace Road Church Hall but used for crèche facilities and agreement achieved with Church over new proposal of St Michael's Church on Mace Road.

### **Proposals of Returning Officer:**

- Polling District and Polling Place to remain unaltered.
- Polling Station to relocate to St Michael's Church on Mace Road.

### **Polling District: SUT**

**Current Polling Station:** Sutton Reading Room.

### **Issues Arising from Access Audit:**

Non-compliant in terms of access and facilities.

Proposal to use St Michael and All Angels Church.

### **Representations Received:**

No objections from Ward Councillors.

### **Outcome of Consultations and Access Audit:**

Proposal to be implemented.

### **Proposals of Returning Officer:**

- Polling District and Polling Place to remain unaltered.
- Polling Station to relocate to St Michael and All Angels Church.

### **Polling District: THH**

Current Polling Station: 13 Russell Hill, Thornaugh.

### **Issues Arising from Access Audit:**

Private House no longer available for polling purposes.

Proposal to re-locate to Church and use facilities at Parish Clerk's house.

### **Representations Received:**

No objections from Ward Councillors.

### **Outcome of Consultations and Access Audit:**

Proposal to be implemented.

### **Proposals of Returning Officer:**

- Polling District and Polling Place to remain unaltered.
- Polling Station to relocate to St Andrew's Church.

### **Polling District: WAL2**

Current Polling Station: Calverstede Early Year's Centre

### **Issues Arising from Access Audit:**

Taken over by private sector enterprise and building no longer available owing to

intensification of usage and there being no part thereof with access separate from teaching/caring spaces. Use of Paston and Gunthorpe Community Centre to be examined.

### **Representations Received:**

No objections.

### **Outcome of Consultations and Access Audit:**

Combination of PAS1 and WAL2.

Walton Community Centre considered inappropriate for use owing to busy road.

### **Proposals of Returning Officer:**

Polling District to remain unaltered.

Polling Place and Polling Station to move to Paston and Gunthorpe Community Centre.

### **Polling District: WOT**

Current Polling Station: Private residence at Roach House.

### **Issues Arising from Access Audit:**

Private house no longer available suggest relocate to private house, "The Spinney".

### **Representations Received:**

Response received from one Ward Councillor (Councillor Over) with no objection to the proposal.

### **Outcome of Consultations and Access Audit:**

Relocate to "The Spinney".

### **Proposals of Returning Officer:**

Polling District and Pollling Place to remain unaltered.

Polling Station to relocate to "The Spinney".

3.2 All issues raised by Ward Councillors were examined with inspections undertaken of alternative premises when suggestions were received.

### 4. FURTHER FINAL PROPOSALS

- 4.1 Further proposals were developed following the consultation process with Ward Councillors.
- 4.2 Ultimately, final proposals have been developed which reflect that there has been:-

- A consultative approach to inform the findings of the review

# COUNCIL DECISION: DESIGNATION OF POLLING DISTRICTS AND PLACES

### 1. SCHEDULE OF RECOMMENDATIONS

- 1.1 The Council is responsible for identifying the Polling Districts and Places that are to be used within the area of the local authority. It is common practice to designate the Polling Districts and Places as being one and the same as this provides maximum flexibility for the Returning Officer in responding to changing circumstances regarding the availability of premises used as Polling Stations.
- 1.2 Arising from the current Polling Review, there have been no proposals made to change the Polling Districts within the area. However, there are certain proposals which would mean that all Polling Places are not located within the Polling Districts they serve. This is allowed under Electoral Law and reflects the scarcity of Public Buildings that are accessible and fit for purpose in specific locations.
- 1..3 The recommendations for Polling Districts and Places that are made following the process of consultation that has been undertaken are set out below:

- 1.2 Consultation on the designation of Polling Stations will continue, with representations welcome, up until 31 December 2007.
- 1.3 In the longer term, the Returning Officer must be able to respond to changing circumstances in fulfilling his/her statutory duty should a set of premises be unavailable on Polling Day, or indeed better facilities are identified as a result of the refurbishment or erection of buildings in a particular Polling District. In these circumstances, it would be useful to provide a clear process of engagement prior to a decision being taken. This will ensure that al views are considered and the most convenient and accessible Polling Stations are used to serve the electors of Peterborough.
- 1.4 It is proposed that the following procedure be adopted:

### Consultation Process on the Re-designation of Polling Stations

Stage 1: Identification of need for change of Polling Station by Returning Officer

Stage 2: Consultation allowing 5 days for comment with the following:

(a) Group Leaders

(b) Ward Councillors

Stage 3: Notification of the decision of the Returning Officer to:

(a) Group Leaders

(b) Ward Councillors

(c) Main Political Parties

Stage 4: Implementation of the decision to include appropriate measures to notify the local electorate.

Note:

This process shall be adopted in it's entirety, where there is a period of two calendar months between the proposed date of change and polling day, or so far as it is practicable, when there is a lesser period before polling day.
