They state that they do this in three ways: through social innovation, through social finance and through workspace and enterprise support.</p> <p>They provide support that helps the development of businesses who re-invest their profits in the business or community to further social and/or environmental causes. As a charitable society they also work with partners to deliver and grow the social investment market and make a social profit by creating opportunities to raise investment from individual and corporate investors for organisations delivering social benefit. Membership and benefits are fully available to the general public.</p> <p>They state that their “ideation”, innovation and incubation programmes will also help Peterborough residents who are looking at starting their own social/environmental ventures and will give special consideration to female entrepreneurs and the city’s migrant population who are less well catered for in terms of business support.</p> <p>Through their programmes they aim to improve access to skills, knowledge and finance for innovation within the city, indirectly creating jobs and attracting new businesses into the city.</p> <p>The rateable value of the original assessment has now been reviewed by the Valuation Office Agency and split into various assessments thus making Allia liable for 13 individual assessments. We are recommending this organisation is awarded discretionary rate relief.</p>
