The organisation states that they are a Christian organisation passionate about helping to relieve suffering and poverty around the world through their Feeding, Educating, Empowering and Developing programmes. The work of Smile International involves many people comprised of a dedicated staff, a Board of trustees and several hundred volunteers. They use this property as their main office hub to undertake training, meetings, administration, storage, volunteering and speaking events. The organisation state that they cater for the needs of the people of Peterborough in terms of the provision of volunteering opportunities available. Having reviewed their website there are no details of prior or planned events celebrating volunteering options or provision from or to the people of Peterborough. As this is a National charity providing international aid and there is no direct benefit to the people of Peterborough this application does not meet the criteria set out in point 1 of the Council's guidelines for awarding discretionary relief. Recommendation for refusal of relief in this case. (NB 17/18 rates payable reflect part year occupancy)
