I refer to the Police and Crime Panel meeting on the 14th March 2018 where the Panel raised a number of actions to which my response is given below.

Collaboration

A report on this will be submitted to the July 2018 Business Co-ordination Board and published on my website which I hope reassures the Panel in exercising their role of support and scrutiny of my statutory functions and performance. The report will highlight that collaboration is not solely about monetary benefits but equally the benefits realisation of operational efficiency and effectiveness, such as resilience, economies of scale, and public safety that this brings. As the Panel will be aware, all decisions and future anticipated decisions are provided to every Panel meeting. These have included, and will continue to include, decisions on collaboration.

Business cases, associated documentation and accompanying reports to the Business Co-ordination Board, for collaboration between Bedfordshire Police, Cambridgeshire Constabulary and Hertfordshire Constabulary since 2015 can be found on my website: http://www.cambridgeshire-pcc.gov.uk/collaboration/collaboration-business-cases/. For ease of reference for the Panel, details of which are given at Annex 1. It is worth noting that a number of collaboration business cases were approved prior to November 2012 by the Cambridgeshire Police Authority.
