1.	<p><b>Question from Lucinda Robinson</b></p> <p>To Councillor Walsh, Cabinet Member for Communities</p> <p>At a recent Westwood Residents Association meeting it was again reported that there is continued obstruction by some parked vehicles to residents' private parking. It is difficult for residents to know as to whether obstruction in front of their garages or parking bays at the rear of gardens is the remit of the enforcement team or the local police. For example, much seems to be dependent on which spaces constitute as 'dropped-kerb' parking spaces.</p> <p>Residents can be left unsure of which service is relevant to their obstruction case and are frustrated that much nuisance parking is continuing unaddressed.</p> <p>City Council officers in the enforcement team have indicated that they have brought the matter of obstructed garages to the attention of local police however we don't seem to have had a response.</p> <p>Would you be kind enough to offer assistance in moving this matter forward so that this, often disruptive nuisance, does not continue?</p> <p>May I thank you in anticipation of your assistance in dealing with this matter.</p>
2.	<p><b>Question from Sandra Bond</b></p> <p>To Councillor Hiller, Cabinet Member for Growth, Planning, Housing and Economic Development</p> <p>What is the message from relevant cabinet member to those who will lose vital bus services thanks to Conservative cuts to the Council's bus subsidy?</p>
3.	<p><b>Question from Alan Bridger</b></p> <p>To Councillor Hiller, Cabinet Member for Growth, Planning, Housing and Economic Development</p> <p>Can the Cabinet Member explain how the choice based lettings team operate their allocations system to various social landlords?</p> <p>Once one of the bidders details are passed onto the prospective landlords is there any reason that a landlord could refuse a prospective tenant because of race, religion, etc.? ## **FULL COUNCIL ADDENDUM – MEDIUM TERM FINANCIAL STRATEGY 2019/20-2021/22- TRANCHE TWO**

### **Background**

- 1.1. This addendum has been produced in order that Members receive the most up to date position regarding the Tranche Two Budget Consultation.
- 1.2. This document contains consultation feedback received, which we were unable to include within the main report due to the timing of publication.
- 1.3. The consultation concluded at 5pm on 10<sup>th</sup> December, as originally set out on the website and within the Medium Term Financial Strategy 2019/20-2021/22 Report which went to Cabinet on 15<sup>th</sup> October 2018, and again on 3<sup>rd</sup> December 2018.
- 1.4. No paper (hard copy) consultation responses were received at the reception desks or at the libraries.

### **Changes to the Consultation Response**

- 1.5. This update contains the following:
  - The 12 additional consultation responses received. These together with the 32 responses already reported takes the total amount of responses received via the online survey up to 44.
  - A summary of the feedback received as part of the iCASH consultation, which related to one of the public health proposals included within this Budget Tranche.
  - Feedback received from the clinical Commissioning Group (CCG-NHS)

### **Summary of the responses**

- 1.6. A number of the responses raised concerns around reducing the weekend and less utilised bus routes. With a focus being placed on making transport available to all and also keeping the city environmentally friendly, by reducing the amount of cars used in the city.

- 1.7. Concerns were noted in relation to Adult Social care and the welfare of older and vulnerable people, wanting to ensure that the service provision is there to ensure adequate care is available.
- 1.8. There were also a number of responses which commented on the number of people using the City from out of Peterborough, without having to contribute towards the cost of up keeping the City.
- 1.9. Other areas where concerns were raised include Special Educational Needs Funding (SEND), maintenance of highways and pavements, the risks associated with a CAT transfer and the tourism and leisure information services in the city.
- 1.10. A number of suggestions were included within the responses which are outlined in the following points:
  - Increasing Council Tax
  - Increasing Parking Charges, and ticketless parking.
  - Salary Freeze
  - A mechanism for charging non- Peterborough residents for using Peterborough facilities- for example higher parking charges.
  - Income generation from businesses sponsoring social housing
  - Build our own houses
  - Be more efficient in the way we run our buildings (eg- lights, heating, electricity, use of timers)
  - Development of a Business Improvement District (BID)
- 1.11. The Council is proactive in its approach to managing its financial position and closing budget gap. A number of the recommended initiatives outlined above are already being developed or in place, for example a report was presented to Cabinet on 219<sup>th</sup> November, outlining the plans to implement one of these within the City.

## **Consultation – Tranche Two – 2019/20 budget proposals for Peterborough City Council**

Cambridgeshire and Peterborough Clinical Commissioning Group (CCG) has reviewed the proposals for the Tranche Two of the budget for 2019/20 and is writing in response to the consultation.

Firstly, the CCG recognises the significant financial and operational pressures on the City Council and fully supports the priorities agreed by the Cabinet:-

- Growth, regeneration and economic development of the city to bring new investment and jobs. Supporting people into work and off benefits is vital to the city's economy and to the wellbeing of the people concerned.
- Improving educational attainment and skills for all children and young people, allowing them to seize the opportunities offered by new jobs and our university provision, thereby keeping their talent and skills in the city.
- Safeguarding vulnerable children and adults.
- Pursuing the Environment Capital agenda to position Peterborough as a leading city in environmental matters, including reducing the city's carbon footprint.
- Supporting Peterborough's culture and leisure offer.
- Keeping our communities safe, cohesive and healthy.
- Achieving the best health and wellbeing for the city.

Taking in turn the areas under review, the CCG would like to respond as follows:-

### ***Governance Budget***

The CCG has no comments to make on the proposed savings here.

### ***Growth and Regeneration***

The CCG has no comments on the proposed savings here.

## ***People and Communities***

### **Reduction of CCG/PCC/CCC joint post funding**

The CCG supports the removal of the joint funded post within this directorate. There is good joint working across the CCG and the City Council and we do not feel it necessary to have one post solely dedicated to joint working. Our joint working within the Sustainability and Transformation Programme has shown a shift in culture that can bridge this gap.

### **Sensory equipment**

The CCG would like confirmation that there will be no reduction in service provision and that this saving is from purely contractual efficiency.

### **Deliver improved performance in Adult Social Care Team**

The CCG would be interested to know if there would be an impact on staffing levels.

### **Older people's day services and accommodation**

The CCG would like assurances on the anticipated scale of impact and any adverse impact on accessibility being reduced by transport changes proposed.

### **Hospital Virtual Panel**

The CCG would like to work with the Council on this to better understand the processes, KPIs and implementation of this panel and ensure no delays if panels meet less frequently than current assessment processes.

### **Self Funders**

The CCG would be keen to see that there is early, clear advice available for residents, families and carers, so that there are not delays later on due to lack of understanding or challenge.

### **Nursing Home beds block purchasing**

While the CCG understands the reasons for block purchasing, the CCG is concerned that this is carefully modelled to avoid both void costs and insufficient capacity.

### **Care Home Contract monitoring**

The CCG is keen to better understand this sizeable saving plan.

### **Direct Payments Review**

The CCG is concerned that reductions to hourly rates could have a direct impact on the capacity of social care to support hospital discharges.

### **Adult Social Care Demand Management**

The CCG is keen to work with the Council to ensure that patient experience and quality are not adversely impacted by these measures.

## ***Public Health***

### **Staffing**


The CCG understands the pressures on the Public Health budget, but would be keen to know the impact of the deletion of the mental health promotion post on the wider system.

**Amendment from Councillor Walsh to be moved as follows:**

“This Council notes that:

- The United Kingdom has outlawed the farming of animals for their fur on ethical grounds since 2000 and that the use of one of the most common traps used to catch animals for their fur has been illegal for many years.
- Nonetheless fur products are imported from overseas nations.
- Real fur comes from animals raised in deplorable conditions or trapped in the wild and killed inhumanely.
- Regrettably these products are often found for sale on public markets in the UK and customers can inadvertently buy them thinking them to be made of imitation fur.

Accordingly Council resolves to:

- Prohibit the sale of any product wholly or partially made with real animal fur on Council owned land and at Council run or Council leased markets through its contracts and agreements. This ban to cover such items as fur coats, vintage fur, fur shawls, garments with fur trim, fur pompom hats, and fur accessories and trinkets.
- Support the Fur Free Markets campaign of the animal welfare charity, Respect for Animals, the UK's leading anti-fur organisation, by:
  1. Becoming a signatory to the initiative (further information can be found on the 'respect for animals' website here - <http://www.respectforanimals.org/fur-free-markets/>.)
  2. Seeking the advice and assistance of the charity in the implementation enforcement of this ban.

This Council recognises that:

- there is the potential in the city for illegal sales of furs and fur products by peddlers. To trade legally anyone peddling goods must have applied for and been granted a peddler's certificate by the police, they being the responsible body for regulating the activity. A peddler who has been granted a certificate must produce it if asked by anyone to do so.

And therefore resolves to:

- help the public make informed decisions regarding purchases of goods by using its various media platforms to promote key messages.”

### MOTION FROM COUNCILLOR SEATON

#### Amendment from Councillor Shaz Nawaz to be moved as follows:

“Peterborough City Council recognises that fossil fuels have played a central role in the past 150 years of social and technological development, but that their continued use poses a serious risk to the stability of the climate upon which our well-being and economy depends. Climate change endangers the health of local residents in Peterborough, directly through impacts such as heatwaves and indirectly through impacts on food systems and global security.

Scientists have recently estimated that fossil fuel reserves still in the ground are approximately three times the amount which can be burned to have a 50:50 chance of staying below the agreed target of 2 degrees C of global average warming.

A rapid large-scale shift away from fossil fuels towards energy efficiency and alternative sources of energy is needed to avert catastrophic climate change. This will soon render investments in fossil fuel reserves ‘stranded assets’, representing substantial risk for investors and pensioners. This shift to a zero-carbon economy presents significant opportunities and challenges for Peterborough in ~~meeting~~ its mission to become the UK’s Environment Capital environmental aspirations.

In response to this Peterborough City Council pledges:

- to implement it has introduced an ethical procurement policy, including a commitment to not knowingly invest directly in businesses whose activities and practices pose a risk of serious harm to individuals or groups, or whose activities are inconsistent with the Council’s mission and values. This will include avoiding investment in the top 200 publicly-traded fossil fuel companies. It may also include other companies associated with environmentally or socially harmful activities.

- with respect to its ~~it does not hold any direct or indirect investments,~~ to work with a ratings agency to develop a workable ethical policy aligned with the above mission and values with the aim of achieving full divestment within 5 years. in fossil fuel producers

~~- it has proposed and implemented significant energy infrastructure, with an Energy from Waste plant, solar on all council buildings and many schools and has offered free solar power to residents~~

~~- it has worked to reduce fuel poverty and improve energy efficiency with schemes such as Heataborough and LEAP (which offers a free of charge in-home advice visit that may include installing free simple energy saving measures and finding funding for further energy saving home improvements.~~

~~Peterborough City Council also supports the Cambridgeshire Pension Fund, which already has an ethical investment policy, agreed by cross-party and employee / union representatives,~~

~~in using its good offices to persuade companies involved in the production of fossil fuels to seek alternative approaches.~~

However the Council undertakes to;

~~- to work with local~~ work further with councillors, businesses and community groups to support further positive investment in local companies and projects, including community energy schemes, which are hastening a rapid shift to a zero-carbon economy.

~~- to undertake the above pledges such work~~ in the context of a city-wide energy descent plan and energy security policy which will be developed ~~with councillors,~~ local businesses and community groups including Peterborough in Transition.

- to call on the Cambridgeshire Pension Fund to adopt a similar ethical investment policy and divest from fossil fuels.

~~- write to call on~~ the national U.K. government to support the principle of ~~eliminating~~ fossil fuel use divestment, ~~to seek alternative approaches,~~ to stop subsidising the fossil fuel industry and to advocate for all other countries to commit to this in the wake of the Paris Agreement.

- to explore ways of encouraging new properties to have solar PV panels.

- To work with Peterborough businesses and schools to set CO2 emission targets to reduce citywide emissions by 2030."
