## 1. PURPOSE OF REPORT

**1.1** To consider and determine this application for a variation to the premises licence for Select and Save, 9-11 Scalford Drive, Peterborough, PE1 4XQ taking into account the representations received from Cambridgeshire Constabulary, interested parties and a body (Welland Residents Association) representing interested parties.

## 2. BACKGROUND INFORMATION

- **2.1** On 16 January 2006 an application for a new premises licence was submitted by Mr M Yousaf to allow the off sale of alcohol from 06.00 to 21.00. Representations were received from Cambridgeshire Constabulary as the premises were found to be selling alcohol on three occasions prior to obtaining a premises licence. (Despite the police informing the premises they were unable to sell alcohol during this time.) The application was determined by the licensing committee at a hearing which took place on the 13 March 2006. The committee's decision was to refuse the application.
- **2.2** On the 20 March 2006 an application for a new premises licence was submitted by Mr N Yousaf to allow the off sale of alcohol from 06.00 to 21.00 Monday to Saturday and 07.00 to 20.00 on Sunday. No representations were received for this application and it was therefore granted on the 18 April 2006.
- **2.3** On the 22 November 2006 a variation application was received to extend the sale of alcohol from 06.00 to 22.00 Monday to Sunday. As no representations were received to the variation application, the variation was granted on 22 December 2006.

# 3. SUMMARY OF VARIATION APPLIED FOR

**3.1** To extend the hours for the sale of alcohol off the premises for an extra 6 hours per day Monday to Sunday. Current hours are 06.00 to 22.00, variation application is to extend hours to 06.00 to 04.00. The application does not include any extra conditions to be attached to the premises licence and states that *"it is not anticipated that the proposed variation poses any additional risk to the objectives and that the current working practices employed at the premises are sufficient."* 

## 4. APPLICATION

- **4.2** Representations have been received from Cambridgeshire Constabulary as a Responsible Authority under all of the objectives which are, the prevention of Crime and Disorder, the Prevention of Public Nuisance, public safety and the protection of children from harm. - **4.3** Representations have also been received from the three ward Councillors, namely Cllr Saltmarsh, Cllr Ash and Cllr Miners and Welland Residents Association. Copies of these representations are attached at **Appendix E Page 43**
- **4.4** No representations have been received from any of the other Responsible Authorities i.e. Cambridgeshire Fire and Rescue Service, Peterborough City Council Planning Department, Peterborough City Council Health and Safety Team, Peterborough City Council Child Protection, Peterborough City Council Trading Standards and Peterborough City Council Environmental Pollution Team.

# 6.2 Summary of issues raised:

- Residents fear the increased hours will exacerbate the existing alcohol related anti social behaviour in the locality
- Residents fear for their personal safety due to persons congregating outside the shops
- Litter including cans and broken glass bottles
- Noise and nuisance from patrons utilising the shop during the proposed extended hours
- Anti social behaviour including, noise, shouting, swearing, spitting, urination and vomit
- Proximity to a Primary school and Children's (Sure Start) Centre
- Excessive hours for a residential area
- Area of social deprivation
- Street drinking already occurring potential to increase

## 7. MEDIATION

7.1 Mediation was attempted and the solicitor acting on behalf on the licence holder offered to reduce the hours for the sale of alcohol to 02.00. However this was not accepted by the interested parties and responsible authority making the representations. They felt that this was insufficient to alleviate the concerns raised. The solicitor has subsequently withdrawn this offer as it was not accepted.

## 8. LICENSING OFFICER'S COMMENT (FOR INFORMATION)

- **8.1** The changes to the plan have not been advertised in accordance with the regulations. The changes include a change to the existing layout and the inclusion of an external serving hatch. Members should also consider if the new plan can be accepted as part of this variation application.
- 8.2 In February 2007 the premises failed a test purchase, which resulted in a prosecution at the magistrates' court. The seller of the alcohol (Mr Sajid Yousaf) and the Designated Premises Supervisor (DPS) (Mr Naser Yousaf) both pleaded guilty to the sale of intoxicating liquor to a person under the age of 18.

Further test purchases have been made at the premises and the premises refused the sale.

# 10. LEGAL OFFICER'S COMMENTS

- **10.1** The Licensing Authority (hereafter referred to as 'the Council') is charged with implementing the provisions of the Licensing Act 2003. This is an application for the variation of a premises licence made under Section 34 of the Licensing Act.
- **10.2** In this case, the application was received at these offices on 12 May 2010. The period during which relevant representations were made ended on 9 June 2010.
- **10.3** The application before this committee will be treated on its own merits, and the Licensing committee will make its decision based upon:
  - The merits of the application
  - The promotion of the four licensing objectives
  - The statement of policy of the Licensing Authority
  - The Guidance issued by the Secretary of State for Culture, Media and Sport March 2010 under section 182 of the Licensing Act 2003.
- **10.4** The licensing authority may determine the application, depending upon what is necessary for the promotion of the licensing objectives, in any of the following ways:
  - decide to grant or vary the licence in the same terms as it was applied for
  - decide to grant or vary the licence, but to modify or add conditions (to promote the licensing objectives);
  - exclude from the scope of the licence a licensable activity
  - decide to refuse to vary the licence
- **10.5** Conditions are modified if they are altered, omitted or any new condition added (Section 35(4) Licensing Act 2003.

Note: In this document, the following definitions are included to provide an explanation of certain terms included in the Act. In some cases they are an abbreviation of what is stated in the Licensing Act 2003 or an interpretation of those terms. For a full definition of the terms used, the reader must refer to the Licensing Act 2003.

### 'Child'

(a) means an individual aged under 16

(b) a child is unaccompanied if he is not in the company of an individual aged 18 years or over

**DCMS**: Department for Culture Media and Sport

**'Designated Premises Supervisor'** means the person (who must be a Personal Licence Holder), in the case of premises selling alcohol, who will normally have been given the day to day responsibility for running the premises by the holder of the Premises Licence or will be the Premises Licence holder.

### 'Interested parties':

- a person living in the vicinity of the premises in question;
- a body representing persons living in that vicinity, e.g. a residents association;
- a person involved in a business in the vicinity of the premises in question;
- a body representing persons involved in such a business e.g. a trade association.
- a member of the relevant licensing authority e.g. a Councillor

**'Late Night Refreshment'** means the supply of hot food or hot drink to members of the public (whether for consumption on or off the premises) between the hours of 11.00 pm and 5.00 am.

#### 'Licensable Activities' means: -

- The sale by retail of alcohol
- The supply of alcohol by or on behalf of a club to, or to the order of, a member of the club
- The provision of Regulated Entertainment
- The provision of Late Night Refreshment

'Licensing Authority': - is the licensing function of Peterborough City Council

'Licensed Premises' includes club premises and events unless the context otherwise requires.

### 'Licensing Objectives'

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

**'Operating Schedule'** means a document containing a statement of the following matters (and any others that may be prescribed): -

- The relevant Licensable Activities
- The times at which the Licensable Activities are to take place and any other times when premises are open to the public
- Information regarding the person who will be specified in the Premises Licence as the Premises Supervisor

- Where the Licensable Activities involve the supply of alcohol, whether it is for the supply on and/or off the premises
- The steps being taken to promote the Licensing Objectives

**'Rateable Value'**: as regards a premises, is the value for the time being in force for the premises entered in the local non-domestic rating list for the purposes of Part III of the Local Government Finance Act 1988(b).

'Regulated Entertainment' (Schedule 1 of the Act) means: -

- A performance of a play
- An exhibition of a film
- An indoor sporting event
- A boxing or wrestling entertainment
- A performance of live music
- Any playing of recorded music
- A performance of dance

Or entertainment of a similar description falling within the last three of the categories listed above, where the entertainment takes place in the presence of and for the purposes of entertaining that audience or spectators.

Or the provision of entertainment facilities:

Facilities for enabling persons to take part in entertainment of the following description for the purpose or purposes, which include the purpose of being entertained:

- making music
- dancing
- entertainment of a similar description

**'Relevant Licensing Authority':** is the Authority in the area the premises are situated.

'Responsible Authority' means any of the following: -

- Cambridgeshire Constabulary (The Chief Officer of Police)
- Cambridgeshire Fire and Rescue (The Fire Authority)
- Health and Safety Team, Peterborough City Council
- Planning authority, Peterborough City Council
- Trading Standards, Peterborough City Council
- Environmental Health Pollution, Peterborough City Council
- Children's' Services Child Protection & Review Manager
- Maritime & Coastguard Agency, Walton on Naze. (For vessels carrying more than 12 passengers.)
- Environment Agency, Peterborough (For vessels carrying 12 or less passengers).

## 'Supply of alcohol':

- the sale by retail of alcohol, or
- the supply of alcohol by or on behalf of a club to, or to the order of, a member of the club.

**'Temporary Event Notice'** means a Permitted Temporary Activity involving one or more Licensable Activities subject to the following various conditions and limitations: -

- Duration they are limited to events lasting for up to 96 hours;
- Scale they cannot involve the presence of more than 499 people at any one time;

- Use of the same premises the same premises cannot be used on more than 12 occasions in a calendar year, but are subject to the overall aggregate of 15 days irrespective of the number of occasions on which they have been used; and
- The number of notices given by an individual within a given period of time a Personal Licence Holder is limited to 50 notices in one year, and another person to 5 notices in a similar period.

(In any other circumstances, a full Premises Licence or Club Premises Certificate will be required for the period of the event).

'the Act': means the Licensing Act 2003

**'Vicinity'**: Given the normal everyday meaning of being 'near to' when considering the relevance of representations received from individual's residence or business.

# **Annex 1 - Mandatory conditions**

Licensees should note that the under enclosed Mandatory conditions should be read in conjunction with the granted licence and these conditions shall be enforceable where relevant to the operation of the premise and its activities.

# Supply of alcohol (Premises Licence)

This registration authorises the supply of alcohol subject to the following conditions:

1. No supply of alcohol may be made at a time when

(a) there is no designated premises supervisor in respect of the premises licence, or (b) when the designated premises supervisor does not hold a personal licence or his personal licence is suspended.

2. Every supply of alcohol under the premises licence must be made or authorised by a person who holds a personal licence.

# Annex 2 - Conditions consistent with the Operating Schedule

# **Crime and Disorder**

- 3. Video/CCTV equipment will be set to record from the time that the premises open to the public until the premises close and all members of the public have left.
- 4. Notices advising that CCTV has been installed on the premises shall be posted up so that they are clearly visible to the public within the licensed premises.
- 5. Video/CCTV images shall be retained for at least one month and shall be produced to an authorised officer on demand.

# Public Safety

6. The licence holder must ensure that the premises complies with all existing relevant Health and Safety Regulations.

# **Public Nuisance**

7. A proof of age policy agreed by the police and local authority shall be implemented.

# Protection of Children from Harm

8. Any person selling or supplying alcoholic drink under the authority of a personal licence holder must ask for a photo ID proof of age where they have reason to suspect that the individual may be under 18 years of age.







#### EMAIL FROM PC IFOR MADDOX

On behalf of the Chief Constable, I would like to object to the 4am closing of the Select and Save application.

We have considered the application and are concerned that opening until 4am will impact on the 4 licensing objectives:

- the prevention of crime and disorder
- public safety
- the prevention of public nuisance
- the protection of children from harm

Antisocial behaviour has been a neighbourhood policing priority since April 09 to the present time. Alcohol related crime is already showing a 6.3% increase on last year and ASB an increase of 34.1% in the East Team Norths policing area.

Mapping where ASB is in the neighbourhood a high proportion are in the area surrounding Scalford drive. Having a 4am closing time will in our opinion exacerbate the ASB and alcohol related ASB in the area.

A recent article in the ET had quotes from people living in the area they said the following:

#### Person 1

"I don't think it is a good idea. I have a young baby and the shouting and noise might wake her up. I sometimes use the shop, but I don't like the proposed new hours."

#### Person 2

"There is supposed to be a law against people drinking in the street but that still happens and this will only make things worse. There is not a lot of trouble around here at the moment, but I am concerned it might start. We don't want people fighting in the street."

#### Person 3

"There is enough drink about as it is. There are problems with rubbish with cans and bottles being left in the street as well."

#### Person 4

"I don't see why there would be a need for the extra hours. There are enough places to get alcohol as it is."

#### Person 5

"I can't see that having that sort of kind of thing would be good in a residential area. "It's going to create a lot of problems in an area where a lot of people are living. It might be different if it was in the city centre."

The parade of shops in Central avenue were experiencing high ASB and a wide range of police measures culminating in a dispersal order were put in place.

We have also received a comment from the local PCSO who states:

"As the local officer I have witnessed a lot of unreported ASB around the licensed supermarket. There are a lot of people who hang around outside the supermarket drinking alcohol and are intimidating to members of the public. A lot of the time the people hanging around are quite intoxicated and loud. It is my belief by granting an extension to the liquor license will only have a detrimental effect on this residential area and bearing in mind the supermarket is opposite a school and a Sure Start building where Families are constantly coming and going. This area has historically has had a number of issues surrounding ASB, I do believe that if the license was granted until 4am this would attract and cause ASB in the local area.

I would also like to object to this application.

1 The extra opening hours will lead to more crimes being committed in the area. The police are very worried about this.

2 People gathering outside the shops with cans, bottles etc in their hands are very frightening to other users of the shops along the parade.

3 The extra noise at night will be a nuisance to local residents especially to those living in the flats above the shops.

4 Children will be put at risk as these premises are opposite a Primary school and a Children's Centre.

The Scalford Drive parade has only recently become a place where people feel safe and we do not want to go back to the days when it was a no go area.

Re: Licensing Act 2003 - Select and Save, 9-11 Scalford Drive, Welland, Dogsthorpe, Peterborough.

From the outset, may I say how astounded I was to learn of this application to sell alcohol 22hours a day from this retail outlet. The applicant has obviously no detailed knowledge of the surrounding community and its acute deprivation levels....or a sense of community responsibility.

From the outset, Welland has experienced a bad press. Some of it fabricated by an overzealous press - but some justified by its sheer historic levels of economic and social deprivation that generates a spiral of decline in family values.

In a 1989 report, P'Boro City Council financed the production of a document entitled 'Welland - A Project Appraisal'. Here was a comprehensive study listing some of the issues of local concern and identifying the urgent need for the Government and City to finance "Regeneration Projects" throughout the community area.

Various other in-depth studies followed - culminating in over £10m being spent on local environmental improvement schemes. Which is now only nearing final completion, thanks to investment by the new social landlord in the area, Cross Keys Homes.

The Greater Dogsthorpe Partnership (GDP) was financed & came into being solely on the back of certain high levels of social deprivation on Welland ("Hot Spots"). Without the recorded nationally recognised levels of poor health, unemployment, lack of work skills/training, secure family units, one-parent families, benefit dependency, severe income levels etc etc....the GDP would never have appeared locally.

Welland has always been blighted with a label of petty crime and social disorder. Adjoining communities stating that "them over there" are the culprits "those living there" are the ones responsible.

#### Crime & Disorder

There is a record of anti-social behaviour in & around the shopping area where this shop is located. This culminated in various dispersal orders, installation of CCTV and increased local policing.

There is an alcohol problem in the area - an acute alcohol problem. There are large areas virtually swimming in discarded drink cans/bottles in the immediate vicinity. Local shrubbery seems to have more bottles/cans than flowering shrubs! There is a problem already of drinkers sitting/camping outside the Children's Centre (Surestart) Acorn Centre opposite on the grassed frontage drinking their alcohol during daylight/work/school times (Welland Primary School is also opposite on the other side of the road). These drinkers seem to be waiting for friends or family members visiting the Children's Centre to come out!

Increased time & opportunity to buy even more alcohol at virtually all hours will lead to more acts of anti-social behaviour.

The lack of adequate and positive local community policing is already a local issue. How on earth are the Police going to cope with even more drink related social disorder & crime during these extended shop opening hours to sell cheap booze!

#### Public Safety

The Police will hopefully be able to give more detailed historical information on the aspects of local public safety around this area.

Already many people feel intimidated by 'gatherings' of people obviously under the influence of drink or drugs.

Some families will not use this shop because they are in fear of their own personal safety. Will it be safe to walk home in the dark when there are individuals buying & drinking alcohol at all hours!

Alcohol attracts those elements in society that prey on easy targets and is the ignition required for acts of GBH and ABH.....culminating in violence and acts of theft etc.

Family units locally will suffer. Those addicted to drink will go and buy that extra can/bottle of booze - instead of that healthy food option for their baby/child. The temptation to buy and consume even more drink will be too much for those addicted. Resulting in more child abuse/partner abuse and drink related illnesses and deaths.

I know Alcoholics Anonymous is already very worried about the high levels of consumption of all ages locally and fearful of the damage young drinkers are doing to their physical and mental health.

#### Public Nuisance

There is already a problem with discarded beer cans/bottles...wine/cider containers. Smashed glass is regularly crushed underfoot.

Coupled with the drink comes NOISE / SHOUTING / ARGUING / SWEARING / SPITTING / URINATING and sick being deposited everywhere.

Having lived locally in the area all my life and being a local councillor representing the area for over 30yrs - I am convinced such an extension to sell alcohol 22hrs a day will result in more acts of nuisance behaviour and fear of feeling safe to walk locally.

What about those living above the shop area. They will suffer acute public nuisance with cars driving to buy booze at all hours...no doubt with car radios/horns blaring and then speeding/racing along local roads.

#### Protection of Children from harm

Obviously I have touched on this issue in various previous statements above. Children will be in more danger of family abuse/attack.

They will be in danger of injury when walking/playing locally because of all the discarded bottles/cans/litter being strewn/thrown all over the place by people the worse for wear because of their lack of consumption control with alcohol levels.

Why is there a local Children's Centre in the community.....these Surestart centres are there to plug social gaps, to give/offer opportunities and attack poverty at its source.

If this application to sell alcohol locally 22hrs a day is allowed then this local authority is sourcing the continuing high levels of poverty and benefit dependency that so blights the local community.

We should be encouraging less alcohol consumption and not more. We have a social duty and responsibility to safeguard children and family well-being. There can be only one decision REFUSAL.

Hi,

I have received a resident response to this application.

She wishes to remain anonymous but can be described as Mrs R.D.

I now repeat her exact words.

#### The Prevention of Crime & Disorder

"It will increase both by encouraging people to have somewhere to congregate. It will give drunks and youths the chance to sit on the walls near the shops a drink at all hours & make an unruly row, when most residents just need to sleep. This often happens in the daytime now, but in the small hours of the morning the noise is exaggerated and will keep people awake. Cans & bottles are already thrown around everywhere now and children going to school in the morning do not need to have this type of rubbish to contend with. Why do people really need to shop at this time of the morning anyway!"

#### Public Safety

"It will encourage even more drunks into the area and we have enough already in this socially deprived area."

The Prevention of Public Nuisance

"This will cause an even bigger problem for people who live near the shop and many drunks already trot up & down Redmile Walk all day now. In the peace and quiet of the night the sound will become louder for residents. The shop needs to have less opening hours not more."

#### The Protection of Children from Harm

"The shop is opposite a Primary School and also a Children's Centre. Obviously these are both closed at night, but the debris of cans & bottles is already visible in the day hours and is not nice for children and parents alike. Vomit can often be seen in the vicinity of the shop in the mornings & at the side of the shop, drunken men can be seen in the daytime urinating against the wall.

Parents are already witnessing anti-social behaviour and it is having the effect of making them feel that they do not want to park

their car near the shops or even come into the shop/s or attend groups at the Children's Centre.

Children attending the school are having to walk by drunks now and they should not have to be exposed to this" Unquote.



# **Store launches** 4am drinks bid

PLANS by a city shop to sell alcohol until 4am have been met with

anger by residents living nearby. The Select and Save shop, in Scalford Drive, Welland, has applied to Peterborough City Council for a licence to sell al-cohol from 6am until 4am, seven days a week.

Currently, the shop - which is opposite Welland Primary School – has a licence to sell alcohol until 10pm. A decision will be made on June 9 and if

approved the shop could start trading with its new hours the following day. However, people living nearby are con-

cerned about noise, trouble and litter which could be created by the new hours.

Mother Ester Zawisza (29) said she was concerned that there would be more noise at night.

She said: "I don't think it is a good idea I have a young baby and the shouting and noise might wake her up. I sometimes use the shop, but I don't like the proposed new hours.

Another resident, Wendy Clark (47), add-ed: "There is supposed to be a law against people drinking in the street but that still happens and this will only make things worse. "There is not a lot of trouble around

here at the moment, but I am concerned it might start. We don't want people fighting in the street.

Teresa Pickett (43) added: "There is enough drink about as it is. There are problems with rubbish with cans and bottles being left in the street as well.

Her husband Christopher Pickett (50) added: "I don't see why there would be a need for the extra hours. There are enough places to get alcohol as it is."

Councillor Chris Ash, ward councillor for Dogsthorpe, said: "I can't see that hav-ing that sort of kind of thing would be good in a residential area. I will be putting in a formal comment to the council along those

an area where a lot of people are living. It might be different if it was in the city cen-

A Peterborough City Council spokeswoman said there are 16 premises in the city licensed to serve alcohol longer than the planned hours at the shop. Of those, six are pubs and clubs, including city centre bar Angels and The Cresset theatre at Bretton. The remaining 10 include supermarkets, large convenience stores and hotels

Owner of Select and Save, Naser Yousaf, said the hours would help him compete with other stores.

He said: "Keeping the shop trading until 4am will ensure we serve the needs of the community. I am also taking this action because of competition from nearby supermarkets

He said night staff would serve customers through a hatch to ensure security.

Cambridgeshire police community safe-ty and licensing team leader Debbie Sampson said police are gathering information before making a representation to the city council on the application.

The main aim of a new bypass would be to give people an alternative route from March to Peterborough and to make sure that when the A47 is blocked that the A605 through Whittlesey is not used as a rat run. People who say a King's

Dyke flyover is not needed need to look at what happens when the crossing is closed for engineering works, there are three alternative routes; north bank which cannot cope with HGVs and is shut at various times throughout the year through flooding, travelling the back roads through Pondersbridge which adds 3-4 miles each way to your journey and has many treacherous bends and the A47 which adds 7 miles each way and travelling through Thorney depends on the B1040 Wash Road being open.


