## The Proceedings

Following referral by the Investigation Officer, an investigation into a complaint made about Councillor Fower was presented to the Adjudication sub-committee of the Standards Committee for Peterborough City Council.

In order to determine the findings of fact, the committee was addressed by the Investigation Officer and Councillor Fower. The committee questioned both parties to clarify any issues. The committee adjourned in order for the panel to determine the findings of fact.

The findings of fact were presented to the Investigation Officer and Councillor Fower who were able to make representation about whether the findings constituted a breach of the Code of Conduct. The committee adjourned in order for the panel to determine whether the facts constituted a breach of the Code. The panel agreed that there had been a breach of the Code.

Councillor Fower was able to make representations as what any sanction should be. The committee adjourned in order for the panel to determine any sanction. The panel agreed the sanctions as detailed below.

Result

The Chairman made recommendation to the Authority and then closed the meeting.

### Sanction Imposed

The Panel see this as a serious breach of the Code of Conduct and therefore:
1. we censure Councillor Fower for divulging confidential information.

- 2. we require that a written apology is provided to Councillor Goldspink within two weeks of today's date. A copy shall be provided to the Monitoring Officer.
- 3. that Councillor Fower shall undertake appropriate training by the Monitoring Officer on the subject of trust and a councillor's duty not to disclose confidential information.

### Reasons

That a serious breach of the Code of Conduct which undermines the trust between Councillors and the public has occurred.

#### **Right to Appeal**

Councillor Fower has the right to apply in writing to the president of the Adjudication Panel for England for permission to appeal the standards committee's finding. The president of the Adjudication Panel must receive written notice within 28 days of the member's receipt of notification of the standards committee's finding.
