1. Apologies for Absence

No apologies for absence were received.

2. Declarations of Interest and Whipping Declarations

Declarations of interest were received from Councillor JR Fox and Councillor Sandford in relation to item 6 on the agenda - Environment Capital: Progress Update. Councillor Fox declared that he was employed by the Peterborough Council of Voluntary Services as a coordinator of Shop Mobility. Councillor Sandford declared that he was a Director on the Board of the Peterborough Environment City Trust and worked for the Woodland Trust as an employee. He also declared that he had Solar Panels fitted on his own property and received a Feed-In Tariff.

3. Minutes of the Meeting held on 9 June 2011

The minutes of the meeting held on 9 June 2011 were approved as a correct record.

4. Call In of any Cabinet, Cabinet Member or Key Officer Decisions

There were no requests for call-in to consider.

5. Members Waste and Recycling Task and Finish Group

The report informed the Committee of the proposal to disband the Members Waste and Recycling Task and Finish Group which had been formed in January 2003 under the former Leader of the Council and was then repositioned as a sub working group of the Environment Capital Scrutiny Committee in April 2009. After considering the proposal the Committee sought assurance from Officers that if the Task and Finish Group were to be disbanded that all important items relating to Waste 2020 would be brought before this Committee. Officers gave assurance that this would happen.

RECOMMENDATION

The Committee recommends that the Members Waste and Recycling Task and Finish Group be disbanded immediately and that all future monitoring of Waste 2020 be dealt with directly through the Environment Capital Scrutiny Committee reporting process.

6. Environment Capital: Progress Report

The report provided information on progress in delivering the "Home of Environment Capital" initiative. The Director of Environment Capital confirmed that the "Home of Environment Capital" Major Policy had been approved by Council in 2010 and was now being used across the authority. Members were informed that a report would be brought to the next meeting of the Committee on the performance of the City in comparison to other cities. The assessment for this had been based on the Forum for the Future Sustainable Cities Index. A full report on the progress of the Carbon Reduction Commitment (CRC) would be presented to the Committee in March 2012.

Questions and observations were raised around the following areas:

- Members were concerned that the increase in rejection of wind farms would affect the renewable energy policy. The objections were usually about visual quality and these would have to be taken into account but if the right sites were chosen then it would not have a major effect.
- Is it possible to put Photo-voltaic panels on the Lido building? In the process of setting up an Energy Services Company and as part of that process a full buildings assessment would be carried out. The Lido had not been identified but it would be added to the list.
- Waste to energy plant. Would it be possible to have a pipe to carry steam to the Regional Pool and Lido for heating? The facility would be combined heat and power enabled and a requirement would be to extract heat. This would mean that heat could be moved to adjacent industrial or commercial buildings like the Regional Pool. However it would take additional investment to lay the pipes and would therefore take a while to implement.
- In the report it was mentioned that PCC had completed and submitted a bid totalling £4,999,990 to the Department for Transport which included sustainable transport improvements and aimed at increasingly integrating sustainable travel into mainstream travel planning. It covered four key packages:
 - 1. Working with individuals, communities and neighbourhoods
 - 2. Workplace travel planning
 - 3. Healthier travel
 - 4. Young peoples travel

How do you propose to publicise these initiatives. The Sustainable Environment Manager informed the Committee that the bid had been successful for the full amount of £4,999,990. The bid detailed the initiatives under each package and included projects with local businesses, schools, Primary Care Trust and large infrastructure projects such as looking at the cycle infrastructure around the station. A full copy of the bid could be provided to Members.

Members congratulated officers on their hard work in successfully receiving the full amount of the bid.

The Cabinet Member for Environment informed Members that Peterborough City Council
had just launched a cycle to work scheme where employees were offered the chance to
buy a bike through work and claim the tax back.

- Could some of the bid money be used for Bluetooth communications for people who are partially sighted? The bid does include looking at technology solutions and the Sustainable Environment Manager welcomed suggestions for further investigation.
- Members wanted further clarification on the tangible benefits of The Peterborough Model and how adaptable it was and what it delivered. Members were informed that The Peterborough Model used Google Earth for its base and it provided a clearer way of translating data that would normally be presented on spreadsheets. The type of data provided would be information on energy use, water use and flood plains. The information was turned into a graphic 3D image. The benefits will mean that a public website will be launched in a few weeks showing the City's environmental performance.
- The Cabinet Member for Environment informed members that the Peterborough Model would ideally be used for decision making to benefit the city and a future modelling device. It would also be a useful educational tool for schools and colleges.
- Does the authority get any royalties from the The Peterborough Model if used by other authorities? No royalties would be received but it will be published and sold as the Peterborough Model.
- Does the authority have a strategy for promoting solar energy and renewables? Members were informed that there was no dedicated policy for renewables in place. In the current economic climate if housing developers were expected to build to a code 6 sustainably rating which was a zero carbon home then it would make the housing developments completely unviable. A guidance document for developers was currently being produced on what the authority would like to achieve as an Environment City. When the housing market picked up this would go to Full Council to become policy. The Home of Environment Capital Policy did state the following within its policy:
 - We will seek to minimise the use of energy and will ensure that, where energy is used, it will be done so effectively and efficiently.
 - We will seek to minimise waste of energy, and will ensure that, where energy is used, the greatest possible proportion becomes useful heat, light or power. We will use environmentally safe and, where practicable, sustainable energy sources and will invest in, demonstrate and promote, the benefits of energy efficiency.
- Council Landlords could improve the use of Photo-voltaic panels if there was a Green Leasing Policy in place. There is currently no incentive to put them on properties as under tenancy agreements properties have to be returned to their existing state when occupants leave. Has the Council looked into this? Members were informed that officers had been asked to investigate this. The Director of Environment Capital also advised Members that systematically every council property was being looked at and assessed to see how much electricity could be generated from their roofs and prioritised for its capability to produce electricity.
- Can we ring fence the money that is saved by using solar panels and reinvest it into wind farms and further Photo-voltaic panels. The savings that were made would be invested into further green projects. There was some money in the Salix Fund which provided interest free funding to accelerate investment in energy efficiency technologies. Savings made through these investments went back into the fund for further investment. Members were invited to put ideas forward for green projects.
- Can you guarantee that the public transport budget will remain the same in the next financial year? The bus subsidy budget had been set and no cuts were planned.
- Can you evidence that there has been a 9% reduction in traffic. This information came from the Travelchoice data. In 2004 and 2005, at the beginning of Travel Choice, surveys were completed on a group of people who kept a diary of their travel behaviour. The same group were resurveyed in 2008 and it demonstrated an increase in bus usage, walking and cycling equating to a relative reduction in car use of 9% across the targeted group of people. Of late there is also evidence of more people cycling from the data gathered through the cycle counters placed across the city. In addition, traffic flow data shows no significant increase in car use.

- 1000 trees had been cut down during the building of the hospital and it was promised that these would be replaced. Approximately 300 trees have been replaced but many of them have died. Can you ensure that the trees would be replaced and that the ones that had died would also be replaced? The Cabinet Member for Environment assured Members that the trees would be replaced. Approximately 800 trees had been replaced so far and was unaware that many had died. This would be looked into. As part of the Enterprise Contract there was a full survey of all the trees in the city being completed.
- The Committee are still waiting for a response to the Friends of the Earth questions with regard to costings on the Waste 2020 facility. When can we expect to receive a report in response to the questions? Officers advised that they were still waiting to hear from Friends of the Earth with regard to clarification on some of the questions. Members requested that a report be brought to the Committee as soon as possible.
- Can you explain the item in the report which states that there will be a project to expand
 the Shopmobilty scheme to local centres and provide charging points for scooters? The
 ConAge bid was a bid to the European Commission to provide funding to improve and
 increase the use of sustainable travel to people over 50. More detail with particular
 reference to the Shopmobility scheme would be provided by the officer leading on the
 project.

ACTION AGREED

The Committee agreed that:

- I. A full report on the progress of the Carbon Reduction Commitment (CRC) would be presented to the Committee in March 2012.
- II. A full copy of the Local Sustainable Transport Fund bid would be provided to Members.
- III. The Cabinet Member for Environment would look into the replacement of dead trees at the new hospital site.
- IV. A report be brought to the Committee on the costs of the Waste 2020 facility in answer to the Friends of the Earth questions.
- V. Further detail to be provided to Members on the expansion of the Shopmobilty scheme to local centres and provision of charging points for scooters.
- VI. Officers to provide a demonstration to the Committee on The Peterborough Model at a future meeting.

7. Environment Capital: Introduction, Overview and Work Programme

The report presented the Committee with an overview of the issues, opportunities, priorities and challenges in connection with the Environment Capital theme. The Committee were asked to identify areas of work to be included in their work programme for the coming year. The report listed the Environment Capital Key Deliverables which were Environmental Businesses, Sustainable Transport, Conserving Natural Resources and Cleaner and Greener.

Members discussed the report and agreed that they should look at the area of conserving natural resources as the main theme of work over the coming year.

ACTION AGREED

That the Committee looks at the theme of conserving natural resources for the work programme for 2011/2012. This to include:

- Consideration of a policy on renewable energy
- Street Lighting Capital Project
- Green Deal Initiative

8. Forward Plan of Key Decisions

The latest version of the Forward Plan, showing details of the key decisions that the Leader of the Council believed the Cabinet or individual Cabinet Members would be making over the next four months, was received.

ACTION AGREED

The Committee noted the Forward Plan and agreed that there were no items for further consideration.

CITY COUNCIL'S BIODIVERSITY STRATEGY: PROGRESS REPORT 2010/11

1. PURPOSE

- 1.1 The purpose of this report is to:
 - a) Provide information with respect to progress against the actions and targets contained in the PCC Biodiversity Strategy (2010).
 - b) Allow feedback to be given by the Committee with respect to progress against the existing strategy.

2. RECOMMENDATIONS

2.1 The Committee is asked to consider the progress made against the City Councils 2010 Biodiversity Strategy and to make any recommendations with regards to the future implementation of the Strategy.

3. LINKS TO THE SUSTAINABLE COMMUNITY STRATEGY

3.1 The 2010 strategy contributes to the Sustainable Community Strategy and LAA via the LAA Biodiversity target which is based on National Indicator 197 (improved local biodiversity), now replaced by National Indicator 160. It is more generally linked to the Community Strategy and National Indicators via the Cleaner/Greener agenda and sections of these documents. It has been agreed with the Greater Peterborough Partnership that reporting against the PCC Biodiversity Strategy will be used, along with other reporting, to give a more detailed picture of the breadth of the actions taking place for biodiversity under the LAA Biodiversity target.

4. BACKGROUND

- 4.1 This report is submitted to the Committee by the PCC Biodiversity Officer Working Group as a progress report for 2010/11 against the existing PCC Biodiversity Strategy. The Strategy was agreed in 2010 with a requirement for annual reporting on progress against the specific actions and targets of the strategy.
- 4.2 This progress report is against the 2010 PCC Biodiversity Strategy.

5. KEY ISSUES

5.1 The key issues which the Committee need to consider are laid out in the appendices. All progress on required actions since the 2009/10 progress report have been achieved from within the Council's existing budgets. Future ability to progress against the 2010 strategy will be dependent on some changes to land management and maintaining existing resources where possible.

6. IMPLICATIONS

6.1 The 2010 Biodiversity report included consideration of cost and resource implications. It was made clear that the actions set out in the 2010 report would have to be achieved within existing resources and that it was envisaged that biodiversity gain could be made through adjusting rather than completely changing current practices. The adoption of the vision statement by Full Council strongly reinforced this.

7. CONSULTATION

7.1 Consultation and discussion has been undertaken with the Executive Director of Operations and the City Council's Biodiversity Officer Working Group.

8. NEXT STEPS

8.1 Feedback from the Committee will be used to inform the future focus of the PCC Biodiversity Officer Working Group.

Appendix B: Full reports from the members of the Biodiversity Officer Working Group

1. Bereavement Services

Cemeteries

- 1.1 The wildlife value of cemeteries is continuing to be recognised, the Friends of Broadway Cemetery Group continue to appreciate the site, which is a County Wildlife Site. The control of bramble and scrub is ongoing at Broadway and the evidence of wildlife has been constant since the last reporting period.
- 1.2 No further action has taken place at Eastfield Cemetery since the last report and the County Wildlife Survey carried out in 2009. The mowing regime has remained the same as it was felt that the cemetery is relatively new compared to Broadway and a change in the cutting regime to aid the wildlife who not be suitable. It has been noted that the sighting of rabbits and squirrels have increased in recent years.
- 1.3 Bereavement Services may put forward an application and management plan to the Green Flag Award Scheme in 2012 to try and get accreditation for one of their cemeteries.

Crematorium

- 1.4 The wildlife area has again continued to develop, the native species are propagating well supplemented with the planting of plugs of native species. The sensitive management of the area has ensured that the compromise with the cutting regime has been accepted by the bereaved.
- 1.5 The Children's Memorial Garden continues to flourish it is regularly maintained in a sympathetic manner which ensures it continues to attract butterflies, bees and other insects. The planned extension to the path from the garden into Pococks Wood has been shelved due to the discovery of an active badger sett along the proposed route.
- 1.6 The reopening of an old path into Pococks at the eastern end has been considered, a tree survey to make safe the route has been carried out and funding is now being identified. With bramble cleared and the tree canopies lifted it is hopeful that native woodland plants may once again thrive.
- 1.7 The Bereavement Services Team have been awarded a further Green Flag for 2011.

2. Children's Services

- 2.1 Children's Services has responsibility for all trees on school sites and are in the process of going out to tender to various arboriculturists for the maintenance of the trees on a 3 year rolling programme. This will ensure that the sites are visited on a regular basis and general advice will be given, including the addition of features which will enhance the grounds as wildlife habitats.
- 2.2 58 PCC schools have either registered, participated, or are currently working towards an eco-school award (see below). Others are actively involved in similar schemes or have developed their own action plans, indicated below as 'other comparable frameworks'. PECT have their own education officer who assists schools with the scheme.

- 2.2 Children's Services assets and school place planning team also operate a "landlord's consent" scheme whereby all schools are required to register capital works to their premises, this enables monitoring and advice to schools in respect of grounds works, planting schemes, ponds, etc. Occasionally works which are not in accordance with City Council policy or procedure, such as inappropriate felling or pruning of trees, can be intercepted via this scheme.
- 2.3 With a rapidly expanding school building programme at both primary and secondary level sustainable features are being incorporated wherever possible. Green roofs that encourage birds and insects are being installed for both new builds and replacement roofs. External landscaping designs are developed to provide some natural spaces both to benefit wildlife and to be an educational resource for pupils. Where a pond had to be relocated to enable a school extension to be built, advice was taken from Natural England and Froglife to ensure suitable alternative ponds were provided.
- 2.4 Schools are funded mainly from Government grants and the vast majority of the funding is devolved to them to make their own management decisions. Therefore, they do not have to comply with City Council procurement regulations. This means that they can use their own preferred contractors, and are free to specify and order works. Schools have to apply for appropriate planning and building control permission as well as consent from Childrens Services as landlords

3. Climate Change

3.1 Unfortunately there has been little progress against the refresh of the climate change strategy due to the need to focus resources within other areas of the climate change work. However, the climate change officer has now begun the process of refresh with a view to prepare the draft version for Environment Scrutiny in early 2012.

4 Natural Environment

The Natural and Historic Environment Team by its nature continues to be involved with much biodiversity activity both within the City Council and in partnership with external partners. A significant proportion of the team's activity is focussed in providing expert advice to the Planning Departments with respect to the development of the Local Development Framework as well as planning applications and the implementation of development within the Unitary Area.

4.1 **Recent/ongoing activities**. These include:

- a) Leading on the achievement of the National Indicator Target for Biodiversity. This has included close liaison with key partners such as the Wildlife Trust, Environmental Records Centre and Peterborough Geology group. Peterborough Conservation Volunteers have also played a vital role in undertaking work on Peterborough sites to maintain and bring them into positive management.
- b) Support to the development of the successful Skills for the Future Bid to the Heritage Lottery Fund by Peterborough Environment City Trust. This includes one post which will be hosted within the team during 2012 which will map and update the Green Grid Strategy as a live electronic (GIS) document and undertaken field surveys of habitat networks. In addition one built environment post is currently being hosted within the team during 2011.
- c) Continued support for the long standing Peterborough Barn Owl recovery programme. This is now recognised as one of the most successful of these programmes in the UK. The data from this ongoing monitoring scheme has proved crucial in the provision of advice to the Planning Department with respect to a number of strategic planning applications for example for wind farm proposals and public enquiries and how they would relate to this key environmental feature of the Unitary Area. Press releases for this project and a new webpage have been published in the last 12 months.
- d) Liaison and advice to officers and departments from across the City Council with respect to Biodiversity. In addition to those specifically represented on the Biodiversity Officer Working Group these also for example include highways and rights of way officers.
- e) Surveys, provision of advice to landowners and activities carried out on behalf on the Natural Environment Team by the Wildlife Trust via a Service Level Agreement.
- f) Continued support for monitoring and habitat management for the rare four spotted moth in Peterborough. The monitoring has also allowed the extension of the neighbouring County Wildlife Site and its continued assessment as being in positive management which has directly contributed to the National Indicator 197 target included in the Local Area Agreement.
- g) Representation of the City Council with and support to the Cambridgeshire and Peterborough Environmental Records Centre which has provided data for a number of PCC projects and reports including those associated with the Local Development Framework, Annual Monitoring Report and National Indicator 197.

- h) Representation of the City Council with and support to the Cambridgeshire and Peterborough Biodiversity Partnership and its associated projects. The work of the partnership has recently included the development of a ponds restoration project aimed at restoring at least 30 ponds across the County with at least 5 of these within the Peterborough area. Whilst the initial bid was unsuccessful, it is anticipated that funding may become available from reserves in the Biodiversity Partnership to enable several of Peterborough's ponds to be restored in the near future.
- i) Representation of the City Council within and support to the Natural Networks Partnership.
- j) Administration and technical support to the City Councils Natural Environmental Grant Scheme which has supported a significant number of projects with schools, Parish Councils and other organisations.
- k) Continued support to the planning department to enable the integration of Biodiversity into new development. This has for example included recent and ongoing developments at, Hempstead, Great Haddon as well as wind farms, road schemes and minerals and waste sites. A planning application checklist has also been produced based upon the Natural England standing advice for use by planning applicants and planning officers.
- I) Continued support to the Planning Policy Team with respect to the production of Local Development Framework.
- m) Liaison with and support to local conservation organisations such as the Wildlife Trust, Buglife, Froglife and the Langdyke Countryside Trust and their sites and projects.
- n) Provision of support and guidance to landowners and community groups in relation to biodiversity, this has included Schools and Parish Councils.
- o) Provision of biodiversity education via schools liaison, interpretation, guided walks and presentations, including a bat walk.
- p) Support to the Peterborough Green Festival for example through Officer support during the planning of this event and provision of activities as part of the festival.
- q) Administration and support to the Peterborough Tree and Pond Warden Networks. The City Council continued as a full member of the Tree Council and was therefore able to continue to fully support the tree Warden Network.
- r) Continued support to Peterborough Conservation Volunteers where their activities have taken place on PCC owned sites and Peterborough County Wildlife Sites.
- 4.2 **Current activities:** In addition to the continuation of many of the activities listed in 4.1 current activities and projects of note include:
 - a) Leading and co-ordinating the update on annual progress against the City Councils biodiversity Strategy, which is due to be reviewed by Cabinet in September.
 - b) Support to PECT with respect to the production of work and training plans for Skill for the Future placements which will be hosted with the team.
 - c) Continued support to the County Wildlife Sites System and progression against the LAA/National Indicator target.

- 4.3 **Future Activities:** Where relevant and budgetary approval is received it is planned to continue activities listed in 4.1 and 4.2 such as the Natural Environment Projects Grant. Other planned future activities and projects of note include:
 - a) To continue to work with the project group of the Biodiversity Partnership to prepare project bids for various schemes aimed at enhancing biodiversity at several of Peterborough's County Wildlife Sites and ponds.
 - b) To continue to work with PECT to ensure that the Skills for the Future posts hosted by the team are well recruited and a success.
 - c) To work with bereavement services to investigate the production of a management plan for Pococks wood and possibly the accessing of external funding for woodland management works.
 - d) To work with Natural Networks partners on the Forest for Peterborough initiative.

5.0 **Property Design and Maintenance**

- 5.1 Local Authorities have an explicit duty to consider biodiversity in the discharge of their functions. In accordance with this duty and the City Councils Environmental Strategy the Property Design and Maintenance division actively champion biodiversity and sustainability in a number of ways, the majority of which are already incorporated into standard practice through the careful specification and monitoring of contracts. For example:
 - ensuring trees are adequately protected when development takes place
 - planting new trees for any that have to be removed when development takes place,
 - the control of waste and pollution,
 - the sustainable sourcing of materials,
 - the temporary storage of soils that might otherwise be removed from site,
 - good site fencing to ensure that areas damaged by the very disruptive nature of construction activity to a minimum

Building on previous initiatives, the Property Design and Maintenance division, now Enterprise Peterborough, continues to promote biodiversity and sustainability, wherever it can.

- 5.2 Over the last year green roofs have been installed at Hampton Hargate and Woodston Junior Schools as well as on Children's Centres at John Clare School Helpston, and Thorney.
- 5.3 A green roof is also being proposed at Eye Primary School and the design for the new Welland School includes extensive green roofs, rain water harvesting and wood chip heating.
- 5.4 At Hampton Hargate two wildlife ponds have been created to replace one that was lost in the extension works. This project also includes rain water harvesting and ground sources heat pumps.
- 5.5 The new Community Car Park at Werrington using sustainable drainage concepts has created opportunities for short term damp habitats within its extensive wild flower areas.
- 5.6 Planting schemes, which included a small area of new woodland at Clare Lodge continues to use native plants wherever appropriate as well as woven willow structures in children's areas.
- 5.7 By designing with the ethos of removing the need to consume electrical energy for lighting and ventilation, we seek to make significant reductions on existing and new buildings

potential carbon footprint thus having a positive environmental impact in the short and long term.

6.0 Peterborough In bloom

6.1 An annual garden competition has been co-ordinated for the last 5 years, 2011 being the fifth year; this includes a wildlife friendly category. This receives a steady percentage of entrants and the gardens are judged on a wide variety of elements, all contributing to biodiversity. Peterborough was also awarded a Gold award for Anglia in Bloom.

7. Enterprise Peterborough (formerly City Services)

Action in support of biodiversity & sustainability taken or planned 2010/11

- 7.1 The G50 parkway grass cutting specification has been changed to one breed along the kerb line of 50mm to 100 mm with the remainder cut at 100mm to 200mm where it was previously 75 mm. In addition various areas across the city are now cut at 50mm to 100mm where previously they were cut at 25mm to 50mm. This not only reduces an operational carbon footprint but allows for colonisation of wildflowers.
- 7.2 The cutting regime for shrubs has been altered to flail works from the traditional cutter bar which results in a quicker operation for carbon diminution as well as a reduction in collection requirement followed by transportation to tip. In addition the tops of shrubs/hedges are not cut back between 1st March and 31st August due to the active/nesting birds policy. A site-line cut only, on a health and safety basis, is carried out which totals 10% of the 750,000m2 and the same amount for 58,000lm of hedges.
- 7.3 Operational works within the shelterbelts has been followed by chipping the cut back into the belt and the stacking of the logs for their gradual decay and production of invertebrate habitat. In addition chippings from shrubs and hedges are cut back into the beds where possible and into shelterbelts if the beds are not possible.
- 7.4 An agreement has been made between Betterland and City Services through which garden waste collected from the brown bins is taken and composted, the latter being used to grow plants purchased by the Authority for amenity landscaping. Recently we delivered approximately 300 tonnes of leafs, grass cuttings, bedding plants for composting.
- 7.5 The composting facilities at Bretton Park have been expanded and the resultant material reintroduced over the shrub and annual beds. Estimated tonnage amounts to that within the region of 300 tonnes during 10/11.
- 7.6 The Crematorium has retained the Green Flag award within the time period with support for associated issues of sustainability. We have also retained a Green Flag award for Central and Itter Parks.
- 7.7 As a component of the In Bloom campaign a move has been made towards recycling of the dead heads cut from bedding. Historically the outcome was to transport material to tip.
- 7.8 The Boardwalks at Thorpe Meadows continue to be opened up by thinning the canopies of the Willow trees overhanging the numerous ponds. This action has been taken to promote amphibian habitat creation.
- 7.9 Debdale Pond in Orton Warterville has received attention from the local open space friends group in an attempt to clear the banks and allow sunlight to gain entry. In addition there has been a local schools bird box campaign utilising the mature trees on site.
- 7.10 An area of land adjacent to Potter's Way has been allowed to develop naturally during the last 4 years through deliberate non-intervention.
- 7.11 A review of the management techniques deployed within the shelter belts continues along

- with an assessment of their potential to accommodate multiple habitats at levels ranging from the forest floor to the top. This on-going process will feed into the Trees & Woodland Strategy which is currently being finalised.
- 7.12 At Central Park some areas, the sunken garden for example, offer the potential for different planting schemes rather than the summer bedding planted at the moment. Different planting schemes designed to attract bees, etc. need to be explored. The use of perennials is another option, as are using native species. Also, we could stack logs after trees are removed and leave a section of the trunk standing, rather than clearing and grinding.
- 7.13 Planning applications detailing the implementation of SUDS are forecast to become far more frequent in the future. Management will have an element relating to bio-diversity and maintenance teams will require very specific training to manage SUDS systems in a professional manner.
- 7.14 Julia Chatterton has been leading on PCC SUDS work and has also, as part of the flood risk management programme, looked at watercourses. There is currently nothing in the Enterprise Peterborough specification about managing watercourses although there is the PCC requirement in the method statements. Julia is going to prepare a specification during the autumn and there will be some funding for Enterprise Peterborough to manage the City's watercourses according to the specification, next year. The Wildlife Officer is likely to be contributing to the specification.

ALLOTMENTS:

7.11 An on-going review of allotments is seeking to address rubbish dumping issues and investigating opportunities for composting. In addition the Allotments Officer has contributed towards a workshop organised by the Environment Network at the Green Backyard.

PLAY PROVISION:

- 7.12 The Big Lottery Wildplay project has now been completed and the successes include an increase in the number of children and young families using their local greenspace or nature reserve; new audiences to wildlife activities and sites from different ability, socio economic and BME groups; a fresh approach to encouraging people into the natural environment using play and adventure; an increase in children and young people joining local wildlife groups and an increase in the number of children and young people enjoying their local greenspace in a positive way.
- 7.13 An unexpected outcome from the Wildplay project was the demand from young people for adventure and from families for guided outdoor events. There is scope to build on this work and do much more of it. Funding needs to be directed at facilitation of play rather than capital items such as structures. The Wildlife Trust built Watch Groups in for sustainability but these groups can only accept a certain number of children and families. We developed materials for children and adults with children / group leaders to facilitate and encourage further development self-interest, but we have evidence of demand from more people in Peterborough for a facilitated service of this nature; nothing else exists here.

ENVIRONMENT CAPITAL PERFORMANCE UPDATE

1. PURPOSE

1.1 This report updates the Committee on performance against the Council's Environment Capital ambition as measured by Forum for the Future through its Sustainable Cities Index 2010.

2. RECOMMENDATIONS

2.1 The Committee is asked to note the city's performance as measured by the Sustainable Cities Index and identify issues it may wish to consider in more depth at future meetings.

3. LINKS TO THE SUSTAINABLE COMMUNITY STRATEGY

3.1 Adopting this approach will ensure that subsequent Scrutiny meetings will directly contribute to the objectives and outcomes contained in the Sustainable Community Strategy.

This committee in particular most directly contributes to the 'Creating the UK's Environment Capital' priority in the Sustainable Community Strategy.

4. BACKGROUND

4.1 Peterborough's Sustainable Community Strategy contains four priorities: Creating Strong and Supportive Communities; Creating the UK's Environment Capital; Creating Opportunities, Tackling Inequalities; Substantial and Truly Sustainable Growth. Each of these priorities has four specific outcomes, beneath which sit a diverse range of actions and interventions to deliver lasting positive change for Peterborough.

By adopting the Sustainable Community Strategy, the council has committed itself to becoming the UK's Environment Capital, building on the longstanding experience as one of four Environment Cities in the UK. The "journey" from Environment City to Environment Capital is considered appropriate given the shift towards global environmental challenges such as climate change as well as the city's ambition to grow substantially and sustainably.

Environment Capital now has widespread support as a key focus and unique selling point for Peterborough which has been achieved through clear political direction and the efforts of a committed, cross-sector partnership working.

4.2 At its meeting in July, the Committee resolved that before the City Council launched its Environment Capital approach, agreed criteria should be met and an independent assessment should be undertaken. The most cost effective basis for this comparative work is the Forum for the Future Sustainable Cities Index. The organization assessed Peterborough as part of the Jonathan Porritt Master Class in Nov 2009. Forum for the Future has recently assessed the city against 2010 Index. It should be noted that the Index compares Peterborough with a number of much larger UK cities but it is one of only a few, reliable local authority comparators. Peterborough is the only city which voluntarily submits itself to this additional scrutiny with regard to its sustainability

performance.

In order that progress and trends can be tracked and, in the absence of a defined set of comparative indicators, it was agreed that the city would again use the Index as its preferred measurement methodology. Earlier this year, Forum for the Future was commissioned to compare the city against the 2010 Index and Britain's' twenty largest cities.

The results (including comparative 2009 performance) are as follows:-

(N.B. Scores for each basket are out of a maximum of 21. The overall score is the sum of the three baskets and is, therefore, out of a total of 63. Rank position is from 1 to 21.)

Overall, the city has retained its position. Whilst slipping back slightly under the "future- proofing" basket of measures it has improved its score and position against environmental and quality of life measures. The following sections look briefly at each of the baskets in a little more detail.

4.3 Environmental performance

This basket focuses on environmental performance using data on air quality, waste, resource use and ecological footprint.

As can be seen from the above table, the City performs well in this area compared with the 20 largest UK cities. It has substantially improved on its 2009 rank position. Peterborough leads the way on air quality and biodiversity although the waste per head of population remains a concern alongside the ecological footprint. The latter measures the amount of global land needed to sustain each resident of the local authority. Amongst other things, the calculation takes into consideration domestic fuel use, car fuel use, meat, fish and vegetable consumption.

Turning specifically to the waste produced per head of population, the figures for 2009/10 and the estimates for 2010/11 have reduced for the amount of household waste collected per person (BVPI 84a) to 493.06 kg in 09/10 and 486.27kg in 10/11, a significant decrease from the 2008/09 figure of 558 kg. This still makes us high compared to the other 20 cities, which appear to be reducing the figure at a faster rate. It is worth recognizing that the nature of the large cities in this comparison needs to take into account the different nature of the waste generated. Peterborough is likely to produce more household waste as it collects garden waste at the kerbside which is not common practice in big cities.

4.4 Quality of Life

This basket attempts to measure what the city is like to live in and how it is performing on social sustainability. Whilst not normally topics within the scope of this Committee, it is included here for completeness.

The quality of life score and rank have reduced slightly since the 2009 assessment although the overall basket has seen improvements in relation to the percentage of individuals claiming job seekers allowance, life expectancy and the number of green spaces per 100,000 inhabitants.

The Transport indicator measures the number of minutes per month per household spent walking and/or taking public transport or cycling to four key services: food, GP, further education and secondary school. The research necessary to calculate this indicator was not commissioned as part of the brief but the work has since been undertaken though the results were not available for the report deadline. The figure used in the table above is an all city average. The actual figure may alter the relative rank position and, therefore, Peterborough's overall rank (see 4.2 above). Members will be provided with a verbal update at the Committee.

4.5 Future Proofing

The future proofing indicators seek to capture how cities are addressing some of the strategic issues that require local, civic leadership including preparations for climate change, resilience to changes in the food supply chain, re-use of resources and dynamism and innovation in the local economy.

The city has slipped back slightly on this basket though continues to perform well against the other

cities, however, it ranks first in relation to its recycling rate and on allotment availability.

Whilst the performance on the climate change indicator is disappointing, it must be noted that this is assessed on 2010 performance. A significant amount of positive work has been undertaken since the adoption of the Carbon Management Action Plan which is likely to substantially improve performance against the 2011 Index. An update on the Carbon Management Action Plan is due to be published in November 2011. In addition, as it is no longer a statutory requirement, Peterborough has not progressed the climate change adaptation work as far as some other authorities. However, the partnership with Rutland County Council offers the opportunity to progress this work and this is currently being explored.

5. KEY ISSUES

- 5.1 Within the scope of this Committee's responsibilities, Members are asked to focus on a number of areas for improvement within the document, namely, but not exclusively: -
 - Kg of waste produced per head of population.
 - Ecological footprint and
 - Climate Change
- 5.2 Members may also wish to identify issues for closer scrutiny by including these in the Committee's future work programme.

6. IMPLICATIONS

6.1 For the city to achieve its ambition of becoming the UK's Environment Capital, it must show a strong and evidenced track record of environmental achievement backed by a focus on addressing areas for improvement. The Sustainable Cities Index is one mechanism through which the city's response to key challenges can be monitored and areas for improvement identified.

7. CONSULTATION

7.1 The Environment Capital initiatives and projects outlined in this report are subject to individual and specific consultation as part of their development and implementation.

8. NEXT STEPS

8.1 The outcomes of the latest Sustainable Cities Index will be used to focus on key areas of improvement where these are within the sphere of influence of the local authority.

It is intended to commission Forum for the Future later in 2011 to benchmark Peterborough against the 2011 Sustainable Cities Index.

FORWARD PLAN OF KEY DECISIONS

1. PURPOSE

1.1 This is a regular report to the Environment Capital Scrutiny Committee outlining the content of the Council's Forward Plan.

2. RECOMMENDATIONS

3. BACKGROUND

- 3.1 The latest version of the Forward Plan is attached at Appendix 1. The Plan contains those key decisions, which the Leader of the Council believes that the Cabinet or individual Cabinet Member(s) will be making over the next four months.
- 3.2 The information in the Forward Plan provides the Committee with the opportunity of considering whether it wishes to seek to influence any of these key decisions, or to request further information.
