1. PURPOSE OF REPORT

- 1.1 To consider and determine an application for a review of a Premises Licence under Section 51 of the Licensing Act 2003 for the above premises, taking into account the representation made by Pollution Control and a letter of support from Cambridgeshire Constabulary in their capacities as a Responsible Authorities. A further representation was also made by a local resident. The review was bought by the South Central East Residents Association in their role as a group representing local residents. The review was bought under the prevention of crime and disorder and the prevention of public nuisance objectives. A copy of the review application is attached at **Appendix B – Page 9**

2. BACKGROUND INFORMATION

- 2.1 On the 25th July 2005 a conversion application was submitted by Mr Giovanni Tomeo to convert a Justices restaurant licence to a premises licence. At that time of conversion the premises was called Marisqueira. As there were no objections from the police, the licence was granted on 22nd August 2005. Mr Tomeo was named on the licence as the Designated Premises Supervisor. A copy of this original premises licence is attached at **Appendix C – Page 19**
- 2.2 On the 18th December 2007 an application to change the name of the premises to 'Sopranos' was received and subsequently was granted.
- 2.3 On the 3rd March 2008 an application to vary the premises licence was received. This application was to remove the majority of the embedded restrictions, add dancing to the licence and to increase the hours for live music and the sale of alcohol until 3am. A representation from the Noise Pollution team was successfully mediated out. As there were no other representations received the application was granted on the 1st April 2008. This premises licence is attached at **Appendix D – Page 29** with all of the changes to the licence highlighted for easy reference.

- 2.4 On the 24th February 2009 an application to vary the Designated Premises Supervisor on the premises licence was received. The application was to place Mrs N Cascalheira on the licence and remove Mr Tomeo with immediate effect. As no representations were received, the application was granted.
- 2.5 On the 24th June 2009 an application to vary the Designated Premises Supervisor back to Mr Tomeo with immediate effect was received. As no representations were received the application was granted.
- 2.6 On the 25th August 2009 a minor variation to the premises licence was applied for by Mr Tomeo. This application was to change the layout plan of the premises and to increase the conditions on the licence. As no representations were received, the application was granted. A copy of this licence is attached at **Appendix E – Page 41** with all of the changes to the licence highlighted for easy reference.
- 2.7 On the 10th December 2009 an application to transfer the premises licence to Mr Joaquim Mendes was applied further. An additional application was also received to place Mr Mendes on the licence as the Designated Premises Supervisor. As no representations were received both applications were granted. A copy of this current premises licence is attached at **Appendix F – Page 53**

- 3.1 In accordance with section 51 of the Licensing Act 2003 following the submission of an application to review the premises licence from the South Central East Residents Association, a body representing local residents, the licensing authority must hold a hearing.

- 3.3 A copy of the 'Notice' that was displayed on the premises in accordance with Part 5 no. 38 of Statutory Instruments 2005 No. 42 – The Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005 is attached at **Appendix G – Page 65**
- 3.4 A representation was received from the Pollution Control team as a Responsible Authority, a copy of this representation is attached at **Appendix H – Page 67**. This representation includes noise logs that were completed by a local resident. A letter supporting the applicant's recommendation to curtail licensable activities at the premises to 11pm was received from Cambridgeshire Constabulary and is attached at **Appendix I – Page 71**

8. LEGAL OFFICER'S COMMENTS

- 8.1 The Licensing Authority (hereafter referred to as "the Council) is charged with implementing the provisions of the Licensing Act 2003. This is an application for a review of a premises licence following the application by Pollution Control (Responsible Authority) to review the premises licence made under section 51 of the Licensing Act 2003.

- 8.2 In this case, the application was received at these offices on 5th July 2011.

- 8.3 The application before this committee will consider –

- (i) The application to review the licence,
- (ii) Any relevant representations

- 8.4 The committee will take such of the steps as it considers that action is necessary for the promotion of the licensing objectives. The steps are –

- (a) to modify the conditions of the premises licence
- (b) to exclude a licensable activity from the scope of the licence
- (c) to remove the designated premises supervisor from the licence
- (d) to suspend the licence for a period not exceeding three months, or
- (e) to revoke the licence

and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added

- 8.5 In addition the guidance issued under section 182 of the Licensing Act 2003 states:

'The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular time. It is expected

that licensing authorities will regard such warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be issued in writing to the holder of the licence. But, where responsible authorities like the police or environmental health officers have already issued warnings requiring improvements – either orally or in writing – that have failed as part of their own stepped approach to concerns, licensing authorities should not merely repeat that approach.

Note: In this document, the following definitions are included to provide an explanation of certain terms included in the Act. In some cases they are an abbreviation of what is stated in the Licensing Act 2003 or an interpretation of those terms. For a full definition of the terms used, the reader must refer to the Licensing Act 2003.

‘Child’

(a) means an individual aged under 16

(b) a child is unaccompanied if he is not in the company of an individual aged 18 years or over

DCMS: Department for Culture Media and Sport

‘Designated Premises Supervisor’ means the person (who must be a Personal Licence Holder), in the case of premises selling alcohol, who will normally have been given the day to day responsibility for running the premises by the holder of the Premises Licence or will be the Premises Licence holder.

‘Interested parties’:

- a person living in the vicinity of the premises in question;
- a body representing persons living in that vicinity, e.g. a residents association;
- a person involved in a business in the vicinity of the premises in question;
- a body representing persons involved in such a business e.g. a trade association
- a member of the relevant licensing authority.

‘Late Night Refreshment’ means the supply of hot food or hot drink to members of the public (whether for consumption on or off the premises) between the hours of 11.00 pm and 5.00 am.

‘Licensable Activities’ means: -

- The sale by retail of alcohol
- The supply of alcohol by or on behalf of a club to, or to the order of, a member of the club
- The provision of Regulated Entertainment
- The provision of Late Night Refreshment

‘Licensing Authority’: - is the licensing function of Peterborough City Council

‘Licensed Premises’ includes club premises and events unless the context otherwise requires.

‘Licensing Objectives’

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

‘Operating Schedule’ means a document containing a statement of the following matters (and any others that may be prescribed): -

- The relevant Licensable Activities
- The times at which the Licensable Activities are to take place and any other times when premises are open to the public
- Information regarding the person who will be specified in the Premises Licence as the Premises Supervisor
- Where the Licensable Activities involve the supply of alcohol, whether it is for the supply on and/or off the premises

- The steps being taken to promote the Licensing Objectives

‘Rateable Value’: as regards a premises, is the value for the time being in force for the premises entered in the local non-domestic rating list for the purposes of Part III of the Local Government Finance Act 1988(b).

‘Regulated Entertainment’ (Schedule 1 of the Act) means: -

- A performance of a play
- An exhibition of a film
- An indoor sporting event
- A boxing or wrestling entertainment
- A performance of live music
- Any playing of recorded music
- A performance of dance

Or entertainment of a similar description falling within the last three of the categories listed above, where the entertainment takes place in the presence of and for the purposes of entertaining that audience or spectators.

Or the provision of entertainment facilities:

Facilities for enabling persons to take part in entertainment of the following description for the purpose or purposes, which include the purpose of being entertained:

- making music
- dancing
- entertainment of a similar description

‘Relevant Licensing Authority’: is the Authority in the area the premises are situated.

‘Responsible Authority’ means any of the following: -

- Cambridgeshire Constabulary (The Chief Officer of Police)
- Cambridgeshire Fire and Rescue (The Fire Authority)
- Health and Safety Team, Peterborough City Council
- Planning authority, Peterborough City Council
- Trading Standards, Peterborough City Council
- Environmental Health – Pollution, Peterborough City Council
- Children’s Services – Child Protection & Review Manager
- Maritime & Coastguard Agency, Walton on Naze. (For vessels carrying more than 12 passengers.)
- Environment Agency, Peterborough (For vessels carrying 12 or less passengers).

‘Supply of alcohol’:

- the sale by retail of alcohol, or
- the supply of alcohol by or on behalf of a club to, or to the order of, a member of the club.

‘Temporary Event Notice’ means a Permitted Temporary Activity involving one or more Licensable Activities subject to the following various conditions and limitations: -

- Duration – they are limited to events lasting for up to 96 hours;
- Scale – they cannot involve the presence of more than 499 people at any one time;
- Use of the same premises – the same premises cannot be used on more than 12 occasions in a calendar year, but are subject to the overall aggregate of 15 days irrespective of the number of occasions on which they have been used; and

- The number of notices given by an individual within a given period of time – a Personal Licence Holder is limited to 50 notices in one year, and another person to 5 notices in a similar period.

(In any other circumstances, a full Premises Licence or Club Premises Certificate will be required for the period of the event).

‘the Act’: means the Licensing Act 2003

‘Vicinity’: Given the normal everyday meaning of being ‘near to’ when considering the relevance of representations received from individual’s residence or business.

There are a whole host of issues that impact on the quality of life of local residents that clearly emanate from the said premises. Below is a list of the problems/ issues that are being caused by the customers using the premises.

These and other similar incidents of antisocial and violent behaviour occur regularly and particularly on Friday and Saturday nights, between the times of 12.00 midday to 5am. We also believe there are other licencing conditions that are not being adhered to (i.e closing at 3am, doors and windows are kept open while loud music is being played).

1. Noise which includes loud music, screaming and shouting, abusive language and fighting. The premises are advertised as a Café/Restaurant but actually it runs more on a bar/night club model.

2. Loud music is being played in the premises resulting in local residents including school children and the elderly being woken or kept up till beyond 02.00 am and being deprived of a proper nights sleep. This is made worse by the fact the premises keeps all its windows and doors open during business hours, which is in clear contravention of the existing conditions of licence.

3. Screaming & shouting not just outside the premises when the customers leave but continuing along the streets as they leave the area in the early hours of the morning.

4. Anti social behaviour, when leaving the premises such as urinating in local gardens and streets and being abusive and threatening residents when asked to stop.

5. Violence with regular fights starting inside the premises and continuing onto the street outside

6. Criminal damage to local property and vehicles.

7. Foul and abusive language amongst the users of the premises and at times this is also targetted at passers by and local residents including women and children.

8. Blocking off the pavement and drinking outside the premises at various times by customers.

RECOMMENDATIONS:

We the local residents appreciate that this is a business and we have nothing against it in principal therefore, we are not asking for the licence to be revoked. We respectfully request the panel to impose the following conditions which we hope will allow the business to continue and more importantly alleviate the problems/issues that are being caused by the business at the present time.

A) The opening hours be reduced to 11pm every evening of the week. - This will help to reduce the antisocial behaviour, the violence (fighting), urianting in public, breaking bottles etc.

B) We ask that the premises only be allowed to play incidental music. - This will alleviate the problems of noise pollution being suffered by local residents. We feel this should not be an issue as the premises is a Cafe/Restaurant and therefore only minimal background music is required.

After parking my car outside outside 25 Russell Street, I had to walk past the Marisqueira Restaurant on 62 Cromwell Road, Peterborough to get to my house. As I got closer to the junction of Cromwell Road & Russell Street I could see a brawl was taking place between 30-40 people outside the Marisqueira Restaurant. People were running in and out of the premises some trying to stop the fighting while others were getting involved. I placed a call to the emergency services to request the Police to attend 62 Cromwell Road as a fight was in progress. People fighting had flowed out onto the road and pavement on both sides of Russell street therefore blocking the road for oncoming traffic. There was lots of shouting and swearing in addition to the fight that was happening. I could see that there were quite a few local residents including children who had come out to see what was happening and they were clearly very frightened at seeing the violence. I know this incident was directly associated with the Marisqueira Restaurant as I clearly saw people coming out and getting involved in the violence and others who were trying to break up the fight taking people back inside the premises.

From 10.00pm on Saturday 14th May 2011 until around 4am on Sunday 15th May 2011, there was constant disruption for us due to the very loud music being played in the Marisqueira Restaurant, 62 Cromwell Rd, Peterborough. I have a child who suffers from a rare medical condition which requires constant 24 hour supervision. During the night she has a nurse stay with her to change her medication whilst she sleeps and although we regularly have to put up with loud music until the early hours of the morning both me and the nurse particularly remember this occasion as on the night concerned we felt very scared due to the high level of anti social behaviour that accompanied the very loud music. From past experience of suffering verbal abuse and threats of violence from Marisqueira's customers when I had asked them to keep the noise down, this time I was too scared to open the front door to have a look. Instead I and the nurse looked out of my bedroom window, and saw the doors and windows of the Marisqueira Restaurant fully open and could clearly hear the music bellowing from the premises along with a group of rowdy people standing outside smoking, drinking and shouting at each other and passers by. As I watched I saw two of them throw bottles onto the road and one of them hit a car parked opposite my house. The noise and antisocial behaviour has been steadily getting worse with every weekend this year.

Me and my wife found it hard to sleep on the night of Friday 3rd June 2011 due to the loud dance music emanating from the Marisqueira Restaurant, 62 Cromwell Rd, Peterborough. At around 3am the intensity of the noise increased due to the amount of people congregating outside the premises, I looked out of my bedroom window I could see people fighting, screaming and shouting, and also blue lights flashing. It was only the next day that I discovered that a brutal attack had occurred on an innocent taxi driver.

I have been disturbed by the goings on at the Marisqueria Restaurant for many months now. My daughter has lodged a complaint with the City Council for some time now with regards to the level of noise and nuisance coming directly from the Marisqueira Restaurant, 62 Cromwell Road, Peterborough and its patrons.

I live a few houses away from the Marisqueira Restaurant on Cromwell Road Peterborough. On the above night loud music was being played at the Marisqueira Restaurant, from 6pm until 3.30am. I am a cancer sufferer and found it very difficult to sleep on the above night, along with the loud music there was a constant gathering of people outside the Marisqueira Restaurant, talking loudly, smoking, drinking and shouting. I felt scared to step outside my house and could not approach anybody for help. I called the police who advised me that it was a council issue and they could not help. I then out of frustration at 1am made my way outside into my front garden where upon I found three men sitting on my garden wall drinking. I approached the men and asked them if they could kindly keep the noise down as we were trying to sleep and for them to stop sitting on my wall. The three of them laughed at me and said something in a foreign language and one of them smashed his bottle against the front wall of my house and walked towards the Marisqueira Restaurant. I then stepped out on to the footpath and could see up to 10 people standing outside the Marisqueira Restaurant and being very noisy. I witnessed the three gentlemen who I asked to move off my wall enter the Marisqueira Restaurant. In the morning I discovered empty beer bottles in my front garden.

The noise and antisocial behaviour has been steadily getting worse over the past few months.

I can confirm that on these nights: Friday 6th May, Saturday 7th May, Friday 13th May, Saturday 14th May, Friday 20th May, Saturday 21st May, Friday 27th May, Saturday 28th May, Friday 3rd June, Saturday 4th June 2011, loud music was being played from the Marisqueira Restaurant with people congregating outside the premises smoking, shouting, and talking loudly and on occasions violence has flared. I arrive home between the hours of 1-2am on the weekends due to my work commitments. The noise is also troubling to my family and neighbours who find it hard to sleep at the weekends.

14. Log Book – any and all incidents in or in the surrounding vicinity of the club to be recorded in this book and the proprietor or nominated person to take appropriate action and record any actions taken.

16. Log Book – walk around the perimeter of the premises at regular intervals to check for any thing that may cause a nuisance to neighbours in the area. Walk around to be recorded in the log book.
17. Customers smoking area to be monitored and the number of smokers to be restricted should any undue noise or other problems arise from customers using this area.
18. Drinking out side to be prohibited at all times.
19. A contact telephone number for the proprietor or a nominated person to be given to residents wishing to advise of disturbances from the premises and a positive response to any calls to be given. These calls and responses with any action taken to be recorded in the log book.
20. **Odour**

All ventilation of steam and cooking fumes to the atmosphere shall be suitably filtered to avoid nuisance from smell, grease or smoke to persons in neighbouring or nearby properties.
21. **Odour**

Details of the nature and location of such filtration equipment should be submitted to and agreed in writing by the Local Planning Authority before installation and should be installed before the use of the premises commences.

Pollution Control Team Representation

The Pollution Control Team are submitting a representation for a premises licence review on the grounds for preventing a public nuisance.

Pollution Control received a complaint made by a resident of Russell Street on 4th May 2011. A letter addressed to the restaurant has been sent to inform the premises that complaint had been made.

The complainant returned a completed log sheet on 17/06/2011. A review of the log sheet showed that loud music and noisy customers can be heard in the complainant's house on two consecutive weekends when the noise has been monitored. The noise was ongoing until 02:00hrs 03:00hrs and beyond up to 03:45hrs.

A further letter was sent to the premise licence holder Mr Joaquim Mendes on 03/06/2011 to the address given on the licence. Following the letter I have received a phone call from Mr Mendes on 08/06/2011.

I discussed with him the content of the log sheets and informed him that statutory noise nuisance can be caused at any time of a day. I was assured that staff would be briefed and steps would be taken to prevent customers outside the premises from causing the nuisance.

On 16/06/2011 I have received further completed log sheets from the complainant indicating that the noise was ongoing for last three weekends including the weekend 10-12/06/2011 which was the weekend after I had the conversation with Mr Mendes.

Copies of the completed log sheets are attached to this application as Appendix 1.

I therefore suggest that due to the continuing complaints and monitoring evidence undertaken, that Marisque Restaurant at 62 Cromwell Road, Peterborough is in breach of condition 11 of the current licence as well as operating outside the authorisation.

Condition 11. The Prevention of Public Nuisance

All music noise and amplified music or speech emitted from the premises shall not be audible inside noise sensitive premises between 23:00 hrs and 07:00hrs.

Recommendations

Condition 11 to be replaced with the following

The holder of the premises licence or a nominated representative shall take all necessary steps to ensure that noise is not noticeable at the façade of any noise sensitive premises.

Additionally the following conditions should be added to the licence.

1. The holder of the premises licence or a nominated representative shall take reasonable steps to prevent and control noise nuisance caused by persons using the Licensed Premises and also ensure patrons and visitors arrive and depart from the premises in a manner which will not cause annoyance to nearby residents.
2. Any request by an Officer of the Council, Police Officer or PCSO in relation to reducing noise levels shall be complied with immediately.



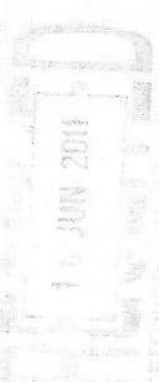

I am writing to complain about the disturbance of peace caused by the "Marisqueira" institute on 62 Cromwell Road within the central ward of Peterborough. As a resident of Russell Street, I live within the immediate vicinity of this pub/club/restaurant and am hugely angered by the actions of this place. This often happens to such an extent that the sleeping patterns of both myself and my grandparents are often significantly affected; this, as you should know, has a direct bearing upon not only my educational performance but the day-to-day actions of two OAPs. The following are plagues that we must contend with; loud music late into the night (often up till 3am on Fridays and Saturdays), people (often drunk) entering our premises and violating our property through urinating/excreting on it, drug use in the immediate locality and large, imposing rowdy groups who tend to garner around the Cromwell Road and Russell Street corners from around 7pm onwards. As someone who has been temporarily residing with my grandparents (for around a month), I am already sickened and directly affected by this appalling enforcement of standards within an area clearly categorised as being "residential". However, my grandparents have had to put up with this for the last year. Please take immediate action or legal will be considered.
