### 1. PURPOSE OF REPORT

1.1 To consider and determine an application for a review of a Premises Licence under Section 51 of the Licensing Act 2003 for the above premises, taking into account the representation made by Trading Standards in their capacity as a Responsible Authority, and letter of support of the review and recommendations from Cambridgeshire Constabulary also a Responsible Authority. The review was bought under the Prevention of Crime and Disorder objective.

## 2. BACKGROUND INFORMATION

- 2.1 On the 31<sup>st</sup> May 2005 an application to convert an existing justices off licence was submitted by Mr Shaid Majid. As no representations were received from the police the premises licence was granted on 29<sup>th</sup> June 2005. This licence was issued with the name of the premises being 'News N Booze'.
- 2.2 On 23<sup>rd</sup> March 2006 an application to transfer the premises licence to Ms Samira Majid was submitted and, as there were no Police objection the transfer was granted on 7<sup>th</sup> April 2006.
- 2.3 On 29<sup>th</sup> March 2006 an application to transfer the Designated Premises Supervisor of the premises to Ms Samira Majid was submitted. As there was no Police objection the transfer was granted on 13<sup>th</sup> April 2006.
- 2.4 On 23<sup>rd</sup> May 2006 an application was submitted to extend the hours for the sale of alcohol. After a Police objection to this extension mediation was undertaken resulting in additional conditions being placed upon the licence. The variation was then granted on 29<sup>th</sup> June 2006. <u>However</u> the premises licence holder was unable to meet the requirements of these new conditions until 7<sup>th</sup> December 2006 so the premises continued to sale alcohol as per it's original authorisations. On 7<sup>th</sup> December 2006 the Licensing Authority were satisfied that the new conditions were being complied and the extended hours were authorised.

- 2.5 On 30<sup>th</sup> March 2007 the premises licence holder changed the name of the premises to 'The B Stop'. A copy of this licence is attached at **Appendix B Page 9.**
- 2.6 On 18<sup>th</sup> April 2007 an application to review the premises licence was made by Cambridgeshire Constabulary. This review was sought after staff at the premises sold alcohol on two occasions to underage persons. These offences took place on 6<sup>th</sup> April and 17<sup>th</sup> February 2007. As a result of this review further conditions were imposed on the premises licence by the Licensing Act 2003 Sub-Committee. A copy of the current premises licence is attached at **Appendix C Page 19**.

### 3. APPLICATION

- 3.1 In accordance with section 51 of the Licensing Act 2003 following the submission of an application to review the premises licence from Trading Standards, a Responsible Authority, the licensing authority must hold a hearing.
- 3.2 A copy of the application to review was received 4<sup>th</sup> August 2011 and a copy of which is attached at **Appendix D Page 29.**
- 3.3 A copy of the 'Notice' that was displayed on the premises in accordance with Part 5 no. 38 of Statutory Instruments 2005 No. 42 The Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005 is attached at **Appendix E Page 35.**
- 3.4 A representation in support of the review and recommendations was received from Cambridgeshire Constabulary as a Responsible Authority, a copy of this representation is attached at **Appendix F Page 37.**
- 3.5 No other representations have been received from any of the remaining Responsible Authorities or any interested parties.

### 4. **RESPONSIBLE AUTHORITY**

### 4.1 Summary of issues raised by Responsible Authorities

- i. Her Majesty's Revenue and Customs (HMRC) have seized alleged non UK duty paid alcohol from the premises on 24<sup>th</sup> November 2010 and also on 20<sup>th</sup> April 2011
- ii. The premises have failed to provide documentation for the seized alcohol on both occasions to prove that UK duty had been paid.
- iii. The UK Duty evaded was £59.98 on 24<sup>th</sup> November 2010 and £88.20 on 20<sup>th</sup> April 2011. This is a total of £148.18 duty evaded.
- iv. Guidance issued under section 182 of the Licensing Act 2003 recommends revocation, even in the first instance.

### 5. LICENSING OFFICERS COMMENTS

5.1 Section 11.23 of Guidance (issued under section 182) states, 'A number of reviews may arise in connection with crime that is not directly connected with licensable activities. For example, reviews may arise because of drugs problems at the premises or money laundering by criminal gangs or the sale of contraband or stolen goods there or the sale of firearms. Licensing authorities do not have the power to judge the criminality or otherwise of any issues. This is a matter for the courts of law. The role of the licensing authority when determining such a review is not therefore to establish the guilt or innocence of any individual, but to ensure that the crime prevention objective is promoted.

### 7. LEGAL OFFICER'S COMMENTS

- 7.1 The Licensing Authority (hereafter referred to as "the Council) is charged with implementing the provisions of the Licensing Act 2003. This is an application for a review of a premises licence following the application by Trading Standards (Responsible Authority) to review the premises licence made under section 51 of the Licensing Act 2003.
- 7.2 In this case, the application was received at these offices on 4<sup>th</sup> August 2011.
- 7.3 The application before this committee will consider
  - (i) The application to review the licence,
  - (ii) Any relevant representations
- 7.4 The committee will take such of the steps as it considers that action is necessary for the promotion of the licensing objectives. The steps are
  - (a) to modify the conditions of the premises licence
  - (b) to exclude a licensable activity from the scope of the licence
  - (c) to remove the designated premises supervisor from the licence
  - (d) to suspend the licence for a period not exceeding three months, or
  - (e) to revoke the licence

and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added

7.5 In addition the guidance issued under section 182 of the Licensing Act 2003 states:

'The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular time. It is expected that licensing authorities will regard such warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be in issued in writing to the holder of the licence. But, where responsible authorities like the police or

environmental health officers have already issued warnings requiring improvements – either orally or in writing – that have failed as part of their own stepped approach to concerns, licensing authorities should not merely repeat that approach.

Note: In this document, the following definitions are included to provide an explanation of certain terms included in the Act. In some cases they are an abbreviation of what is stated in the Licensing Act 2003 or an interpretation of those terms. For a full definition of the terms used, the reader must refer to the Licensing Act 2003.

### 'Child'

(a) means an individual aged under 16

(b) a child is unaccompanied if he is not in the company of an individual aged 18 years or over

**DCMS**: Department for Culture Media and Sport

**'Designated Premises Supervisor'** means the person (who must be a Personal Licence Holder), in the case of premises selling alcohol, who will normally have been given the day to day responsibility for running the premises by the holder of the Premises Licence or will be the Premises Licence holder.

### 'Interested parties':

- a person living in the vicinity of the premises in question;
- a body representing persons living in that vicinity, e.g. a residents association;
- a person involved in a business in the vicinity of the premises in question;
- a body representing persons involved in such a business e.g. a trade association
- a member of the relevant licensing authority.

**'Late Night Refreshment'** means the supply of hot food or hot drink to members of the public (whether for consumption on or off the premises) between the hours of 11.00 pm and 5.00 am.

### 'Licensable Activities' means: -

- The sale by retail of alcohol
- The supply of alcohol by or on behalf of a club to, or to the order of, a member of the club
- The provision of Regulated Entertainment
- The provision of Late Night Refreshment

'Licensing Authority': - is the licensing function of Peterborough City Council

'Licensed Premises' includes club premises and events unless the context otherwise requires.

### 'Licensing Objectives'

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

**'Operating Schedule'** means a document containing a statement of the following matters (and any others that may be prescribed): -

- The relevant Licensable Activities
- The times at which the Licensable Activities are to take place and any other times when premises are open to the public
- Information regarding the person who will be specified in the Premises Licence as the Premises Supervisor
- Where the Licensable Activities involve the supply of alcohol, whether it is for the supply on and/or off the premises

• The steps being taken to promote the Licensing Objectives

**'Rateable Value'**: as regards a premises, is the value for the time being in force for the premises entered in the local non-domestic rating list for the purposes of Part III of the Local Government Finance Act 1988(b).

'Regulated Entertainment' (Schedule 1 of the Act) means: -

- A performance of a play
- An exhibition of a film
- An indoor sporting event
- A boxing or wrestling entertainment
- A performance of live music
- Any playing of recorded music
- A performance of dance

Or entertainment of a similar description falling within the last three of the categories listed above, where the entertainment takes place in the presence of and for the purposes of entertaining that audience or spectators.

Or the provision of entertainment facilities:

Facilities for enabling persons to take part in entertainment of the following description for the purpose or purposes, which include the purpose of being entertained:

- making music
- dancing
- entertainment of a similar description

'Relevant Licensing Authority': is the Authority in the area the premises are situated.

### 'Responsible Authority' means any of the following: -

- Cambridgeshire Constabulary (The Chief Officer of Police)
- Cambridgeshire Fire and Rescue (The Fire Authority)
- Health and Safety Team, Peterborough City Council
- Planning authority, Peterborough City Council
- Trading Standards, Peterborough City Council
- Environmental Health Pollution, Peterborough City Council
- Children's' Services Child Protection & Review Manager
- Maritime & Coastguard Agency, Walton on Naze. (For vessels carrying more than 12 passengers.)
- Environment Agency, Peterborough (For vessels carrying 12 or less passengers).

### 'Supply of alcohol':

- the sale by retail of alcohol, or
- the supply of alcohol by or on behalf of a club to, or to the order of, a member of the club.

**'Temporary Event Notice'** means a Permitted Temporary Activity involving one or more Licensable Activities subject to the following various conditions and limitations: -

- Duration they are limited to events lasting for up to 96 hours;
- Scale they cannot involve the presence of more than 499 people at any one time;
- Use of the same premises the same premises cannot be used on more than 12 occasions in a calendar year, but are subject to the overall aggregate of 15 days irrespective of the number of occasions on which they have been used; and

• The number of notices given by an individual within a given period of time – a Personal Licence Holder is limited to 50 notices in one year, and another person to 5 notices in a similar period.

(In any other circumstances, a full Premises Licence or Club Premises Certificate will be required for the period of the event).

'the Act': means the Licensing Act 2003

**'Vicinity'**: Given the normal everyday meaning of being 'near to' when considering the relevance of representations received from individual's residence or business.

On the 20<sup>th</sup> April 2011 a joint initiative by Trading Standards, HMRC and Cambridgeshire Police was carried out to clamp down on the illicit tobacco and alcohol trade.

HMRC officers seized a total of 28.5 Litres Italian Wine from manager of the shop Mr Mohammed Shafiq as liable to forfeiture by virtue of the Customs & Excise Acts. They were satisfied that due to the proprietors inability to produce invoices or receipts to prove duty payment, that United Kingdom Excise Duty had not been paid on said goods.

The revenue due on the seized goods is £88.20

The goods were seized in accordance with section 139 of Customs & Excise Management Act 1979.

No notice of claim against the forfeiture was received within the statutory time limit therefore the Wine is condemned as forfeited in accordance with paragraph 5 of schedule 3 to the above legislation.

On 24/11/2010 a visit was also undertaken by HMRC officers to the premises when officers seized a total of 6.3 Litres Spirits (8x.70cl bottles of Glens Vodka = 5.6 litres and 0.7cl Dexter Whisky) from Shafiq Muhammed

The revenue due on the seized goods is £59.98

**Recommendations**:

A revocation of the alcohol licence.

Reasons for the above recommendation;

Trading Standards as a responsible authority recommends revocation due to the seriousness of the illicit trade.

This is supported by guidance issued under section 182 of the Licensing Act 2003. 11.26 There is a certain criminal activity that may arise in connection with licensed premises, which the Secretary of State considers should be treated particularly seriously.

One of them being;

- for the sale of smuggled tobacco and alcohol.

Guidance states - It is envisaged that licensing authorities, the police and other law enforcement agencies, which are responsible authorities will use the review procedures effectively to deter such activities in crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through premises being used to further crimes, it is expected that revocation of the licence - even in the first instance - should be seriously considered.

On the 20<sup>th</sup> April 2011 Cambridgeshire Constabulary supported Trading Standards and HMRC in a joint initiative designed to clamp down on the illegal trade of illicit and counterfeit goods. B Stop – 415 Lincoln Road was visited and illicit goods were seized showing revenue due to the value of £88.20

Cambridgeshire Constabulary are also aware that a previous visit undertaken by HMRC on 24<sup>th</sup> November 2010 to the same address location resulted in the seizure of various goods with revenue due to the value of £59.98.

"Cambridgeshire Constabulary take a very serious view on the sale of illicit and/or counterfeit goods realising the serious implications upon the licensing principle of preventing crime and disorder. Such crime has a detrimental effect upon the community and can be harmful to unwitting customers. Such crime is linked to serious and organised crime.

Under the guidelines as set out under S.182 of the Licensing Act 2003 (11.26) Cambridgeshire Constabulary fully support our partners, HMRC and Trading Standards, as a responsible authorities, and there recommendations for the full revocation of the license for B Stop – 415 Lincoln Road, due to evidence of illicit trade".

# 1. PURPOSE OF REPORT

1.1 To consider and determine an application for a review of a Premises Licence under Section 51 of the Licensing Act 2003 for the above premises, taking into account the representation made by Trading Standards in their capacity as a Responsible Authority, and letter of support of the review and recommendations from Cambridgeshire Constabulary also a Responsible Authority. The review was bought under the Prevention of Crime and Disorder objective.

# 2. BACKGROUND INFORMATION

2.1 On the 11<sup>th</sup> July 2006 an application for a new off licence was submitted jointly by Mr Murat Tasci & Mr Ergun Tasci. As there were no representations from any of the responsible authorities nor from any interested parties the premises licence was granted on 11<sup>th</sup> August 2006. A copy of this current premises licence is attached at **Appendix B – Page 45**.

# 3. APPLICATION

- 3.1 In accordance with section 51 of the Licensing Act 2003 following the submission of an application to review the premises licence from Trading Standards, a Responsible Authority, the licensing authority must hold a hearing.
- 3.2 A copy of the application to review was received 4<sup>th</sup> August 2011 and a copy of which is attached at **Appendix C Page 53**.
- 3.3 A copy of the 'Notice' that was displayed on the premises in accordance with Part 5 no. 38 of Statutory Instruments 2005 No. 42 The Licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005 is attached at Appendix D Page 59.

- 3.4 A representation in support of the review and recommendations was received from Cambridgeshire Constabulary as a Responsible Authority, a copy of this representation is attached at **Appendix E Page 61.**
- 3.5 No other representations have been received from any of the remaining Responsible Authorities or any interested parties.
- 3.6 A letter was received by the premises licence holder's agent, NARTS, containing a voluntary set of additional conditions that the premises licence holders are now adhering to and also copies of invoices from Achala Traders UK Ltd and Roy Nut Foods Ltd. They purport that these copy invoices indicate that UK Duty has been paid on the Vodka and that a member of staff from Roy Nuts Foods Ltd would be willing to confirm that duty had been paid on the tobacco. These papers are attached at **Appendix F Page 63**.

# 4.1 Summary of issues raised by Responsible Authorities

- i. Her Majesty's Revenue and Customs (HMRC) have seized alleged non UK duty paid alcohol & tobacco from the premises on 20<sup>th</sup> April 2011
- ii. The premises had initially failed to provide documentation for the seized alcohol & tobacco to prove that UK duty had been paid.
- iii. The UK Duty evaded for both alcohol & tobacco was £373.43.
- iv. Guidance issued under section 182 of the Licensing Act 2003 recommends revocation, even in the first instance.

# 5. LICENSING OFFICERS COMMENTS

5.1 Section 11.23 of Guidance (issued under section 182) states, 'A number of reviews may arise in connection with crime that is not directly connected with licensable activities . For example, reviews may arise because of drugs problems at the premises or money laundering by criminal gangs or the sale of contraband or stolen goods there or the sale of firearms. Licensing authorities do not have the power to judge the criminality or otherwise of any issues. This is a matter for the courts of law. The role of the licensing authority when determining such a review is not therefore to establish the guilt or innocence of any individual, but to ensure that the crime prevention objective is promoted.

# 7. LEGAL OFFICER'S COMMENTS

- 7.1 The Licensing Authority (hereafter referred to as "the Council) is charged with implementing the provisions of the Licensing Act 2003. This is an application for a review of a premises licence following the application by Trading Standards (Responsible Authority) to review the premises licence made under section 51 of the Licensing Act 2003.
- 7.2 In this case, the application was received at these offices on 4<sup>th</sup> August 2011.
- 7.3 The application before this committee will consider
  - (i) The application to review the licence,
  - (ii) Any relevant representations
- 7.4 The committee will take such of the steps as it considers that action is necessary for the promotion of the licensing objectives. The steps are
  - (a) to modify the conditions of the premises licence
  - (b) to exclude a licensable activity from the scope of the licence
  - (c) to remove the designated premises supervisor from the licence
  - (d) to suspend the licence for a period not exceeding three months, or
  - (e) to revoke the licence

and for this purpose the conditions of the licence are modified if any of them is altered or omitted or any new condition is added

7.5 In addition the guidance issued under section 182 of the Licensing Act 2003 states:

'The licensing authority may decide that no action is necessary if it finds that the review does not require it to take any steps necessary to promote the licensing objectives. In addition, there is nothing to prevent a licensing authority issuing an informal warning to the licence holder and/or to recommend improvement within a particular time. It is expected that licensing authorities will regard such warnings as an important mechanism for ensuring that the licensing objectives are effectively promoted and that warnings should be in issued in writing to the holder of the licence. But, where responsible authorities like the police or environmental health officers have already issued warnings requiring improvements – either orally or in writing – that have failed as part of their own stepped approach to concerns, licensing authorities should not merely repeat that approach.

Note: In this document, the following definitions are included to provide an explanation of certain terms included in the Act. In some cases they are an abbreviation of what is stated in the Licensing Act 2003 or an interpretation of those terms. Trading Standards are requesting a review of the premises licence for Peterborough Supermarket (known as Peterborough Food and Wine Centre) under the prevention of crime and disorder following a joint operation by Trading Standards, HM Revenue and Customs (HMRC) and Cambridgeshire Police to clamp down on the illicit tobacco and alcohol trade.

On 20<sup>th</sup> April 2011 a joint initiative by Trading Standards, HM Revenue and Customs and Cambridgeshire Police was carried out to clamp down on the illicit tobacco and alcohol trade.

HMRC officers seized a total of 3.75 Litres counterfeit Passion Vodka and 2.75 kg Shisha Tobacco (5 boxes Alfakher and 6 boxes Nakhla) from Murat Tasci, as liable to forfeiture by virtue of the Customs & Excise Acts.

They were satisfied that due to the proprietors inability to produce invoices or receipts to prove duty payment, that United Kingdom Excise Duty had not been paid on said goods.

The revenue due on the seized goods is £373.43

The goods were seized in accordance with Section 139 of Customs & Excise Management Act 1979.

No notice of claim against the forfeiture was received within the statutory time limit therefore the Spirits and Shisha Tobacco are condemned as forfeited in accordance with paragraph 5 of schedule 3 to CEMA.

Recommendations;

A revocation of the alcohol licence.

Reasons for the above recommendation;

Trading Standards as a responsible authority recommends revocation due to the seriousness of the illicit trade.

This is supported by guidance issued under section 182 of the Licensing Act 2003 11.26 There is a certain criminal activity that may arise in connection with licensed premises, which the Secretary of State considers should be treated particularly seriously.

One of them being;

- for the sale of smuggled tobacco and alcohol.

Guidance states - It is envisaged that licensing authorities, the police and other law enforcement agencies, which are responsible authorities will use the review procedures effectively to deter such activities in crime. Where reviews arise and the licensing authority determines that the crime prevention objective is being undermined through the premises being used to further crimes, it is expected that revocation of the licence - even in the first instance - should be seriously considered.

I can further confirm that our client was on holiday and upon his return he became aware that there had been a review application submitted by the Trading Standards.

After our instruction, we have advised our client to comply with the following five conditions voluntarily to prevent any further incidents which has never happened under his ownership for five years at this premises:

1. No alcoholic goods will ever be purchased from sellers calling to the shop.

2. Invoices (or copies) for all alcoholic goods on the premises will be kept at the shop and made available to officers from the council, police or HMRC upon request.

3. A stock control system will be introduced, so that the licensee can quickly identify where and when alcoholic goods have been purchased.

4. An ultra-violet light will be available at the premises for the purpose of checking the UK Duty Stamp on spirits as soon as practical after they have been purchased.

5. If any spirits bought by the company have UK Duty Stamps that do not fluoresce under ultra-violet light, or are otherwise suspicious, the licensee shall identify the supplier to Trading Standards Department and HMRC as soon as possible.
