### 1. PURPOSE OF REPORT

1.1 To consider and determine this application for a <u>new</u> premises licence for Tesco, 140 Oundle Road, Peterborough, taking into account the representations received from 47 persons and one local Councillor who are all, under the Licensing Act 2003, defined as 'other persons'.

### 2. BACKGROUND INFORMATION

- 2.1 The premises had, until 14 October 2013 been operating as a public house under the authority of a premises licence. The premises had been called The Boys Head and The Boro Bar.
- 2.2 The premises licence was initially granted on 4 August 2005 after being converted under 'grandfather rights' from the previously held Justices Licence. The premises had been subject to a number of different premises licence holders and designated premises supervisors since the initial granting of the licence.
- 2.3 On 14 October 2013 the premises licence was surrendered by Star Pubs & Bars.

### 3. AUTHORISATIONS AND TIMES APPLIED FOR

• Sale of alcohol for consumption off the premises

Monday to Sunday 06.00 to 23.00

• Hours premises are open to the public

Monday to Sunday 06.00 to 23.00.

### 4. APPLICATION

- 4.1 Please refer to the application attached at **Appendix B Page 11 22**
- 4.2 Representations have been received from one local Councillor and 47 'other persons'. These are attached at **Appendix B on Page 23**.
- 4.4 Part P of the application sets out the applicant's proposed conditions under the licensing objectives, these being, 'The Prevention of Public Nuisance', 'Public Safety', 'Prevention of Crime and Disorder' and 'The Protection of Children from Harm'. These are also contained within the body of this report (in section 7) and in accordance with section 10.5 of Guidance have been interpreted into enforceable conditions. Only those appropriate and proportionate for the promotion of the licensing objectives have been included in the Operating Schedule.
- 4.5 No representations have been received from any of the Responsible Authorities i.e. Cambridgeshire Constabulary, Peterborough City Council Trading Standards, Public Health Authority, Cambridgeshire Fire and Rescue Service, Licensing Authority, Peterborough City Council Planning Department, Peterborough City Council Health & Safety Department, Children's Services or Peterborough City Council Environmental Pollution Team.
- 4.6 A 'Notice' was displayed in the newspaper in accordance with Part 4 No. 25 of Statutory Instruments 2005 No. 42 The licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005.

### 5. OTHER PERSONS

- 5.1 Summary of issues raised:
  - If granted it would contribute to an increase in street drinking in the area;
  - If granted it could lead to a rise in anti social behaviour; and
  - If granted it would lead to an increase in noise and disturbance in the area.

### 6. MEDIATION

6.1 No mediation has taken place.

### 7. APPLICANT'S PROPOSED CONDITIONS UNDER THE LICENSING OBJECTIVES:

### 7.1 Crime and disorder

- Digital CCTV recording equipment shall be installed inside the premises and maintained in working order;
- Digital CCTV images will be clear and comprehensible and shall be retained for at least 21 days. The images shall be produced to an authorised Police or Licensing Authority Officer on demand; and
- Notices advising that CCTV has been installed on the premises shall be posted up so that they are clearly visible to the public within the licensed premises.

### 7.2 **Prevention of Public Nuisance**

Store management will proactively liaise with both the Police and Local Authorities if required.

### 7.3 **Protection of children from harm**

Any person selling or supplying alcohol under the authority of a personal licence holder must ask for a photo ID proof where they have reason to suspect the individual may be under 25 years of age;

- Signage will be prominently placed within the premises advertising the fact that the premises operates the 'Think 25' initiative;
- > Staff training will be ongoing and reviewed regularly; and
- > A till prompt will appear on the initial sale of alcohol that will remind the seller to adopt the 'Think 25' policy.

### 7.4 **Public Safety**

> The store will adhere to all rules and regulations relating to public safety.

### 9. LICENSING OFFICER'S COMMENT (FOR INFORMATION)

- 9.1 Regulation 19(a) requires authorities to disregard any information given by a party or person that is "not relevant" to the application.
- 9.2 Members should note that the letters attached are in their entirety and that not all matters raised within the representations are relevant matters for consideration under the Licensing Act 2003. It is up to the Committee to decide upon what 'weight' they attach to these areas.

### 10. LEGAL OFFICER'S COMMENTS

- 10.1 The Licensing Authority (hereafter referred to as "the Council) is charged with implementing the provisions of the Licensing Act 2003. This is an application for a new licence made under Section 17 of the Licensing Act.
- 10.2 In this case, the application was received at these offices on 5 February 2014.
- 10.3 The application before this committee will be treated on its own merits, and the Licensing committee will make its decision based upon
  - The merits of the application
  - The promotion of the four licensing objectives
  - The statement of policy of the Licensing Authority
  - The Guidance issued by the Secretary of State for Culture, Media and Sport under section 182 of the Licensing Act 2003 October 2012
- 10.4 The licensing authority may determine the application, depending upon what is appropriate for the promotion of the licensing objectives, in any of the following ways:

- Decide to grant the licence in the same terms as it was applied for
- Decide to grant the licence, but to modify or add conditions (to promote the licensing objectives)
- Exclude from the scope of the licence a licensable activity
- Decide to refuse to grant the licence
- 10.5 Conditions are modified if they are altered, omitted or any new condition added (Section 35(4) Licensing Act 2003.

### LICENSING ACT 2003 GLOSSARY OF TERMS

Note: In this document, the following definitions are included to provide an explanation of certain terms included in the Act. In some cases they are an abbreviation of what is stated in the Licensing Act 2003 or an interpretation of those terms. For a full definition of the terms used, the reader must refer to the Licensing Act 2003.

### 'Child'

(a) means an individual aged under 16

(b) a child is unaccompanied if he is not in the company of an individual aged 18 years or over

DCMS: Department for Culture Media and Sport

**'Designated Premises Supervisor'** means the person (who must be a Personal Licence Holder), in the case of premises selling alcohol, who will normally have been given the day to day responsibility for running the premises by the holder of the Premises Licence or will be the Premises Licence holder.

### 'Other Persons':

- persons who live, or are involved in a business, in the relevant licensing Authorities area and who are likely to be affected by the application and are not a Responsible Authority.

**'Late Night Refreshment'** means the supply of hot food or hot drink to members of the public (whether for consumption on or off the premises) between the hours of 11.00 pm and 5.00 am.

'Licensable Activities' means: -

- The sale by retail of alcohol
- The supply of alcohol by or on behalf of a club to, or to the order of, a member of the club
- The provision of Regulated Entertainment
- The provision of Late Night Refreshment

'Licensing Authority': - is the licensing function of Peterborough City Council

'Licensed Premises' includes club premises and events unless the context otherwise requires.

### 'Licensing Objectives'

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

**'Operating Schedule'** means a document containing a statement of the following matters (and any others that may be prescribed): -

- The relevant Licensable Activities
- The times at which the Licensable Activities are to take place and any other times when premises are open to the public
- Information regarding the person who will be specified in the Premises Licence as the Premises Supervisor
- Where the Licensable Activities involve the supply of alcohol, whether it is for the supply on and/or off the premises
- The steps being taken to promote the Licensing Objectives

**'Rateable Value'**: as regards a premises, is the value for the time being in force for the premises entered in the local non-domestic rating list for the purposes of Part III of the Local Government Finance Act 1988(b).

'Regulated Entertainment' (Schedule 1 of the Act) means: -

- A performance of a play
- An exhibition of a film
- An indoor sporting event
- A boxing or wrestling entertainment
- A performance of live music
- Any playing of recorded music
- A performance of dance

Or entertainment of a similar description falling within the last three of the categories listed above, where the entertainment takes place in the presence of and for the purposes of entertaining that audience or spectators.

**Or** the provision of entertainment facilities:

Facilities for enabling persons to take part in entertainment of the following description for the purpose or purposes, which include the purpose of being entertained:

- making music
- dancing
- entertainment of a similar description

**'Relevant Licensing Authority':** is the Authority in the area the premises are situated.

'Responsible Authority' means any of the following: -

- Cambridgeshire Constabulary (The Chief Officer of Police)
- Cambridgeshire Fire and Rescue (The Fire Authority)
- Health and Safety Team, Peterborough City Council
- Planning authority, Peterborough City Council
- Trading Standards, Peterborough City Council
- Environmental Health Pollution, Peterborough City Council
- Children's' Services Child Protection & Review Manager
- Primary Care Trust or Local Health Board (Director of Public Health)
- The Relevant Licensing Authority, Peterborough City Council
- Maritime & Coastguard Agency, Walton on Naze. (For vessels carrying more than 12 passengers.)
- Environment Agency, Peterborough (For vessels carrying 12 or less passengers).

### 'Supply of alcohol':

- the sale by retail of alcohol, or
- the supply of alcohol by or on behalf of a club to, or to the order of, a member of the club.

**'Temporary Event Notice'** means a Permitted Temporary Activity involving one or more Licensable Activities subject to the following various conditions and limitations: -

- Duration they are limited to events lasting for up to 168 hours (7 days);
- Scale they cannot involve the presence of more than 499 people at any one time;
- Use of the same premises the same premises cannot be used on more than 12 occasions in a calendar year, but are subject to the overall aggregate of 21 days irrespective of the number of occasions on which they have been used; and

• The number of notices given by an individual within a given period of time – a Personal Licence Holder is limited to 50 notices in one year and another person to 5 notices in a similar period.

(In any other circumstances, a full Premises Licence or Club Premises Certificate will be required for the period of the event).

a) General - all four licensing objectives (b,c,d,e)

We are a national retailer that sells alcohol as part of a broad offering of goods and services. We have held off-licences in our stores for many years and are an approved British Institute of Inn-keeping examination centre. We have written training policies and formal training programmes are in place, which ensure our people are equipped to meet all licensing objectives. All training and revision/refresher materials are reviewed regularly. All stores currently comply with our 'Think 25' policy, this is brought to customer's attention through point of sale material within the store. We take legal compliance very seriously and in addition to local training we employ a central alcohol licensing compliance manager and have a compliance committee.

b) The prevention of crime and disorder

The premises will have digital CCTV system that covers many areas of the shop floor, including the proposed area which will be used for beer and wine, should we be successful with our application.

Images will be retained for a minimum of 21 days and made available on enforcement request. Ordinarily, a member of the Management team will be on the premises all the time the store is open. A person will have responsibility for the premises whilst the premises are open.

c) Public safety

A person will have responsibility for the premises whilst the premises are open. Management will be trained to support the running of the premises including looking after our customers and staff. The store will adhere to all rules and regulations relating to public safety.

d) The prevention of public nuisance

We intend to be an active member of the community. We welcome the opportunity to liaise with Police and enforcement authorities should the need arise. Continued from previous page...

e) The protection of children from harm

All staff will be trained and regularly refreshed in the corporate 'Think 25' Policy. Staff will be trained to look at the customer and 'Think 25' when selling alcohol.

A till prompt will appear on the initial sale of alcohol that will remind the seller of their responsibilities including not to sell alcohol to anyone under the age of 18.

The store will display signage around the premises informing both staff and customers of our 'Think 25' policy on alcohol.

Hello

I am writing to request the license for the above application not to be granted.

As a local councillor I have worked with local residents, council officers and the police to change the area in and around the proposed license store to eradicate significant street drinking and alcohol abuse. We have made significant progress in this area and their is a visible difference in the area. With one of the groups residing within yards of this proposed store and we have managed to dissolve the issue.

The prevention of crime and disorder

After a significant amount of time removing alcohol related disorder and crime in this very specific area. The people responsible for these types of issues remain in the same street and close by to this store. To open another establishment will firstly send the wrong message but more importantly it

would help to reverse all the gains we have made. We have put a strong message out regards Alcohol related disorder and acted decisively to make a difference and another store with cheap alcohol will undoubtedly be a step in the wrong direction. Police have been called to the direct area of the store to deal with significant crime and disorder within 100 yards of this store.

It will be in the benefit of the store not to sell alcohol and will minimise the issues they will undoubtedly be bringing on themselves. This disorder will be close to and in the same cul de sac as a school and children's centre which is a real concern for me as children will be passing this store from

early in the morning to early evening. The store is proposing to open from 6 am to 11pm which will be a magnet and incentive for street drinkers and disturbances will happen to very late and night and the feedback from drinkers is they seem to like the idea of a 6 am local store who will sell

cheap alcohol. This tells me the likelihood of crime and disorder are very high. This is a quiet residential area now and the license will create pressures that can and should be avoided.

### Public Safety

The area and the road which the store is located is right next to a church and school and with the anticipated re-emergence of the street drinking this store will create their is a real and concerned opinion that safety of children and parents as they pass the drinking community. There has already

and continues to be violent related incidents in the area, this has diminished through work done by the police and council to dispute this problem. The probability in my experience with the problem that this store will encourage and create an area of drunken disorder causing real public safety concerns. We have had in the past violent altercations in the area due to problems with the street drinking community to the point there was serious police intervention on a number of times due to violence. This will be a probable outcome again if we allow alchol to be sold from these premises.

### Protection of children from harm

This store will sell alchol directly outside a primary school, nursery and children's centre. Parents and children will be passing by this store all day and with the known problem in the area of street drinking and the related issues that go along with this issue there is a real probability of children

being exposed too and being unwilling drawn into the associated problems. From my experience dealing with this issue I can almost without uncertainty guarantee that children will be affected by the disorder cheap alcohol in this specific area will bring. The school and children's environment should not be compromised or threatened by the selling of alcohol and the knock on effect of encouraging street drinking.

### The prevention of public disorder

Another store selling alcohol will escalate and send the wrong message to street drinkers which will increase public nuisance and affect local residents. The previous use of the site was a public house and the drinking was managed and in reality it was a discouragement for street drinking and public nuisance due to the fact the landlords managed the situation and most importantly the drinking was done in the building not outside. The premises are in a cul de sac, residential and close by a school. Next door to the store is a church who have grave concerns over the possibility of alcohol sales and the impact it will have on their congregation. There is also a remembrance garden used by family members to mourn their loved ones. This area has and may well again be a magnet to people wanting to consume their recently purchased alcohol. Overwhelmingly the local groups, residents and businesses are concerned for the level of public order which I and they believe will be compromised. Street drinking will become a real problem again in this area if the license is approved and this will lead to serious disorder on a regular basis. This will take us back two years, after a

significant effort by a number of organisations who due to financial constraints may not be repeatable.

If you are minded to approve the license could I ask for consideration on when alcohol is sold and ensure it does not happen during school times and ensure the street drinkers cannot buy alcohol early in the morning and late at night.

Also, as other city's do could you consider the ability to restrict the sale of cheap alcohol as instructed by other authorities such as Northampton Council.

Many thanks for your attention and I look forward to the support of this body in making Fletton and Woodston a place where quality of life and community are the main catalyst for all decisions.

#### Dear Sir/ madam

I am writing to you with regards to the application for a licence to sell alcohol on the premises by the above company. As a resident of Woodston I am requesting that the license is not granted to Tesco Stores Ltd for the following reasons:

#### 1) The prevention of crime and disorder

I believe granting a license to sell alcohol in this residential area near a school could bring street drinking to our area. Our local councillor has been working closely with the police to stop this in our area and another alcohol outlet will reverse the gains that have been made. With street drinking there is a greater risk of crime and disorder. There have been a number of incidents in this direct area where police have had to intervene due to alcohol related incidents, which if this license is granted, will create real and significant rises in crime and disorder by reversing all the gains that have been made over the last couple of years.

#### 2) Public safety

Granting a license to Tesco Express which is located next to 2 primary schools and a nursery is a real concern to me. If people are buying alcohol from this shop and street drinking, the parents and children would not feel safe going to and leaving schools and nursery. With street drinking usually comes public disorder and maybe even violence. There has been violent, drink related problems in the area where people have felt physically threatened or have been the victim of violence. There has been a lot of good work to remove this problem and if this license is granted this work would be put into reverse.

#### 3) The protection of children from harm

This retail business is in a vicinity very close to 2 primary schools and a nursery. The parents and children have to pass by this shop to go to and from the primary schools and nursery. If alcohol is sold here, street drinking will occur as it has happened in the past next to the other two shops which already have a license. Residents feel that if you grant this shop a license to sell alcohol you would be putting our children at risk as with street drinking usually comes public disorder and maybe even violence directly next to a primary school. The school environment should not be compromised by alcohol related problems and this application is directly next to a school.

#### 4) The prevention of public nuisance

There are already 2 shops close by which sell alcohol. Street drinking has been a problem in this area for quite some time. If another shop is allowed to sell alcohol the street drinking issue will escalate and with that comes a public nuisance. This would be in a residential area near schools and a nursery. The shop is planning to open until 11pm at night, this would not be fair on the residents who live close by. If the shop sells alcohol it will attract people who will create more noise and disturbance to the residents. The premises was previously used as a public house, the street drinking was not its role and in fact it discouraged street drinking, this license will encourage street drinking in an area next to a school and where there are already a number of outlets selling alcohol.

- 4.2 The applicant is Littlejohn & Co who are a private limited company. Mr Sanjay Khunti is the proposed DPS (Designated Premises Supervisor) and has held a personal licence with Peterborough City Council since 7<sup>th</sup> March 2014.

- 4.3 Representations have been received from one 'other person' and is attached at **Appendix B on Page 49**.
- 4.4 Part P of the application sets out the applicant's proposed conditions under the licensing objectives, these being, 'The Prevention of Public Nuisance', 'Public Safety', 'Prevention of Crime and Disorder' and 'The Protection of Children from Harm'. These are also contained within the body of this report (in section 7) and in accordance with section 10.5 of Guidance have been interpreted into enforceable conditions. Only those appropriate and proportionate for the promotion of the licensing objectives have been included in the Operating Schedule.
- 4.5 No representations have been received from any of the Responsible Authorities i.e. Cambridgeshire Constabulary, Peterborough City Council Trading Standards, Public Health Authority, Cambridgeshire Fire and Rescue Service, Licensing Authority, Peterborough City Council Planning Department, Peterborough City Council Health & Safety Department, Children's Services or Peterborough City Council Environmental Pollution Team.
- 4.6 A 'Notice' was displayed in the newspaper in accordance with Part 4 No. 25 of Statutory Instruments 2005 No. 42 The licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005.

### 5. OTHER PERSONS

- 5.1 Summary of issues raised:
  - If granted it would contribute to an increase in anti-social behaviour in the area;

- All invoices (originals or copies) for all alcoholic goods for retail sale on the premises will be kept at the shop and made available to Police, Council and HMRC Officers upon request;
- An ultra violet light will be available and maintained at the store for the purpose of checking the UK Duty Stamp on all spirits as soon as practical after they have been purchased;
- If any spirits brought by the company / licensee have UK Duty Stamps that do not fluoresce under ultra-violet light, or are otherwise suspicious, the licensee shall

identify the supplier to Trading Standards Department or HMRC as soon as possible;

- A means of two way communication shall be provided between the premises and the local police or CCTV monitoring centre to report incidents;
- Public information notices about crime and disorder issues shall be displayed at the request of the Council or the Cambridgeshire Constabulary; and
- Any conditions of entry to the premises shall be displayed in the vicinity of any entrance to the premises.

### 7.2 **Prevention of Public Nuisance**

- No customers will be admitted, or permitted to leave when carrying open or sealed bottles or glasses; and
- > No alcohol shall be consumed on the premises.

### 7.3 **Protection of children from harm**

- Any person selling or supplying alcohol under the authority of a personal licence holder must ask for a photo ID proof where they have reason to suspect the individual may be under 25 years of age;

- Where the Licensable Activities involve the supply of alcohol, whether it is for the supply on and/or off the premises
- The steps being taken to promote the Licensing Objectives

**'Rateable Value'**: as regards a premises, is the value for the time being in force for the premises entered in the local non-domestic rating list for the purposes of Part III of the Local Government Finance Act 1988(b).

'Regulated Entertainment' (Schedule 1 of the Act) means: -

- A performance of a play
- An exhibition of a film
- An indoor sporting event
- A boxing or wrestling entertainment
- A performance of live music
- Any playing of recorded music
- A performance of dance

Or entertainment of a similar description falling within the last three of the categories listed above, where the entertainment takes place in the presence of and for the purposes of entertaining that audience or spectators.

- the supply of alcohol by or on behalf of a club to, or to the order of, a member of the club.

**'Temporary Event Notice'** means a Permitted Temporary Activity involving one or more Licensable Activities subject to the following various conditions and limitations: -

- Duration they are limited to events lasting for up to 168 hours (7 days);
- Scale they cannot involve the presence of more than 499 people at any one time;
- Use of the same premises the same premises cannot be used on more than 12 occasions in a calendar year, but are subject to the overall aggregate of 21 days irrespective of the number of occasions on which they have been used; and

• The number of notices given by an individual within a given period of time – a Personal Licence Holder is limited to 50 notices in one year and another person to 5 notices in a similar period.

(In any other circumstances, a full Premises Licence or Club Premises Certificate will be required for the period of the event).

#### Please summarise your concerns about this application:

I am writing to register my objection to the application for a premises licence by Littlejohn & Co Ltd, for 4 Fortune Buildings, Cowgate, Peterborough PE1 1LR.

The basis for this opposition is that granting a licence for these premises will not promote the licensing objectives, in particular the prevention of crime, disorder and anti-social behaviour.

Furthermore, 4 Fortune Buildings lies within Council's Central ward, (fringe city centre, and business district) and enabling the premises to sell alcohol would be totally detrimental to its aims and objectives. The application proposes that alcohol will be sold for consumption off the premises between: 07:30a.m. – 10:00 p.m. Monday to Friday, and 08:00a.m. – 10:00p.m. at weekends (7 days a week).

Granting a licence would provide a further source of alcohol within an area already heavily populated with other licenced premises and that crime, disorder and public nuisance have already reached problem levels for the local authorities.

Existing residents and new residents (new housing development on the corner of Priestgate) as well as business workers, footfall shoppers already suffer noise nuisance and anti-social behaviour at for many hours of the day and night. They have endured this inconvenience since 2003 when the licensing legislation was first amended, and it is totally unacceptable to expect members of the public to continue having to endure such problems.

## Please give further details of <u>why</u> you believe this application will have an adverse effect on the licensing objectives

There is limited cctv in the area and only intermittent city Wi-Fi coverage in Cowgate which is a security issue for people's safety whilst in the area whilst entering and exiting the shop.

The lighting directly underneath and around Fortune Buildings is totally inadequate and must be improved for public safety. Also as shrinkage and pilfering in the off-licence happens it will be very difficult to detect the would be suspects.

The shop will become very difficult to manage for the owner due to shoppers wishing to purchase regular and excessive amounts of alcohol – often straight from coming out of the establishments such as: Drapers Arms pub, Post Office, Sports Lounge, The Pizza House, Prezzo and The Gourmet Plaza.

Due the limited number of waste bins in proximity of this shop lots of people will simply purchase something from this shop and dispose of their litter on the floor area in and around Cowgate and St. Johns Square such as: cigarette ends, bubble gum, empty cans, various bits of plastic.

I would also urge the committee to consider the findings of Health Impact Assessment, in which evidence of the negative effects of the flexible licensing hours has been supported by the views of the wider community.

In view of the above, I would urge the Licensing Authority to refuse the application.
