1. PURPOSE OF REPORT

1.1 To consider and determine this application for a new premises licence for Rylass, 489A Lincoln Road, Peterborough, taking into account the representations received from Cambridgeshire Constabulary and MANERP (a group representing local residents) in opposition to the application.

2. BACKGROUND INFORMATION

2.1 The application for a new premises licence was made by Mr Matas Bagociunas on 6 February 2015. The application did not address the Cumulative Impact Policy in which the premises is located, the applicant was contacted and he submitted a supplementary statement with extra conditions. This is attached at **Appendix C – Pages 21**

2.2 The Council adopted a special policy relating to cumulative impact in respect to all licensed premises for the Op Can Do area on 18 April 2013.

4. APPLICATION

4.1 Please refer to the application attached at **Appendix B – Pages 9**

- 4.2 Representations against the application have been received from Cambridgeshire Constabulary and MANERP (a group representing local residents) These are attached at **Appendix D on Page 23**.
- 4.3 Peterborough City Council Pollution Control Team recommended the addition of an extra four conditions to those offered in the application and supplementary statement. The applicant agreed the addition of the extra four conditions, therefore no representation was made by the pollution team. The agreement is attached at **Appendix E on Page 31**.
- 4.4 Part P of the application sets out the applicant's proposed conditions under the licensing objectives, these being, 'The Prevention of Public Nuisance', 'Public Safety', 'Prevention of Crime and Disorder' and 'The Protection of Children from Harm'. These are also contained within the body of this report (in section 7) and in accordance with section 10.5 of Guidance have been interpreted into enforceable conditions. Only those appropriate and proportionate for the promotion of the licensing objectives have been included in the Operating Schedule.
- 4.5 A 'Notice' was displayed in the newspaper in accordance with Part 4 No. 25 of Statutory Instruments 2005 No. 42 – The licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005. A copy of this notice is attached at **Appendix F on Page 35**.

5. REPRESENTATIONS

5.1 Summary of issues raised

- Application falls within the Cumulative Impact (CI) Area, an area identified within the Councils Statement of Licensing Policy as already saturated with licensed premises.
- A further off licence is likely to add to the existing crime and anti-social behaviour fuelled by alcohol in the area, which is subject to a significant concentration of licensed premises.
- Evidence exists of the negative impact on the licensing objectives caused by alcohol, and the ease and availability of low cost alcohol which is purchased and abused in this locality.
- Application did not address the CI policy and does not demonstrate that it would not contribute towards issues already experienced.

6. MEDIATION

- 6.1 Mediation in relation to this application would not be appropriate. The adoption of a Cumulative Impact Policy creates a rebuttable presumption to refuse when relevant representations are received. Therefore it is for the Licensing Sub-Committee to determine whether or not to depart from this policy.

7. APPLICANT'S PROPOSED CONDITIONS UNDER THE LICENSING OBJECTIVES :

7.1 Crime and disorder

- CCTV must be installed and cover the inside and outside of the premises. It must be capable of holding recordings for 31 days and be available on request to a suitably authorised officer.
- Notices advising that CCTV has been installed on the premises shall be posted so that they are clearly visible to the public within the licensed premises.
- All employees/staff will receive initial and regular six monthly refresher training with regard to the conditions attached to the premises licence and the law, specifically to the Licensing Act 2003 and the four objectives. All training will be recorded and up to date training records of all training given by and to whom, will be maintained at the premises and produced and made available for immediate inspection upon request by an authorised officer.

- Any incidents of crime and disorder will be recorded in an incident register, which will be produced and made available for immediate inspection upon request by an authorised officer.
- No persons will be allowed to remain on the premises if they are displaying any signs violence or drunkenness through speech, manner or tone, or their disposition or steadiness on their feet.

7.2 **Prevention of Public Nuisance**

- Staff/employees of the premises will actively discourage and prevent anyone congregating, drinking or causing a disturbance outside the premises.
- Disposal of waste bottles into external receptacles where noise will be audible to neighbouring properties must not occur between 23:00 and 07:00 hours.
- Arrangements must be in place to ensure that waste collection contractors do not collect refuse between 23:00 and 07:00 hours
- An adequate number of suitable (lidded) receptacles shall be provided to receive and store refuse from the premises/site.
- Music played at the premises shall be background only.
For the purposes of this condition, 'background' means music that is inconspicuous i.e. it is possible to hold a conversation at normal volume with the music playing.

7.3 **Protection of children from harm**

- Any person who appears to be under the age of 25 will be challenged to produce identification prior to being allowed to purchase alcohol. Only identification bearing a photograph, date of birth, and either a holographic mark or ultraviolet feature will be accepted.
- Notices advising the Challenge 25 policy will be displayed inside the premises and at the main entrance, and on any advertising, literature, notices or website promoting the premises.

7.4 **Public Safety**

- Lighting will be provided both internally and externally to ensure the safety of customers, whilst also ensuring that it does not cause a public nuisance.

10. LEGAL OFFICER'S COMMENTS

- 10.1 The Licensing Authority (hereafter referred to as "the Council) is charged with implementing the provisions of the Licensing Act 2003. This is an application for a new licence made under Section 17 of the Licensing Act.
- 10.2 In this case, the application was received at these offices on 6 February 2015.
- 10.3 The application before this Committee will be treated on its own merits, and the Licensing Committee will make its decision based upon
- The merits of the application
 - The promotion of the four licensing objectives
 - The statement of policy of the Licensing Authority
 - The Guidance issued by the Secretary of State for Culture, Media and Sport under section 182 of the Licensing Act 2003 – October 2014
- 10.4 The licensing authority may determine the application, depending upon what is appropriate for the promotion of the licensing objectives, in any of the following ways:
- Decide to grant the licence in the same terms as it was applied for
 - Decide to grant the licence, but to modify or add conditions (to promote the licensing objectives)
 - Exclude from the scope of the licence a licensable activity
 - Decide to refuse to grant the licence
- 10.5 Conditions are modified if they are altered, omitted or any new condition added (Section 35(4) Licensing Act 2003).

LICENSING ACT 2003 GLOSSARY OF TERMS

Note: In this document, the following definitions are included to provide an explanation of certain terms included in the Act. In some cases they are an abbreviation of what is stated in the Licensing Act 2003 or an interpretation of those terms. For a full definition of the terms used, the reader must refer to the Licensing Act 2003.

'Child'

(a) means an individual aged under 16

(b) a child is unaccompanied if he is not in the company of an individual aged 18 years or over

DCMS: Department for Culture Media and Sport

'Designated Premises Supervisor' means the person (who must be a Personal Licence Holder), in the case of premises selling alcohol, who will normally have been given the day to day responsibility for running the premises by the holder of the Premises Licence or will be the Premises Licence holder.

'Other Persons':

- persons who live, or are involved in a business, in the relevant licensing Authorities area and who are likely to be affected by the application and are not a Responsible Authority.

'Late Night Refreshment' means the supply of hot food or hot drink to members of the public (whether for consumption on or off the premises) between the hours of 11.00 pm and 5.00 am.

'Licensable Activities' means: -

- The sale by retail of alcohol
- The supply of alcohol by or on behalf of a club to, or to the order of, a member of the club
- The provision of Regulated Entertainment
- The provision of Late Night Refreshment

'Licensing Authority': - is the licensing function of Peterborough City Council

'Licensed Premises' includes club premises and events unless the context otherwise requires.

'Licensing Objectives'

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

'Operating Schedule' means a document containing a statement of the following matters (and any others that may be prescribed): -

- The relevant Licensable Activities
- The times at which the Licensable Activities are to take place and any other times when premises are open to the public
- Information regarding the person who will be specified in the Premises Licence as the Premises Supervisor
- Where the Licensable Activities involve the supply of alcohol, whether it is for the supply on and/or off the premises
- The steps being taken to promote the Licensing Objectives

'Challenge 25' means that a retailer will ask for proof of identification if they have reason to believe that the person making a purchase of alcohol is under the age of 25.

‘Rateable Value’: as regards a premises, is the value for the time being in force for the premises entered in the local non-domestic rating list for the purposes of Part III of the Local Government Finance Act 1988(b).

‘Regulated Entertainment’ (Schedule 1 of the Act) means: -

- A performance of a play
- An exhibition of a film
- An indoor sporting event
- A boxing or wrestling entertainment
- A performance of live music
- Any playing of recorded music
- A performance of dance

Except where there is an exemption under the Live Music Act 2012 or Statutory Instrument 2013 No. 1578 The Licensing Act 2003 (Descriptions of Entertainment) (Amendment) Order 2013

Or entertainment of a similar description falling within the last three of the categories listed above, where the entertainment takes place in the presence of and for the purposes of entertaining that audience or spectators.

‘Relevant Licensing Authority’: is the Authority in the area the premises are situated.

‘Responsible Authority’ means any of the following: -

- Cambridgeshire Constabulary (The Chief Officer of Police)
- Cambridgeshire Fire and Rescue (The Fire Authority)
- Health and Safety Team, Peterborough City Council
- Planning authority, Peterborough City Council
- Trading Standards, Peterborough City Council
- Environmental Health – Pollution, Peterborough City Council
- Children’s Services – Child Protection & Review Manager
- Primary Care Trust or Local Health Board (Director of Public Health)
- The Relevant Licensing Authority, Peterborough City Council
- Maritime & Coastguard Agency, Walton on Naze. (For vessels carrying more than 12 passengers.)
- Environment Agency, Peterborough (For vessels carrying 12 or less passengers).

‘Supply of alcohol’:

- the sale by retail of alcohol, or
- the supply of alcohol by or on behalf of a club to, or to the order of, a member of the club.

‘Temporary Event Notice’ means a Permitted Temporary Activity involving one or more Licensable Activities subject to the following various conditions and limitations: -

- Duration – they are limited to events lasting for up to 168 hours (7 days);
- Scale – they cannot involve the presence of more than 499 people at any one time;
- Use of the same premises – the same premises cannot be used on more than 12 occasions in a calendar year, but are subject to the overall aggregate of 21 days irrespective of the number of occasions on which they have been used; and
- The number of notices given by an individual within a given period of time – a Personal Licence Holder is limited to 50 notices in one year and another person to 5 notices in a similar period.

(In any other circumstances, a full Premises Licence or Club Premises Certificate will be required for the period of the event).

I would like to add these to my four licensing objectives

- As I mentioned in my application my premises is monitored by CCTV internally and externally. All recordings are available on request for 30 days
- The premises licence holder will be on duty at the premises at most times that the premises are open to the public.
- Internal and external lighting fixed to promote the public safety objective
- Customers will be asked not to stand around loudly talking in the street outside the premises. Customers will not be admitted to premises above opening hours.
- All employees of the premises will receive initial and regular 6 monthly refresher training by the premises licence holder with regards to the conditions attached to the premises licence and the law in relation to the Licensing Act 2003. All training will be recorded and up to date training records of all training given and by/to whom, will be maintained at the premises and produced and made available for immediate inspection upon request.
- Any incidents of crime and disorder will be recorded in an incident register which will be produced and made available for immediate inspection upon request by the Police

On 06th February 2015 Cambridgeshire Constabulary Licensing Department (Peterborough District) received e-mail notification from Peterborough City Council Licensing Authority of an application for a new Premises License at 489a Lincoln Road, Peterborough, PE1 2PE. The application has been submitted electronically by Mr. Mantas Bagociunas of Rylas Ltd, 2 Nuts Grove Farm House, Scolding drove, Thorney, Peterborough, PE6 0TP, who will be the proposed Premises License holder and Designated Premises Supervisor respectively. Mr. Bagociunas holds an Alcohol Personal License issued very recently by PCC Licensing Authority reference: 070791.

This application seeks to install a new premises license at 489a Lincoln Road with the premises open and the supply of alcohol 'Off Premises' between 10:00am and 22:00pm daily. No other licensable activity has been applied for.

489a Lincoln Road is located centrally within the CAN-DO Operational area, on Lincoln Road and ultimately within the Cumulative Impact Area (Special Policy) drawn up and adopted on 18th April 2013. It has been positively identified that there is a significant concentration of licensed premises within the CAN-DO area. This premises is located next door to an existing Asian Muslim supermarket which does not sell alcohol. It is also situated directly across the road from Occupation Park – a large community field frequented by all members of the community and specifically children. The park area is always littered with discarded alcohol containers – more so as the evenings now get lighter.

Evidence does exist of the negative impact on the statutory objectives caused by alcohol within the CAN-DO area. Peterborough City Council's 'Statement of Licensing Policy', 'Special Policy on Cumulative Effect' - Paragraph 11.6 states:

*"This special policy creates a rebuttable presumption that applications within the Op Can Do area for **new premises** or club premises certificates or variations that are likely to add to the existing cumulative impact will normally be refused, if relevant representations are received about the cumulative impact on the licensing objectives, unless the applicant can demonstrate why the operation of the premises involved will not add to the cumulative impact already being experienced".*

Para 11.7 within the policy states:

“Applications will need to address the special policy issues in their operating schedules in order to rebut such a presumption”.

The formal application - part 19 states:

“Describe the steps you intend to take to promote the four licensing objectives:”

The applicant has asked for a small number of the standard conditions to be added to the license which only included CCTV, a proof of age scheme and he also refers to staff training – basic conditions routinely applied for given normal circumstances. The applicant makes no reference to how his premises will not add to the cumulative impact of alcohol harm associated with the area. However, I do understand the applicant has responded further (separate from this application) volunteering up further license conditions.

In my professional opinion as the Cambridgeshire Constabulary Licensing Officer for Peterborough District a further ‘Off’ license is more than likely going to add to the existing cumulative impact. Alcohol and its associated harms, crime and anti-social behaviour is having a significant impact on the local community specifically around the proposed shop location. There already exist a high number of licensed premises with the nearest one – an ‘Off’ License – directly across the road. Alcohol availability has exceeded saturation point within the CAN-DO area. Unfortunately no realistic suggestions by the applicant has been received that would satisfactorily demonstrate that the application, if granted, would not contribute towards the cumulative impact already being experienced. The license conditions may help the proposed licensee to sell alcohol responsibly, but does not take the extra step in addressing the real world outside the store door. If granted this would be another alcohol outlet offering all strengths of alcohol at reduced competitive prices to a vulnerable and already over supplied community.

Ultimately the decision on granting the license lies with the Licensing Sub-Committee. I am conscious that with a new license in place there is a real risk of a significant additional impact from the sale of alcohol on the local and wider community. A statistical report is currently being compiled and will be submitted as a ‘Supplementary Report’ in good time for the applicant and sub-committee to review prior to any listed hearing.

Cambridgeshire Constabulary do not support this application and recommend the Licensing sub-committee seriously consider the ‘Special Policy’ and reject the application. Should a rejection be considered as unsuitable in this case, and a license is granted, I would like to see the applicant reduce his hours that alcohol sales are made available and cease sales at 18:00pm daily. I would also recommend the following conditions are considered and added to the license to support the licensee and Local Authority in ensuring the Licensing Objectives are upheld.

The Prevention of Crime and Disorder:

1. CCTV will be provided in the form of a recordable system, capable of providing pictures of evidential quality in all lighting conditions in particular facial recognition. Cameras shall encompass all entrances and exits to the premises, fire exits and all area where the sale / supply of alcohol occur. A camera will be positioned outside the premises covering the shop frontage.
2. CCTV equipment must be maintained in good working order, be correctly time and date stamped. Recordings must be kept in date order, numbered sequentially and kept for a period of 28 days.

3. The Premises License Holder must ensure at all times a Designated Premises Supervisor or appointed member of staff is capable and competent at downloading CCTV footage in a recordable format and hand this footage over to the Police / Local Authority on demand.
4. The recording equipment and discs / usb pen drives shall be kept in a secure environment under the control of the DPS or other responsible named individual.
5. An operational daily log report must be maintained endorsed by signature, indicating the system has been checked and is compliant, in the event of any failings of the system actions taken are to be recorded.
6. In the event of a technical failure of the CCTV equipment the Premises License Holder / Designated Premises Supervisor must report the failure to the Police or local authority immediately.
7. Notices advising that CCTV has been installed on the premises shall be posted so that they are clearly visible to the public within the licensed premises.
8. Staff training in relation to identifying and preventing sales of alcohol to any person who is, or appears to be drunk should be undertaken on a monthly basis. This training, together with on-going training to prevent underage sales (Challenge 25) should be recorded in a written format and be available to an authorised officer upon demand.
9. A refusals log will be maintained on a daily basis recording all refused attempted purchases of alcohol.
10. No alcoholic drinks will be purchased by the store owners or staff from sellers calling at the store.
11. All invoices (originals or copies) for all alcoholic goods for retail sale on the premises will be kept at the licensed premises and made available to Police, Council and HMRC Officers upon request.
12. A strict stock control system will be introduced so that the licensee can quickly identify where and when alcoholic drinks have been purchased.
13. A ultra-violet light will be available and maintained at the store for the purpose of checking the UK Duty Stamp on all spirits as soon as practical after they have been purchased.
14. If any spirits bought by the company have UK Duty Stamps that do not fluoresce under ultra-violet light, or are otherwise suspicious, the licensee shall identify the supplier to the Trading Standards department and HMRC as soon as possible.
15. No single or double vessels of Beer, Lager or Cider above 6.5% Abv (alcohol content) will be offered for sale in the premises.

Promote Public Safety -

16. An adequate and appropriate supply of first aid equipment and materials shall be available on the premises.
17. Valid Public liability Insurance shall be kept in force and a copy of the schedule shall be available for inspection by an authorised officer on request.

18. No person will be allowed to enter or leave the licensed premises (as defined by the plan) with an open vessel of alcohol and the licensee will actively discourage and prevent anyone congregating or drinking outside the premises.

The Protection of Children from Harm –

19. Signage will be prominently placed within the premises advertising the fact that the premises operate the 'Challenge 25' initiative.
20. Any person selling or supplying alcoholic drink under the authority of a personal licence holder must ask for a photo ID proof of age where they have reason to believe that the individual may be less than 21 years of age.
21. A refusal log will be accurately maintained on every refusal made in relation to the attempted purchase of alcohol by a juvenile or intoxicated person.

I am the Chair of Millfield & New England Regeneration Partnership (MANERP) which represents residents who live in the Millfield and New England areas of Peterborough. The reason for writing is to request that the application for a Premises License be refused.

The Millfield and New England area of Peterborough has had for several years a history of anti-social behaviour fuelled by alcohol and drug abuse. This has been exacerbated by the rapid growth of a number of outlets retailing alcohol by means of "off-sales." The area is also within the boundary of the "Can-Do" initiative which has brought together the city council, police, NHS, Resident Associations and other partner agencies to jointly combat the serious issues being faced in this area.

The whole area is very sensitive and volatile because of the ease of access to the purchase of alcohol often sold at a low price in order to attract customers or be competitive. The area also falls within a Cumulative Impact Area.

As the Millfield and New England area has a phenomenal number of outlets selling alcohol "off-sales" (around the mid-seventy plus mark) which has contributed significantly to anti-social behaviour in the area. The current joint partnership between Peterborough City Council, Cambridgeshire Police and other partner agencies through "Operation Can-Do" has highlighted the need to reduce the number of outlets and hours that alcohol can be freely purchased if it is to make any headway towards the goals that it is striving to achieve. With this and the Cumulative Impact Policy in mind, we also make this representation under the following Licensing Objectives set out in the Licensing Act 2003.

- a) The prevention of crime and disorder
- b) Public safety
- c) The prevention of public nuisance

At MANERP our aim is to try to regenerate an area that has been sadly neglected for many years and the largest single problem of all revolves around the ease, low cost and availability at which alcohol can be purchased and subsequently abused.

We therefore respectfully request that this application be refused by the Licensing Committee for the reasons stated above.

With regards to the attached application Pollution Control would recommend the following conditions are attached to the licence:

1. Music played at the premises shall be background only.

For the purposes of this condition, 'background' means music that is inconspicuous i.e. it is possible to hold a conversation at normal volume with the music playing.

2. Disposal of waste bottles into external receptacles where noise will be audible to neighbouring properties must not occur between 23:00 and 07:00 hours.

3. Arrangements must be in place to ensure that waste collection contractors do not collect refuse between 23:00 and 07:00 hours.

4. An adequate number of suitable (lidded) receptacles shall be provided to receive and store refuse from the premises/site.

Additionally, it should be noted that the premise falls within the Council's Cumulative Impact (CI) area for alcohol licensing. This is essentially outlined by section 11.6 of the statement of Licensing Policy:

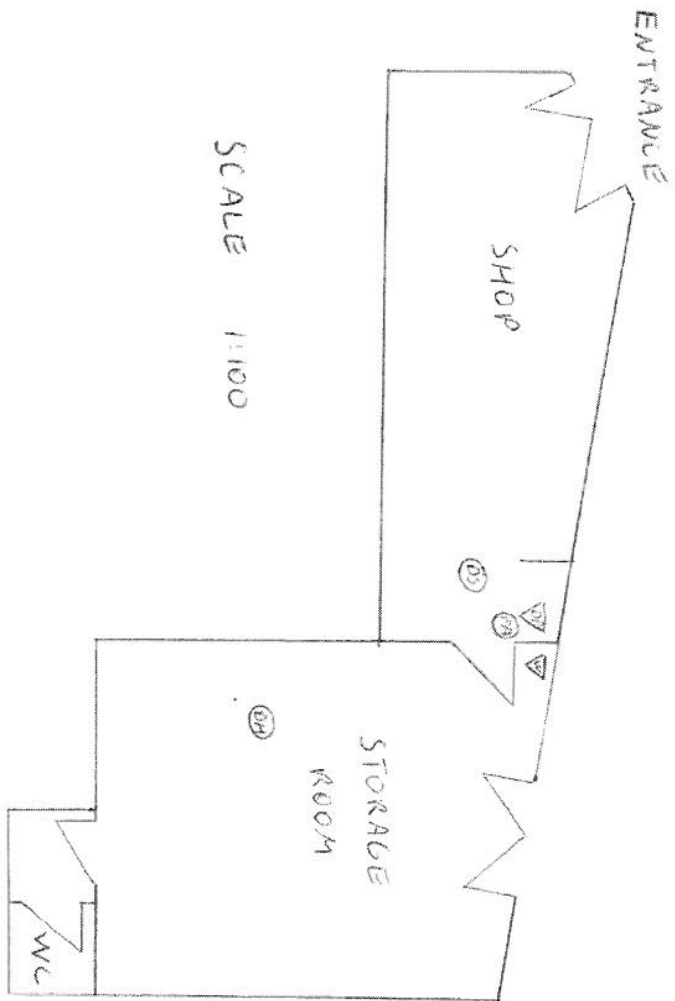
