## **APPOINTMENT TO SHARED ASSISTANT DIRECTOR IT AND DIGITAL SERVICES**

### **1. ORIGIN OF REPORT**

- 1.1 This report is submitted to the Committee following the need to recruit on a permanent basis to the post of Shared Assistant Director IT and Digital Services between Peterborough City Council and Cambridgeshire County Council.
- 1.2 The exempt annex to this report contains the information required by Employment Committee to determine the appointment.

### **2. PURPOSE AND REASON FOR REPORT**

- 2.1 From an initial recruitment and selection process undertaken by the Shared Chief Executive and the Shared Director Digital and Customer Services, Employment Committee are requested to interview and consider a recommendation to appoint to the role of Shared Assistant Director IT and Digital Services.
- 2.2 This report is for the Committee to consider under its Terms of Reference:
  - part 4 Delegations, section 9 clause 5.1: “the Employment Committee will approve the appointment of Chief Officers and Deputy Chief Officers provided that the Committee includes at least one Cabinet Member.”
  - part 3 Delegations, section 2.3.2.6: “to promote and pursue a policy of equal opportunities in employment.”

### **3. REASONS FOR EXEMPTION**

- 3.1 The attached report is NOT FOR PUBLICATION in accordance with paragraph 1, 2 and 4 of Schedule 12A of Part 1 of the Local Government Act 1972 in that it contains information relating to an individual, information which is likely to reveal the identity of an individual and information relating to contemplated consultations or negotiations in connection with a labour relations matter arising between the authority and employees or office holders of the authority. The public interest test has been applied to the information contained within the exempt report and it is considered that the need to retain the information as exempt outweighs the public interest in disclosing it.
