Guidance

This report gives the recommendation made by the Cambridgeshire Police and Crime Panel in accordance with Schedule 1 of the Police Reform and Social Responsibility Act 2011. Its purpose is to outline the Panel's recommendation following a review of the proposal made by the Acting Police and Crime Commissioner to appoint Jim Haylett to the position of Chief Executive.

Hearing

On 10 March 2021 the Cambridgeshire Police and Crime Panel reviewed a notice from the Acting Police and Crime Commissioner to confirm the appointment of Jim Haylett to the position of Chief Executive.

During the hearing, which included an interview with the candidate, the Panel had regard to the information submitted about the candidate, the criteria used to assess the suitability of the candidate for the appointment and the terms and conditions on which the candidate was to be appointed.

Decision

In accordance with the Police Reform and Social Responsibility Act 2011 and following consideration of the information submitted to it, the Panel recommended that the candidate is accepted for the position.

Reasons for the decision

The Panel determined that the candidate clearly demonstrated that he has the relevant professional competence, experience and personal independence needed to carry out the role. The Panel was impressed by the candidate's performance at the hearing and had no reservations on account of his abilities or attitude.
