1. PURPOSE OF REPORT

1.1 To consider and determine this application for a <u>new</u> premises licence for Mixology, Under the Orton Mere Parkway Bridge, Nene Park, Peterborough, taking into account the representations against and for the application that have been received.

2. BACKGROUND INFORMATION

- 2.1 There has been no previous premises licence granted for this premises area.
- 2.2 The premises does <u>not</u> fall within the 'Operation Can Do' area and is therefore <u>not</u> subject to the provisions of the special 'cumulative impact' policy.

4. APPLICATION

- 4.1 Please refer to the application attached at **Appendix B Page 13**
- 4.2 Representations, both against and in favour of the application being granted have been received. These representations are attached at **Appendix C on Page 37**.
- 4.3 Part P of the application sets out the applicant's proposed conditions under the licensing objectives, these being, 'The Prevention of Public Nuisance', 'Public Safety', 'Prevention of Crime and Disorder' and 'The Protection of Children from Harm'. These are also contained within the body of this report (in section 7) and in accordance with section 10.5 of Guidance have been interpreted into enforceable conditions. Only those appropriate and proportionate for the promotion of the licensing objectives have been included in the Operating Schedule.
- 4.5 No representations have been received from any of the Responsible Authorities. Cambridgeshire Constabulary, Peterborough Trading Standards, Cambridgeshire Fire and Rescue Service, Licensing Authority, Peterborough City Council Planning Department, Peterborough City Council Health & Safety Department, Public Health, Peterborough City Council Environmental Pollution Team, or Children's Services.
- 4.6 A 'Notice' was displayed in the newspaper in accordance with Part 4 No. 25 of Statutory Instruments 2005 No. 42 The licensing Act 2003 (Premises Licences and Club Premises Certificates) Regulations 2005.

5. REPRESENTATIONS

- 5.1 Summary of issues raised in the representations against the application being granted:
 - Increase in both vehicle and pedestrian movements near to and to or from the premises
 - Premises is near to a river and therefore potential for accidents to occur if people access the water.
 - Increase in disturbance and noise pollution for local residents from the premises
 - Increase in anti-social behaviour, fuelled by alcohol, from customers of the premises.
 - The number of events that could take place at the premises due to the 7 days a week licence request.
 - Premises would be near to a conservation area within Nene Park.
 - Potential for overcrowding from persons attending the vicinity of the premises without a ticket.
 - Concerns re accessibility of premises for emergency services vehicles
- 5.2 Summary of matters raised from the representations in favour of the application being granted :
 - The initial event ('Under') will finish at 10pm so will not be a late night event
 - The initial event would be something that people would look forward to attending after
 18 months of restrictions during the pandemic
 - There is a relatively low chance of disturbance to local residents owing to the location of the premises.
 - The initial event will be professionally managed by a reputable established company
 who will put in place comprehensive measures to mitigate concerns re disturbance,
 anti-social behaviour and customers safety.
 - The initial event would promote cultural diversity within Peterborough and put the City 'on the map' as a leading arts & music area.
- 5.3 Members should note that the correspondence attached against the application are in their entirety. The correspondence in favour of the application being granted have been placed together and in their entirety on a separate sheet. Please note that not all matters raised within the representations are relevant matters for consideration under the Licensing Act 2003. It is up to the Committee to decide upon what 'weight' they attach to these matters.

6. MEDIATION

6.1 As a number of the representations against the application being granted are requesting refusal of the granting of the licence, mediation was not a reasonably viable option.

7. APPLICANT'S PROPOSED CONDITIONS UNDER THE LICENSING OBJECTIVES:

7.1 Crime and disorder

The premises shall install and maintain a comprehensive digital colour CCTV system when licensable activities take place and for a minimum of 2 hours after any event has ended. All public areas of the licensed premises, including all public entry and exit points, and the street environment will be covered, enabling facial identification of every person entering in any light condition. The CCTV cameras shall continually record while the premises are open to the public and recording shall be kept available and unedited for a minimum of 28 days with the date and time stamping. A staff member who is conversant with the operation of the CCTV system shall be present on the premises at all times when they are open to the public and must be able to produce/download/ burn CCTV images upon request by a police officer or an authorised officer of the licensing authority. Any footage must be in a format that can be played back on a standard personal computer or standard DVD player. Where the recording is on a removable medium (ie. compact disc, flash card etc), a secure storage system to store those recording mediums shall be provided

The premises licence holder will ensure that the digital CCTV system is fully compliant with the guidance contained in the Information Commissioner's Office (ICO) guidance document (www.informationcommissioner.gov.uk) regarding installation of CCTV is provided at the premises.

The premises licence holder shall ensure that the provision of door supervisors at the premises is appropriate to ensure the safe control of the premises, and shall review this on a regular basis and / or prior to an event taking place via a suitable risk assessment and upon request from the Police and/or the Licensing Authority.

All door supervisor staff engaged outside the entrance to the premises, or supervising or controlling queues, shall wear high-visibility jackets or vests.

All door supervisors sited at the access and egress to the premises should be in possession & operate a body worn camera when licensable activities take place

A minimum of 2 Security Industry Authority SIA-licensed door supervisors shall be on duty at every access / egress to the premises at all times while it is open for business

Where the holder of the premises licence employs security personal to carry out a security activity they must be licensed by the Security Industry Authority (SIA) A risk assessment must be carried out to determine the levels of security personal to be on site when the public are in. The Risk Assessment will take into consideration advice from the Purple Guidance in respect to minimal SIA Door Supervisors

A minimum of 2 female door supervisor(s) shall be on duty at the premises at such times as door supervisors are required to be provided where the audience is expected to be in excess of 1000.

An incident log (which may be electronically recorded) shall be kept at the premises for at least six months, and made available on request to the police or an authorised officer of the licensing authority, which will record the following incidents including pertinent details:

- (a) all crimes reported to the venue, or by the venue to the police
- (b) all ejections of patrons
- (c) any complaints received
- (d) Any incidents of disorder

- (f) any faults in the CCTV system, searching equipment or scanning equipment
- (g) any refusal of the sale of alcohol
- (h) any faults in the CCTV system, searching equipment or scanning equipment
- (i) any visit by a relevant authority or emergency service
- (j) the times on duty, names and the licence numbers of all licensed door supervisors employed by the premises.

The premises licence holder and/or DPS shall carry out a documented risk assessment on the need for searching patrons entering the premises. The risk assessment shall be reviewed regularly and no less than every six months.

A clearly visible notice shall be placed at each entrance to the premises advising those attending that it is a condition of entry that customers agree to being searched and that the police will be informed if anyone is found in possession of controlled substances or weapons.

There shall be a policy agreed with Cambridgeshire Constabulary for the premises relating to illegal drugs, weapons or other prohibited items found on persons attempting to enter or on the premises.

28 days' notice shall be given to Cambridgeshire Constabulary and the Licensing Authority of any events held that are organised by an external promoter, including full details of the nature of the event and of the promoter with an anticipated audience of 500 or more persons.

Alcohol is to be served in polycarbonate, plastic or shatterproof glasses. Alcohol and soft drinks may also be served in cans provided that the can is opened by bar staff prior to handing to customer. Alcohol served in any VIP area / Artist dressing or 'green' room may be served in glass subject to a suitable risk assessment being completed by the licence holder

7.2 **Prevention of Public Nuisance**

The number of large music events that may be held shall be restricted to 12 concert days per calendar year. The following conditions shall be applied for large music events. (Such events are described in the Code of Practice on Environmental Noise Control at Concerts. Events shall be regarded as a large music event where it is reasonable to apply that Code for the control of music. This includes live and pre-recorded music.)

The Licensee shall appoint a suitably qualified and experienced noise control consultant, to the approval of the Licensing Authority. The noise control consultant, shall liaise between all parties including the Licensee, Promoter, sound system supplier, sound engineer and the licensing authority etc. on all matters relating to noise control prior to and during the event.

While live or recorded music takes place, a competent & suitably qualified person shall undertake regular monitoring of noise levels at the nearest noise-sensitive locations. A record shall be kept of any monitoring, including the date, time and location of monitoring; the name of the monitor; and any action taken. Records shall be kept for no less than six months and shall be made available upon request by a police officer or an authorised officer of Peterborough City Council.

A noise propagation test shall be undertaken at least 3 hours prior to the start of the event in order to set appropriate control limits at the sound mixer position. The sound system shall be configured and operated in a similar manner as intended for the event. The sound source used for the test shall be similar in character to the music likely to be produced during the event.

The control limits set at the mixer position shall be adequate to ensure that Music Noise Level (MNL) shall not at any noise sensitive premises exceed the background noise level by more than 15 dB(A) over a 15 minute period throughout the duration of the concert.

The control limits at the mixer position shall be adequate to ensure that the Leq,15min in the 63Hz and 125Hz octave bands shall not at any noise sensitive premises exceed 70dB throughout the duration of the event.

The control limits set at the mixer position shall be adequate to ensure that the MNL shall not at any noise sensitive premises exceed the background noise level by more than 15 dB(A) over a 15 minute period throughout any rehearsal or sound check for the event.

The Licensee shall ensure that the promoter, sound system supplier and all individual sound engineers are informed of the sound control limits and that any instructions from the noise control consultant regarding noise levels shall be implemented.

The appointed noise control consultant shall continually monitor noise levels at the sound mixer position and advise the sound engineer accordingly to ensure that the noise limits are not exceeded. The Licensing Authority shall have access to the results of the noise monitoring at any time.

Music from the event is permitted only between the following hours: 10:00 hrs to 23:00 hrs.

The Licence Holder shall effect full control over traders or other organisations on site where there is any type of amplified music or speech being played. At the request of the Responsible Authority for Environmental Health (Pollution Control) the Event Organiser shall arrange for the volume to be reduced or the playing to cease, or if necessary, the equipment to be confiscated.

The holder of the premises licence shall ensure that noise caused by persons using, arriving at or departing from the premises shall not cause nuisance or unreasonable disturbance to the occupiers of any residential properties

The premises licence holder, or a responsible person nominated by them in writing, shall receive and respond to complaints throughout the duration of all licensable activities. These complaints shall be recorded and the records made available to the local authority upon request. Such records shall be retained for a minimum of 2 years.

Prominent, clear notices shall be displayed at all exits requesting customers and staff to respect the needs of local residents and leave the premises and the area quietly

Litter bins shall be provided at the premises in sufficient capacity to ensure that customers can adequately dispose of any litter.

No unauthorised advertisement of any kind (including placard, poster, sticker, flyer, picture, letter, sign or other mark) shall be inscribed or affixed upon the surface of the highway, or upon any building, structure, works, street furniture, tree, or any other property, or distributed to the public, that advertises or promotes the establishment, its premises, or any of its events, facilities, goods or services.

No inflatable play equipment shall be used without the agreement of the Licensing Authority with respect to its hours of use and other conditions as may be appropriate.

7.3 Protection of children from harm

The 'Challenge 25' initiative to prevent sales of alcohol to persons under 18 years of age will be implemented at the premises and signage will be prominently placed within the premises advertising the fact that the premises operate the 'Challenge 25' initiative.

Documented records of training to prevent underage sales shall be completed & shall be kept for each member of staff. Training shall be regularly refreshed and at no greater than 12 monthly intervals. Training records shall be made available for inspection upon request by a police officer or an authorised officer of the Licensing Authority.

7.4 Public Safety

A fire risk assessment required under the Regulatory Reform (Fire Safety) Order 2005 (as amended) will be completed and be available for inspection by an authorised officer.

If it is proposed to play music (other than background music) a suitable cut out device, wired into the fire alarm system, should be installed so that in the event of the fire alarm sounding the music will be automatically shut down. This system must be tested prior to any event taking place.

Valid public liability insurance shall be kept in force and a copy of the schedule will be displayed at the venue and made available for inspection by an authorised Local Authority or Police Officer on request.

9. LICENSING OFFICER'S COMMENT (FOR INFORMATION)

9.1 Regulation 19(a) requires authorities to disregard any information given by a party or person that is "not relevant" to the application.

10. LEGAL OFFICER'S COMMENTS

- 10.1 The Licensing Authority (hereafter referred to as "the Council) is charged with implementing the provisions of the Licensing Act 2003. This is an application for a new licence made under Section 17 of the Licensing Act.
- 10.2 In this case, the application was received at these offices on 11 June 2021.
- 10.3 The application before this Committee will be treated on its own merits, and the Licensing committee will make its decision based upon:
 - The merits of the application;
 - The promotion of the four licensing objectives;
 - The statement of policy of the Licensing Authority; and
 - The Guidance issued by the Secretary of State for Culture, Media and Sport under section 182 of the Licensing Act 2003 – April 2018.
- 10.4 The licensing authority may determine the application, depending upon what is appropriate for the promotion of the licensing objectives, in any of the following ways:
 - Decide to grant the licence in the same terms as it was applied for:
 - Decide to grant the licence, but to modify or add conditions (to promote the licensing objectives);

- Exclude from the scope of the licence a licensable activity; and Decide to refuse to grant the licence.
- Conditions are modified if they are altered, omitted or any new condition added (Section 35(4) 10.5 Licensing Act 2003.

APPENDIX A LICENSING ACT 2003 GLOSSARY OF TERMS

Note: In this document, the following definitions are included to provide an explanation of certain terms included in the Act. In some cases they are an abbreviation of what is stated in the Licensing Act 2003 or an interpretation of those terms. For a full definition of the terms used, the reader must refer to the Licensing Act 2003.

'Child'

- (a) means an individual aged under 16
- (b) a child is unaccompanied if he is not in the company of an individual aged 18 years or over

DCMS: Department for Culture Media and Sport

'Designated Premises Supervisor' means the person (who must be a Personal Licence Holder), in the case of premises selling alcohol, who will normally have been given the day to day responsibility for running the premises by the holder of the Premises Licence or will be the Premises Licence holder.

'Other Persons':

 persons who live, or are involved in a business, in the relevant licensing Authorities area and who are likely to be affected by the application and are not a Responsible Authority.

'Late Night Refreshment' means the supply of hot food or hot drink to members of the public (whether for consumption on or off the premises) between the hours of 11.00 pm and 5.00 am.

'Licensable Activities' means: -

- The sale by retail of alcohol
- The supply of alcohol by or on behalf of a club to, or to the order of, a member of the club
- The provision of Regulated Entertainment
- The provision of Late Night Refreshment

'Licensing Authority': - is the licensing function of Peterborough City Council

'Licensed Premises' includes club premises and events unless the context otherwise requires.

'Licensing Objectives'

- The prevention of crime and disorder
- Public safety
- The prevention of public nuisance
- The protection of children from harm

'Operating Schedule' means a document containing a statement of the following matters (and any others that may be prescribed): -

- The relevant Licensable Activities
- The times at which the Licensable Activities are to take place and any other times when premises are open to the public
- Information regarding the person who will be specified in the Premises Licence as the Premises Supervisor
- Where the Licensable Activities involve the supply of alcohol, whether it is for the supply on and/or off the premises
- The steps being taken to promote the Licensing Objectives

'Challenge 25' means that a retailer will ask for proof of identification if they have reason to believe that the person making a purchase of alcohol is under the age of 25.

'Rateable Value': as regards a premises, is the value for the time being in force for the premises entered in the local non-domestic rating list for the purposes of Part III of the Local Government Finance Act 1988(b).

'Regulated Entertainment' (Schedule 1 of the Act) means: -

- A performance of a play
- An exhibition of a film
- An indoor sporting event
- A boxing or wrestling entertainment
- A performance of live music
- Any playing of recorded music
- A performance of dance

Except where there is an exemption under the Live Music Act 2012 or Statutory Instrument 2013 No. 1578 The Licensing Act 2003 (Descriptions of Entertainment) (Amendment) Order 2013

Or entertainment of a similar description falling within the last three of the categories listed above, where the entertainment takes place in the presence of and for the purposes of entertaining that audience or spectators.

'Relevant Licensing Authority': is the Authority in the area the premises are situated.

'Responsible Authority' means any of the following: -

- Cambridgeshire Constabulary (The Chief Officer of Police)
- Cambridgeshire Fire and Rescue (The Fire Authority)
- Health and Safety Team, Peterborough City Council
- Planning authority, Peterborough City Council
- Trading Standards, Peterborough City Council
- Environmental Health Pollution, Peterborough City Council
- Children's' Services Child Protection & Review Manager
- Primary Care Trust or Local Health Board (Director of Public Health)
- The Relevant Licensing Authority, Peterborough City Council
- Maritime & Coastguard Agency, Walton on Naze. (For vessels carrying more than 12 passengers.)
- Environment Agency, Peterborough (For vessels carrying 12 or less passengers).

'Supply of alcohol':

- the sale by retail of alcohol, or
- the supply of alcohol by or on behalf of a club to, or to the order of, a member of the club.

'Temporary Event Notice' means a Permitted Temporary Activity involving one or more Licensable Activities subject to the following various conditions and limitations: -

- Duration they are limited to events lasting for up to 168 hours (7 days);
- Scale they cannot involve the presence of more than 499 people at any one time;
- Use of the same premises the same premises cannot be used on more than 12 occasions in a calendar year, but are subject to the overall aggregate of 21 days irrespective of the number of occasions on which they have been used; and
- The number of notices given by an individual within a given period of time a Personal Licence Holder is limited to 50 notices in one year and another person to 5 notices in a similar period.

(In any other circumstances, a full Premises Licence or Club Premises Certificate will be required for the period of the event).

'the Act': means the Licensing Act 2003

b) The prevention of crime and disorder

The premises shall install and maintain a comprehensive digital colour CCTV system when licensable activities take place and for a minimum of 2 hours after any event has ended. All public areas of the licensed premises, including all public entry and exit points, and the street environment will be covered, enabling facial identification of every person entering in any light condition. The CCTV cameras shall continually record while the premises are open to the public and recording shall be kept available and unedited for a minimum of 28 days with the date and time stamping. A staff member who is conversant with the operation of the CCTV system shall be present on the premises at all times when they are open to the public and must be able to produce/download/ burn CCTV images upon request by a police officer or an authorised officer of the licensing authority. Any footage must be in a format that can be played back on a standard personal computer or standard DVD player. Where the recording is on a removable medium (ie. compact disc, flash card etc), a secure storage system to store those recording mediums shall be provided.

The premises licence holder will ensure that the digital CCTV system is fully compliant with the guidance contained in the Information Commissioner's Office (ICO) guidance document (www.informationcommissioner.gov.uk) regarding installation of CCTV is provided at the premises.

The premises licence holder shall ensure that the provision of door supervisors at the premises is appropriate to ensure the safe control of the premises, and shall review this on a regular basis and / or prior to an event taking place via a suitable risk assessment and upon request from the Police and/or the Licensing Authority.

All door supervisor staff engaged outside the entrance to the premises, or supervising or controlling queues, shall wear high-visibility jackets or vests.

All door supervisors sited at the access and egress to the premises should be in possession & operate a body worn camera when licensable activities take place

A minimum of 2 Security Industry Authority SIA-licensed door supervisors shall be on duty at every access / egress to the premises at all times while it is open for business

Where the holder of the premises licence employs security personal to carry out a security activity they must be licensed by the Security Industry Authority (SIA) A risk assessment must be carried out to determine the levels of security personal to be on site when the public are in. The Risk Assessment will take into consideration advice from the Purple Guidance in respect to minimal SIA Door Supervisors

A minimum of 2 female door supervisor(s) shall be on duty at the premises at such times as door supervisors are required to be provided where the audience is expected to be in excess of 1000.

An incident log (which may be electronically recorded) shall be kept at the premises for at least six months, and made available on request to the police or an authorised officer of the licensing authority, which will record the following incidents including pertinent details:

- (a) all crimes reported to the venue, or by the venue to the police
- (b) all ejections of patrons
- (c) any complaints received
- (d) any incidents of disorder
- (e) seizures of drugs, offensive weapons, fraudulent ID or other items
- (f) any faults in the CCTV system, searching equipment or scanning equipment
- (g) any refusal of the sale of alcohol
- (h) any faults in the CCTV system, searching equipment or scanning equipment

- (i) any visit by a relevant authority or emergency service
- (j) the times on duty, names and the licence numbers of all licensed door supervisors employed by the premises.

The premises licence holder and/or DPS shall carry out a documented risk assessment on the need for searching patrons entering the premises. The risk assessment shall be reviewed regularly and no less than every six months.

A clearly visible notice shall be placed at each entrance to the premises advising those attending that it is a condition of entry that customers agree to being searched and that the police will be informed if anyone is found in possession of controlled substances or weapons.

There shall be a policy agreed with Cambridgeshire Constabulary for the premises relating to illegal drugs, weapons or other prohibited items found on persons attempting to enter or on the premises.

28 days' notice shall be given to Cambridgeshire Constabulary and the Licensing Authority of any events held that are organised by an external promoter, including full details of the nature of the event and of the promoter with an anticipated audience of 500 or more persons.

Alcohol is to be served in polycarbonate, plastic or shatterproof glasses. Alcohol and soft drinks may also be served in cans provided that the can is opened by bar staff prior to handing to customer. Alcohol served in any VIP area / Artist dressing or 'green' room may be served in glass subject to a suitable risk assessment being completed by the licence holder.

c) Public safety

A fire risk assessment required under the Regulatory Reform (Fire Safety) Order 2005 (as amended) will be completed and be available for inspection by an authorised officer.

If it is proposed to play music (other than background music) a suitable cut out device, wired into the fire alarm system, should be installed so that in the event of the fire alarm sounding the music will be automatically shut down. This system must be tested prior to any event taking place.

Valid public liability insurance shall be kept in force and a copy of the schedule will be displayed at the venue and made available for inspection by an authorised Local Authority or Police Officer on request.

d) The prevention of public nuisance

No noise shall emanate from the premises nor vibration be transmitted through the structure of the premises that gives rise to a nuisance

The holder of the premises licence shall ensure that noise caused by persons using, arriving at or departing from the premises shall not cause nuisance or unreasonable disturbance to the occupiers of any residential properties

The holder of the premises licence shall ensure that no music or amplified speech originating from the premises shall be audible inside any residential property at any time Note: For the purposes of this condition noise may be considered inaudible when it is at a low enough level that it is not recognisable as emanating from the source in question and/or it does not alter the perception of the ambient noise environment that would prevail in the absence of the source in question.

The premises licence holder, or a responsible person nominated by them in writing, shall receive and respond to complaints throughout the duration of all licensable activities. These complaints shall be recorded and the records made available to

the local authority upon request. Such records shall be retained for a minimum of 2 years.

Prominent, clear notices shall be displayed at all exits requesting customers and staff to respect the needs of local residents and leave the premises and the area quietly

While live or recorded music takes place, a competent & suitably qualified person person shall undertake regular monitoring of noise levels at the nearest noise-sensitive locations. A record shall be kept of any monitoring, including the date, time and location of monitoring; the name of the monitor; and any action taken. Records shall be kept for no less than six months and shall be made available upon request by a police officer or an authorised officer of Peterborough City Council.

Litter bins shall be provided at the premises in sufficient capacity to ensure that customers can adequately dispose of any litter.

No unauthorised advertisement of any kind (including placard, poster, sticker, flyer, picture, letter, sign or other mark) shall be inscribed or affixed upon the surface of the highway, or upon any building, structure, works, street furniture, tree, or any other property, or distributed to the public, that advertises or promotes the establishment, its premises, or any of its events, facilities, goods or services.

No inflatable play equipment shall be used without the agreement of the Licensing Authority with respect to its hours of use and other conditions as may be appropriate.

e) The protection of children from harm

The 'Challenge 25' initiative to prevent sales of alcohol to persons under 18 years of age will be implemented at the premises & signage will be prominently placed within the premises advertising the fact that the premises operate the 'Challenge 25' initiative

Documented records of training to prevent underage sales shall be completed & shall be kept for each member of staff. Training shall be regularly refreshed and at no greater than 12 monthly intervals. Training records shall be made available for inspection upon request by a police officer or an authorised officer of the Licensing Authority.

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this in one of two ways: 1) by providing with this application copies or scanned copies of the documents listed below (which do not need to be certified), or 2) by providing their 'share code' to enable the licensing authority to carry out a check using the Home Office online right to work checking service (see below).

Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is A British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A **current** Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, **when produced in combination with** an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in
 combination with an official document giving the person's permanent National Insurance number and their
 name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an
 official document giving the person's permanent National Insurance number and their name issued by a
 Government agency or a previous employer.

- A current passport endorsed to show that the holder is allowed to stay in the UK and is currently allowed to
 work and is not subject to a condition preventing the holder from doing work relating to the carrying on of a
 licensable activity.
- A **current** Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder which indicates that the named person can currently stay in the UK and is allowed to work relation to the carrying on of a licensable activity.
- A **current** Residence Card issued by the Home Office to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights or residence.
- A current Immigration Status Document containing a photograph issued by the Home Office to the holder
 with an endorsement indicating that the named person may stay in the UK, and is allowed to work and is not
 subject to a condition preventing the holder from doing work relating to the carrying on of a licensable activity
 when produced in combination with an official document giving the person's permanent National Insurance
 number and their name issued by a Government agency or a previous employer.
- A Certificate of Application, **less than 6 months old**, issued by the Home Office under regulation 18(3) or 20(2) of the Immigration (European Economic Area) Regulations 2016, to a person who is not a national of a European Economic Area state or Switzerland but who is a family member of such a national or who has derivative rights of residence.
- Reasonable evidence that the person has an outstanding application to vary their permission to be in the UK
 with the Home Office such as the Home Office acknowledgement letter or proof of postage evidence, or
 reasonable evidence that the person has an appeal or administrative review pending on an immigration
 decision, such as an appeal or administrative review reference number.
- Reasonable evidence that a person who is not a national of a European Economic Area state or Switzerland but
 who is a family member of such a national or who has derivative rights of residence in exercising treaty rights in
 the UK including:-
 - evidence of the applicant's own identity such as a passport,
 - evidence of their relationship with the European Economic Area family member e.g. a marriage certificate, civil partnership certificate or birth certificate, and
 - evidence that the European Economic Area national has a right of permanent residence in the UK or is one of the following if they have been in the UK for more than 3 months:
 - (i) working e.g. employment contract, wage slips, letter from the employer,
 - (ii) self-employed e.g. contracts, invoices, or audited accounts with a bank,
 - (iii) studying e.g. letter from the school, college or university and evidence of sufficient funds; or
 - (iv) self-sufficient e.g. bank statements.

Family members of European Economic Area nationals who are studying or financially independent must also provide evidence that the European Economic Area national and any family members hold comprehensive sickness insurance in the UK. This can include a private medical insurance policy, an EHIC card or an S1, S2 or S3 form.

Original documents must not be sent to licensing authorities. If the document copied is a passport, a copy of the following pages should be provided:-

- (i) any page containing the holder's personal details including nationality;
- (ii) any page containing the holder's photograph;
- (iii) any page containing the holder's signature;
- (iv) any page containing the date of expiry; and
- (v) any page containing information indicating the holder has permission to enter or remain in the UK and is permitted to work.

If the document is not a passport, a copy of the whole document should be provided.

Your right to work will be checked as part of your licensing application and this could involve us checking your immigration status with the Home Office. We may otherwise share information with the Home Office. Your licence application will not be determined until you have complied with this guidance.

Home Office online right to work checking service

As an alternative to providing a copy of the documents listed above, applicants may demonstrate their right to work by allowing the licensing authority to carry out a check with the Home Office online right to work checking service.

- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman
 wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not
 exceed 1000. Combined fighting sports defined as a contest, exhibition or display which combines boxing or
 wrestling with one or more martial arts are licensable as a boxing or wrestling entertainment rather than an
 indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:

 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.

Dear Mr Dolby

I am writing to you as a very concerned resident of The Village, Orton Longueville regarding the mixology event at Orton Mere on 14 August. I am very unhappy to read of this event & I outline my objections below:

- 1. The venue is totally unsuitable being located next to the River Nene and the locks which have in the past claimed people's lives due to the strong current. There is also the rowing lake and the water area in Orton Mere on the right hand side which needs to be considered in the health and safety aspect. If 5000 do attend this event where will they be as the area is not large enough, they will have access to alcohol, open water which spells disaster to me. This is a huge health and safety issue.
- 2. The on line Licensing application is very open, rather vague and lacks clarity. It appears to have been directly taken from a previous

application involving different premises and has not even been adjusted to meet the needs of the new venue.

- 3. The application is open ended and not just for one single event. The application is for events on any day of the week from 10.00am to 11.00pm and 2.00am for New Years Eve. Such events are surely unacceptable in an area which is close to residential areas, main roads and schools (family orientated). Also one of the houses along Oundle Road next to the bus stop is for special needs adults which I feel would be very unnerving to for the residents if these events take place.
- 4. It is suggested that just under 5000 tickets are available and Mixology's own Facebook page shows that a some ticket options are sold out. Attendees in such numbers will create problems for access (which is not stated on the application), road safety, parking, congestion and the emergency services may struggle to gain access to the event if required.
- 5. These events will create a huge amount of noise pollution for local residents and the area is not suited for these type of events. Under the bridge will create an echo effect which could be detrimental to drivers who drive over the bridge during the event.
- 6. Have the organisers have given any consideration to the footpaths that are frequently used during the day by families, walkers, runners, cyclists, dog walkers, etc. Surely these will become damaged, unsafe and inaccessible. The area is prone to flooding therefore the amount of attendees would ruin these public footpaths.

7. Have the organisers considered the wildlife and vegetation which will be damaged to the number of attendees and the amount of rubbish left behind.

- 8. The open nature of the application and the type of the event sets a unwelcomed precedent and further destruction of the area.
- 9. The application does not provide sufficient detail into the facilities that will be needed such as toilets and parking (cars will inevitably park along local roads, causing congestion and general annoyance) as well as safety measures.
- 10. This application, and any subsequent ones, has not given proper thought to the local community nor to the Nene Park area. It will cause unwanted damage to the brilliant park that we are fortunate to have access to and would undoubtedly lead to an increase of police presence in the area. The use of alcohol by such a large number of people (and any other illegal substances) cannot be adequately mitigated at this venue, and will cause a decline in the Park which would be a shame consider how much investment has been put into the area by charitable organisations and the local council.
- 11. Given that there are plenty of other areas in the City where this event has be safely held, without causing any nuisance to the local community, it seems nonsensical to hold this obnoxious event along the Nene River.

To conclude, if these events were allowed to be held at Orton Mere we would see a decline in the area and discomfort for the local area - it will ruin the Park which we have all invested in and enjoyed for many years. I ask you to think about the local community, your responsibility to the area and its investments, and most importantly to the environment.

Section D: Your concerns

Please summarise your concerns about this application:

The general application – especially details about the following issues – has clearly been copied from another location and such does not take into account many of the arguments against the event – the most obvious and important being that the event is adjacent to a fast-flowing river! The application therefore is not fit for purpose and should be rejected. Further to this obvious oversight, the event will cause unwanted damage to the local area and community – which I have already outlined to the local council, in an email to Darren Dolby. (Attack)

Crime and Disorder:

- 1. The application mentions the usage of CCTV. Given that this is an outdoor event, with no buildings nearby and no obvious electricity points how will CCTV be operated? If the answer is to use a generator this is clearly unsafe and will lead to corrupt footage. It will also be very difficult to light the area and thus CCTV will not be of any use anyway.
- 2. Given that accessibility is an issue, how will police be able to respond to any incidents along the river. This is clearly an oversight in the application and could lead to destructive crime to attendees at the events and also to the local community.
- 3. Given that very close to the site there is a 'life skills house' for people with learning difficulties, the obnoxious noise created by the event will cause undue distress to the residents. This has not been accounted for in the application.
- 4. Noise pollution from the event will be astronomical and has not been mitigated against. The application makes reference to enclosing the noise given that this is under a bridge how will they safely go about this? Cramming 5,000 people into an area that is roughly 250m² is unsafe to say the least. This noise will cause major disruption to the local community.

Public Safety:

- Further to the obvious lack of preparation for crime at the event, the application makes no
 effort to prepare for any health emergencies that may occur. The aforementioned lack of
 access will mean ambulances and paramedics will be unable to reach people intime if any
 incident occurred.
- 2. Given that the event is along a fast-flowing river and lock-system, the application makes no mention of this (as it has clearly been repurposed without any thought). There is a clear risk of drowning at the event that will go into the night and hence darkness where alcohol (and probably other illegal substances) will be consumed. The risk of fatal injury is monumental and to allow such an event to occur will be putting the public at risk.
- 3. Fire alarms are mentioned in the application I do not see how these will work in an outdoor environment under a very busy dual carriageway.

Public Nuisance:

- Given that parking is limited at Orton Mere (at most 50 cars) where will the attendees park their cars – this leads me to believe they will use local roads, causing congestion as well as noise when attendees return to their vehicles after the event. Access and parking have clearly been ignored while planning for this event.
- 2. This event (or events due to the open nature of the application) will cause grave harm to the local wildlife and flora. Nene Park is a brilliant nature reserve being built with public money and we should be proud of that. Such an event will see damage to the park, and litter in the

river. Plastic non-biodegradable cups / cans were mentioned - these will end up in the Riv	ver
Nene causing damage to the local ecosystem.	

- 3. Given that the area is next to a river, the meadow is a prone to flooding (it is a flood plain). With 5,000 people along this riverbank, surely the ground will be destroyed by the attendees and when putting in the equipment needed. This is along public footpaths how will they be protected and how will the organisers ensure that they will still be able to be used when the event is going on?
- 4. As the event is proposed to take place underneath a busy dual carriageway, how can the organisers ensure the bright lights and loud music will not cause any dangerous distractions to the drivers above. Surely this will lead to road traffic incidents.
- 5. Along with parking being a major problem for the event, the congestion that will be caused along Oundle Road will be unmanageable given that this is a busy road that services two local schools, how can the organisers mitigate for such disruption? Opposite Orton Mere is the Orton Hall hotel (listed building, and in a conservation area) this will surely be used for parking. Have the hotel / local residents been contacted making them aware of the increase of parked cars along a very narrow road? The local community have not been thought of by the organisers.

Please summarise your concerns about this application:

- 1. The online Licensing Application is very open, rather vague and lacks detail. Moreover, it appears to have been directly 'lifted' from a previous application involving different premises, and has not even been adjusted to 'fit' this new venue.
- 2. The Application is 'enduring' and not just for one single event. It seeks 'permission' for events on any day of the week, from 10am to 11pm, and 2am over New Years Eve/New Year's Day. Such events are surely unacceptable, in an area, which sits so close to residential areas, main roads, and schools.
- 3. The Application also suggests that the event will be under the flyover, and that the 'premises' will be enclosed. In what way, I wonder? We are not being told exactly what, so it is difficult to comment.

Please give further details of why you believe this application will have an adverse effect on the licensing objectives

Public Safety:

- 1. The 'venue' is located next to the River Nene, in close proximity to substantial locks, and a short distance from the open water of the rowing lake. There will be up to 5000 attendees, who will have access to alcohol. Open water, locks and alcohol. This poses significant health and safety issues.
- 2. This event will also set a precedent for other events to follow here. Legally approved or otherwise!
- This area floods!

Prevention of public nuisance:

- 1. The Application suggests that just under 5000 tickets are available and Mixology's own Facebook page suggests that these have already been sold. Attendees in such numbers, will undoubtedly pose problems for access, road safety, parking, traffic congestion and cause significant delays. Nene Valley also operates in this vicinity and can be extremely busy as well.
- 2. The Application also states that 'no noise shall emanate from the premises'.....'that gives rise to nuisance'. I find this really difficult to believe, as it is not within a soundproofed building.
- 3. Large screens, mega lighting, live and recorded music, will undoubtedly cause significant noise and light pollution. Bearing in mind, that this event is directly below a dual carriageway, surely this would impact on road safety above?
- 4.The 'venue' has several footpaths that cross it, namely the Nene Way and the Hereward Way. How will access be maintained to these, if the area is 'fenced off' in some way? This part of Nene Park is used regularly, by walkers, dog walkers, joggers, cyclists, and fishermen, and not just locals.
- 6. There is also the wildlife, flora and fauna to consider and the impact that such a noisy and busy event will have on them.
- 7. This event will also set a precedent for other events to follow here. Legally approved or otherwise!
- 8. Adequate security, toilet facilities, safety measures and the clear up afterwards are also of concern.

It is with dismay that we recently found out about the licence request from Mixology Music Ltd to be able to sell alcohol, present recorded music and films and allow dancing 13 hours a day seven days a week in Orton Mere, right in the heart of the Nene Park. The area where these activities would take place is a tranquil area in which many people enjoy walking, cycling, rowing, and generally enjoying the views, the peace and quiet and the wildlife as well as getting exercise. Those who have no garden, spend time at Orton Mere in order to enjoy the outdoors particularly in the Summer. Even during the day, the noise and interference from such an event would destroy many people's enjoyment and at night the noise would be intrusive to nearby housing, especially as alcohol would be involved.

In addition to the disruption to Peterborough residents' lives, the wildlife itself would be seriously disturbed by such noise including the numerous swans, geese and ducks which populate Orton Mere and which add to the beauty of this wonderful natural park.

Finally, we assume that equipment for an event (electronic, staging etc) would have to be transported in by road. The A605 Oundle Road is already one of the busiest main roads in Peterborough and adding to the toll and traffic queues on it would be a major inconvenience to many residents, not just those who live on the sides of the road.

We cannot conceive why this proposal would be of any possible benefit to Peterborough and would ask the Licensing Committee to completely refuse all aspects of this request.

How to make a representation

The statutory representation period begins the day after a valid application is received by the licensing authority and lasts for 28 consecutive days. During this time there must be at least one public notice in a local paper and a blue A4 public notice displayed on site for 28 consecutive days. The application will also appear on the public register.

Any representations must relate to one of the four licensing objectives below:

Prevention of crime and disorder

This relates to any crime, disorder or anti-social behavior in connection with the management of the premises. The licence holder cannot be responsible for the conduct of individuals once they leave the premises.

Public safety

This relates to the safety of the public on the premises - such as fire safety, lighting and first aid.

The prevention of public nuisance

This can relate to hours of operation, noise and vibration, noxious smells, light pollution and litter.

The protection of children from harm

This relates to protecting children from the activities carried out on the premises whilst they are on the premises. The law already provides special protections for children, such as making it illegal for children under 18 to buy alcohol. We recommend that if you wish to object to an application for a premises licence, you use the representation form.

Representations (objections) may not be made anonymously. Any representations that are received will be included in a report to the hearings panel. This report will be a public document and will be circulated to the parties involved prior to the hearing.



There are a number of points and questions that we would like to raise on behalf of the residents of Orton Waterville ward. Please note that the venue is not in Orton Waterville ward, but is close to its boundary.

Prevention of crime and disorder

- 1. Will there be security at the events to prevent drug use and petty crime?
- 2. There is some unpleasant graffiti at the site, including anti-vax and known local gang symbols. Will these be removed prior to the event? (see photo below)

1. How will the site be accessed? We noticed that the footbridge over the Nene that connects the site to Orton Mere car park is narrow and in need of repair (see photo below):



2. The flyover bridge is leaking water (see photo below):



3. How will disabled people access the site and how will they exit the site safely at the end of the event and if there is an emergency?

4. How will people keep safe near the water, particular if intoxicated? We noticed a number of unofficial paths through the grass lead straight to the water (see photo below):



- 5. There are no litter bins at the site. Will these be made available? How will the organisers prevent the area (including the river) from being polluted by litter?
- 6. The site is frequented by dog walkers and other members of the public. How will the presence of those without tickets be managed?
- 7. Will strobing lights be used and will these affect traffic on the flyover?
- 8. Will there be public toilets and hand washing facilities?

- 1. How far will the noise travel? Will the sound be tested in advance of the event to see how far it carries? A recent event involving motorised boats on this stretch of the river could be heard on Church Drive in Orton Waterville.
- 2. Will drinks be served in biodegradable cups? How else will the sale of food and drink be managed so not to harm the local environment?
- 3. How will the long grasses next to the bridge be protected? Will they be checked for wildlife, such as hedgehogs (see photo below):



- 4. Will plants/weeds be cleared from the site and in what other ways will the surface be made appropriate?
- 5. Rabbits have burrows near the site and birds are nesting under the bridge. How will they be protected?

Please give further details of why you believe this application will have an adverse effect on the licensing objectives

We understand that this application pertains to opening hours and sales of alcohol. However, given the nature of the site, we hope the Licensing Committee will consider the questions that we have posed, all of which seek to ensure that people, wildlife and nature are safe during this event (and afterwards). An event like this has not been held in this location previously and local residents have understandable concerns.

The Nene River can be dangerous. The flyover was not designed as a public event space where alcohol would be sold all day. We are concerned about the safe use of the narrow bridge over the river that is used by cyclists as well as pedestrians. We are also concerned that inebriated people may be unaware of how close they are to the river and may accidentally fall into the water.

We would like to be able to reassure our residents that concerns about noise, public safety and protection of the local natural environment have been taken into consideration by the licensing committee, and that a truly safe event can be guaranteed.

It has been reported in The Peterborough Telegraph that this is an under-utilised area of Nene Park and away from footpaths.

However, this is not the case. There a path running through this area that is a National Cycle Network, 63 The Boathouse Route.

I walk my dog there daily and it is, what I would consider a busy thoroughfare.

When out walking, I share this path with cyclists (going in both directions), other dog walkers, joggers and walkers, anglers going for a peaceful time along the river, river traffic looking to stop off and also children going to and from school. Hardly therefore under-utilised.

I am concerned how this will impact on the many users, as it is reported that it will be a fully-enclosed event.

I am also concerned about the impact on the environment and wildlife, the lack of proper toilet facilities, and potential car parking issues, leading to indiscriminate parking.

Another of my concerns is the noise. I live 2 kilometres from the site and I regularly hear the Nene Valley Railway. There was also noise when the essential piling work was undertaken at that site.

I believe that to grant this licence would not be in the best interests of many people, so am therefore appealing against the application.

The fact that this will garner support from people who not only do not know what the event is but also have no concept of where the location is is ridiculous.

I would like to put forward my objection to the alcohol license. I would like to object to the event itself but as tickets have already gone on sale it would appear it is a done deal. I do however feel very strongly that this event should not be given a license. It is in too close proximity to both the river and the rowing lake and this brings with it a number of inherent dangers of people drinking excessive amounts of alcohol near to water.

The other issue to consider is that on the day in question there will be a large rowing regatta at Peterborough Rowing Lake which is a long established event and always takes place on the same weekend in August. The last thing which is needed is for a lot of people to be getting drunk at this event in close proximity to the regatta which would be a danger to both the attendees at the Mixology event and at the regatta. I have no idea why Nene Park Trust thought it sensible to allow this event to go ahead but they did. I do hope you will do the sensible thing and not grant it a License.


