Additional Information - Council Budget Papers

The budget consultation formally closed on Monday 20 February 2012 which is after the date Full Council papers were published, in order to give people the maximum time to respond. This paper therefore provides Council with the responses received after the Cabinet meeting on Friday 10th February 2012.

A further 14 comments have been made through 7 respondents and these can be found from page two of this document.

In total there were 187 comments made through 48 respondents and consultation events. All responses received during the budget consultation process, and the responses given, can be found within the Full Council documents (pages 206 - 250) and at the end of this document.

Can you give me some more factual detail about what activities are involved and the reason for having to accept such an increase, please	This issue has been responded to directly including the reference to additional information requested. In summary: All of the budget reports published by Cabinet have included details of the pressures in Adult Social care, and how we intend to deal with them. I attach the extract which should provide you with the additional detail you have requested. Nationally, a combination of an increasingly elderly population, and other adults developing more complex needs, is placing significant pressure on adult social care services. Peterborough is no exception to this, and it is clear that in the last year we have experienced significant increases in demand for our services. To give you an example, at the start of the year around 1,500 older people required our support. Within nine months of this financial year, an extra 200 older people needed our support. This pattern is the same across all client groups. The extra money has been spent providing the support that these vulnerable people need. Where this support is needed, the Council has a statutory duty to provide that care. I hope that this response provides the additional information you needed.
