## APPENDIX G

## Summary of Members' Remuneration Allowances

In order to reflect the changes made to the Executive Membership and Neighbourhood Chairmen, the allocation of Special Responsibility Allowances will change accordingly. The table below outlines the revised allowances to be paid taking into account:

- a reduction of one Cabinet Member and an increase of two Cabinet advisors;
- The reduction in the number of Scrutiny Committees in that two have been merged into one; and
- the appointment of seven neighbourhood committee chairmen instead of three - the total of the three basic allowances previously paid $(£ 21,497.85)$ will be shared between the seven new chairmen ( $£ 3,071.12$ ).
