## SCHEDULE OF MINOR (PRE-ADOPTION) ADDITIONAL MODIFICATIONS

The Peterborough Planning Policies DPD has been the subject of an independent examination. The planning inspector who conducted that examination has recommended some main modifications to the submission version of the DPD, which are necessary to make the DPD sound.

Section 23(3) of the Planning and Compulsory Purchase Act 2004 (as amended by the Localism Act 2011) allows the council to make additional modifications which (taken together) do not materially affect the policies of the DPD.

This schedule shows the additional modifications that have been made to the submission version of the DPD. They are included in the version that is now recommended for adoption.

The modifications are largely minor editing and updating of the document. The great majority were discussed and publicised during the examination, and consulted on in August/September 2012. In many instances, modifications to policies and text will require consequential policy/paragraph renumbering and alterations to cross-references, but these are not itemised in this schedule.

The schedule below lists the additional modifications. The first column is the reference number of the modification in **bold**, and if the modification had previously been advertised as a suggested change, the reference number used during the public consultation is shown in brackets below. The modifications are listed in Plan-order. The second column shows the chapter/paragraph/policy of the submission version of the DPD to which the modification applies (and does not take into account any deletion or addition of text arising from the inspector's main modifications that may have resulted in paragraph renumbering). The third and fourth columns show the modification and the reason for it.
