4. OUTCOME OF PETITIONS

4.1 <u>Petitions to retain the 413 bus service and against the suspension of Newborough to</u> Peterborough bus services

These petitions were presented to full Council on 10 July 2013 by Councillor David Harrington. The Council's Transport Officer Accessibility & Sustainability responded stating that Cabinet had met again following a call-in of its decision and a further advisory group meeting involving members of the public and bus users would consider the outcome of the procurement exercise before final contracts for the future service were agreed.

4.2 Petition against the proposed solar and wind farms on the council's farms estate

This petition was presented to full Council on 10 July 2013 by Councillor David Harrington. The Council's Renewable Energy Finance Manager responded stating that although the petition had been accepted and included in public responses, a number of the signatories could not be counted as they were from outside the area and the claims in the petition were

not completely correct i.e. there were no plans for the sale of estate land and only 900, not 3000 acres, of farmland were included in the energy project.

4.3 Two petitions to retain the 407 bus service

These petitions were presented to full Council on 10 July 2013 by Councillor Brian Rush. The Council's Transport Officer Accessibility & Sustainability responded stating that Cabinet had met again following a call-in of its decision and a further advisory group meeting involving members of the public and bus users would consider the outcome of the procurement exercise before final contracts for the future service were agreed.

4.4 Four petitions opposing cuts to the 406 bus service

These petitions were presented to full Council on 10 July 2013 by Councillor John Fox. The Council's Transport Officer Accessibility & Sustainability responded stating that Cabinet had met again following a call-in of its decision and a further advisory group meeting involving members of the public and bus users would consider the outcome of the procurement exercise before final contracts for the future service were agreed.

4.5 <u>Petition requesting the continuation of bus services in Fengate</u>

This petition was presented to full Council on 10 July 2013 by Councillor Marion Todd. The Council's Transport Officer Accessibility & Sustainability responded stating that the council was currently in a procurement exercise to secure new services and Fengate would continue to receive a bus service whether timetabled or demand responsive. Final proposals would be presented to an advisory group before awarding contracts for the future provision of services in Fengate.
