PCSO (collar number & name)

has been designated as by the Chief Constable as a Traffic Warden pursuant to Section 95 & 96 of the Road Traffic Regulation Act 1984 and designated as a Community Support Officer pursuant to Section 38 of the Police Reform Act 2002.

- Require name and address person behaving in anti-social manner
- Require name and address for Road Traffic and fixed penalty offences
- Detain a person for 30 minutes to wait for a PC where a correct name and address is not given or believed to be false
- Stop cycles for relevant cycle offences
- Stopping vehicles for test purposes
- Place traffic signs
- Authorise removal of abandoned vehicles
- Direct traffic for purpose of escorting abnormal loads
- Road Checks Sec 4 PACE 1984 & Sec 163 RTA 1988
- Enforcing cordon areas under the Terrorism Act 2000
- Stop/search vehicles in areas authorised under the Terrorism Act 2000
- Dispersal of people involved in ASB or crime
- Require the surrender of property connected to ASB when issued with a dispersal direction
- Enforce PSPO's
- Issue a community protection notice
- Remove children under 16 to place of residence
- Remove truants to designated place
- Stop consumption/surrender of alcohol in designated place
- Photograph persons away from police station that have been detained, arrested or issued with a TOR / fixed penalty notice
- Deal with ASB by community remedy
- Seize vehicles & give warnings where a vehicle is driven off road or

- dangerously and causing harassment, alarm or distress
- With consent, search for alcohol or tobacco
- Confiscate alcohol and tobacco from children and young people
- Seize and retain controlled drugs
- Whilst lawfully on premises, seize stolen property
- Entry to save life, limb or prevent serious damage
- Enter licensed premises to investigate licensing offences
- Enter relevant premises / inspect documents – Security Industry Authority

Issue Fixed Penalty Notices relating to;

- Cycling on the footway, more than one person on a cycle, failing to comply with a traffic direction, failing to comply with a red light
- Cycling without lights or reflectors
- Failing to stop a cycle for relevant offences
- Failing to stop vehicle for purpose of terrorist roadside checks
- Community protection notices
- Dog Control Orders and dog fouling
- Drivers using a bus or cycle lane, contravening one way direction, opening car door causing danger, excessive noise, use of horn at night or when stationary, failing to switch off an engine
- Graffiti / Fly Posting / Criminal damage / Littering
- Truancy
- Sale, purchase and consumption of alcohol for and by persons under 18
- Behaviour likely to cause harassment /alarm /distress
- Possession and misuse of fireworks
- Breach of a public spaces protection order
- False reports to police and fire services
- Trespass and throwing stones at trains
- Breach of PSPO

- Blue epaulettes embroidered 'Police Community Support Officer' with collar number and name
