I refer to the Cambridgeshire Police and Crime Panel meeting on the 28th January 2015 and the actions arising from the meeting on which the Panel sought my response.

In respect of the Panel's comments about the budget setting process, I have provided the Panel with a paper for their meeting on the 18th March 2015 with an update to Appendix 1 'Finances' of my Police and Crime Plan. The paper also details the process for setting the revenue budget for 2015/16, budget assumptions, medium term financial planning, collaboration, grant funding and other matters relating to budget considerations and thus the setting of the precept.

I hope the Panel are able to review the draft variation of Appendix 1 of my Plan and make a recommendation.

There were a number of questions raised in the meeting on 28th January 2015 relating to domestic abuse. Councillor Sinnott was asked to write to me with a list of questions. As of the date of this letter, Councillor Sinnott has not submitted the questions to me or my Office.

I also note the other comments made by the Panel which have now been captured in the minutes of the meeting. These include requests for detailed information, some of which is captured the budget paper detailed above. Other information is also included below. Where further detail is required we will follow that up in writing now that we have the minutes.

Costs of the 101 service and staff costs – to follow.

Details of the 8% rise in the Office of the Police and Crime Commissioner staffing costs — the staffing budget has been increased by £79,000 to reflect the full cost of staff who came into post during the 2014/15 financial year. These posts reflect the increased responsibility and the widening remit of my role and include the posts of Volunteer Co-ordinator, Southern Outreach Worker and Director of Communications and Engagement, along with increasing the number of hours for the Strategic Advisor, who took on the Victims and Restorative Justice programmes.

Breakdown of the Office of the Police and Crime Commissioner staff including salary and posts - to aid transparency I make information relating to my work and that of my office available on my website. This includes information on the staffing of my office. For ease of reference these are presented in Appendix 1 to this letter.

Victims Hub running costs and staff – Victims' Hub funding for 2015/16 is £446,000. Further details to follow.

Treasury details – to follow.

Capital expenditure – to follow.

In addition, one member separately requested further details regarding the presentation given by Brian Ashton, to the Panel. These are presented in Appendix 2 to this letter.

I hope my response completes the actions the Panel required of me.
