It appears they have set themselves up as street traders, working from the addressess on the same day as the Wellington Street Car Boot Sale. This complaint relates to a a Mrs Malayeka Sultan who resides at 57 Lowick Gardens, who appears to be trading at 5 Field Walk. However there appears to be another trader selling electrical goods from the pavement and garage a few doors away.

The trading has been confirmed by Tony Dalessio (Wellington Street Boot Sale organiser), Justin Beaumont and Darren Bell (Both PCC managers).

Justin Beaumont (see attached e-mails) has visited the location and provided photos showing the trading.

Darren Bell (see attached e-mails) has detailed his CEOs to attend the location and confirm pitches are obstructing the highway and the customers parking is also causing an issue. His team have issued a
