full time.

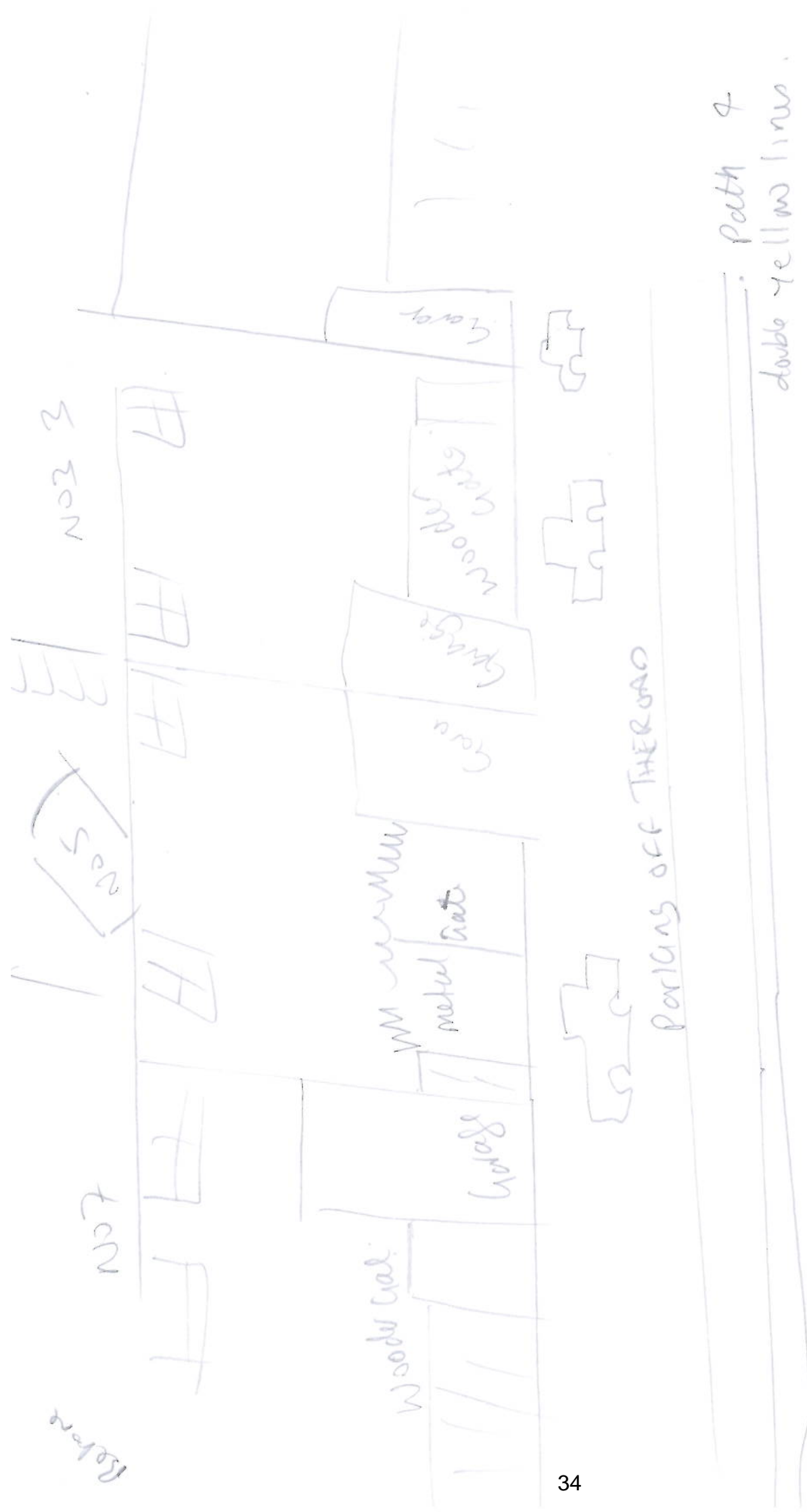

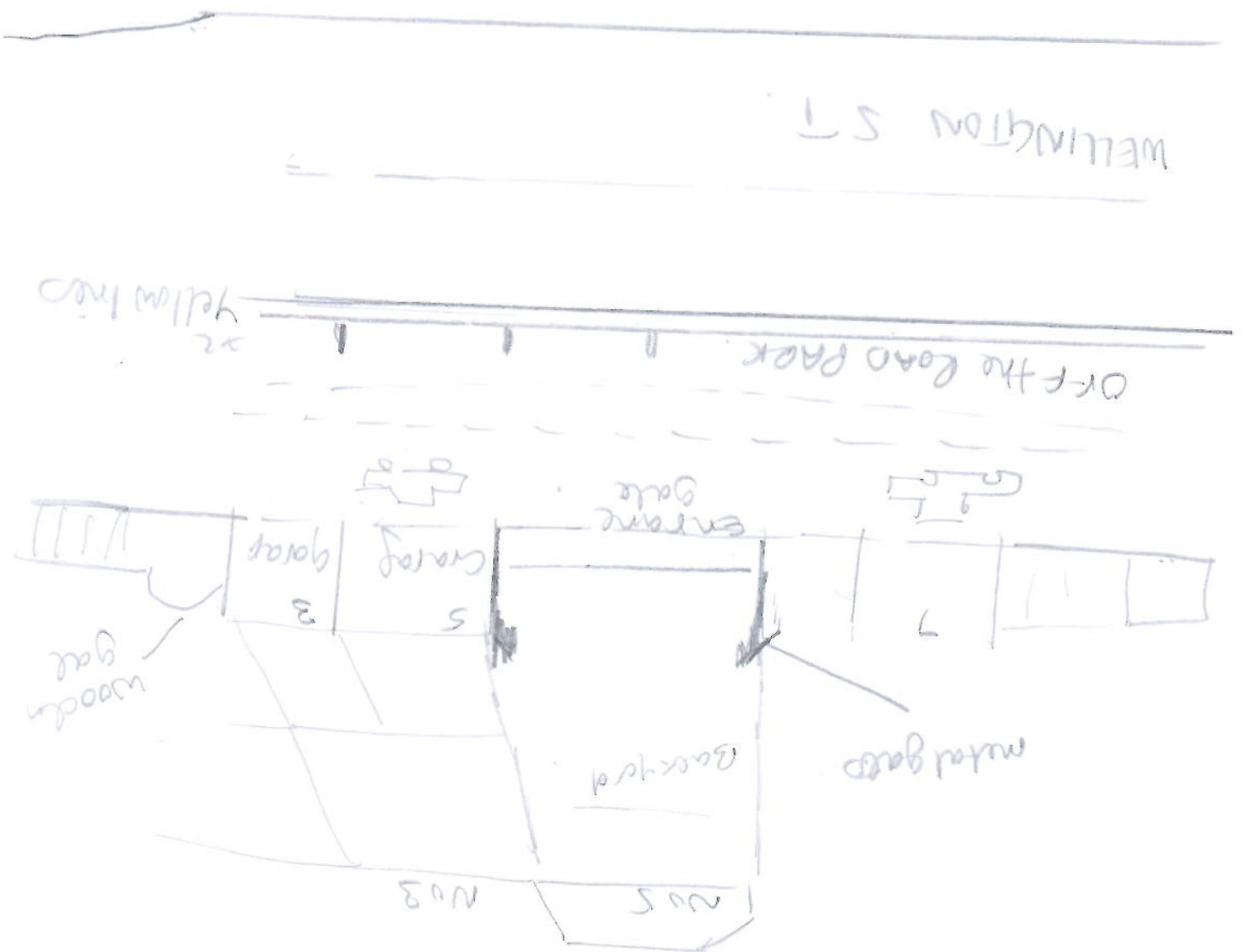

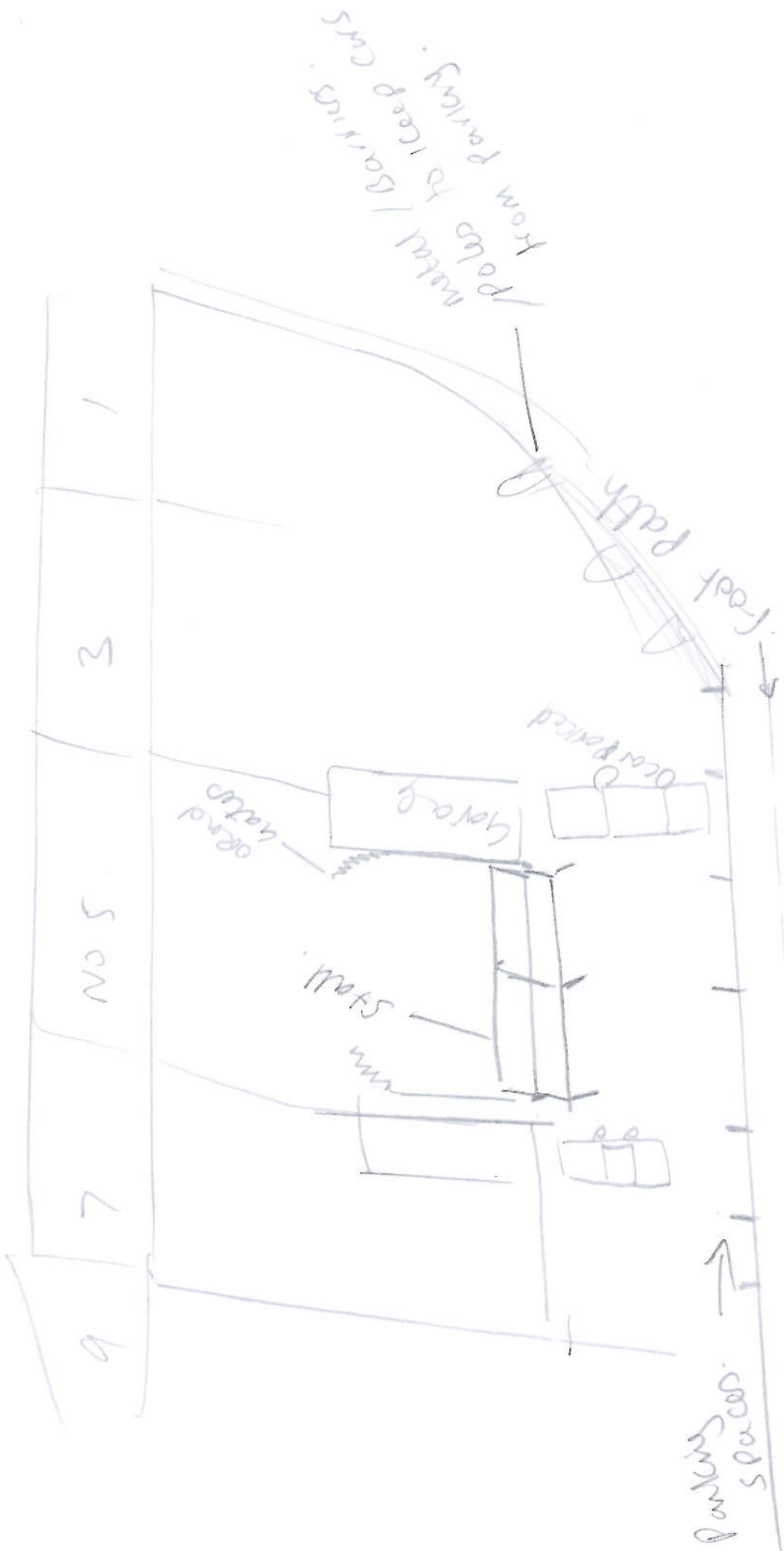
