RECOMMENDATIONS

The Cabinet Member is requested to :

- Authorise the expansion, partial demolition and remodelling of Nene Park Academy up to the value of the budget sum of £8m, subject to the Council obtaining consent pursuant to section 77 of the School Standards and Framework Act 1988. This sum shall include the anticipated design and build contract costs and funding for Information and Communications Technology (ICT), site surveys, and technical advisers' fees.
- 2. Authorise the Council to award the design and build contract to Kier Construction Limited, subject to the recommendations of the value for money report.
- 3. Authorise the Council to enter into an Early Works Agreement with the contractor to undertake enabling works in advance of the main construction contract.
- 4. Authorise the Assistant Director for Legal and Governance, or delegated officers, to enter into any other legal documentation on behalf of the Council in relation to this matter, including the design and build contract and early works agreement.

1. SUMMARY OF MAIN ISSUES

- 1.1 This report seeks the Cabinet Member's approval to the recommendations to expand Nene Park Academy by 2 forms of entry (60 pupils per year group) with 100 additional sixth form places, from September 2018, to be phased over five years.
- 1.2 With the rise in the number of four year olds in the City, there are significant pressures within Peterborough primary schools, with the need for significant investment to meet basic need. The impact of this significant growth in primary age children means that this will

eventually put pressure on the Council's secondary schools too. Pressure for Year 7 places started in 2015 and will be critical by 2018.

- 1.3 A key priority for the Council is to provide local school places for children, and the Council is monitoring very closely the demographic trends, along with the growth in housing developments. The Council has analysed the postcode data of children entering our schools to ensure expansions are taking place in the right parts of the City. This data was used to validate the assumption to expand Nene Park Academy, and confirmed that expansion is required if places are to continue to be made available to local children.
- 1.4 A design control option for the expansion of Nene Park Academy was prepared by the NPS Group, Peterborough City Council's Joint Venture Partner, and this was presented to the Council in December 2016. This confirmed that the proposal to expand the Academy could be accommodated on the site without unduly affecting playing field space.
- 1.5 The expansion proposals will provide the Academy with a 3-storey extension, linked to the existing school, and some internal remodelling to provide general and specialist teaching spaces. Part of the new extension will be built on the footprint of existing old buildings that will be demolished.

2. PURPOSE OF THIS REPORT

- 2.1 The purpose of this report is to provide background information and seek the Cabinet Member's approval in relation to the recommendations.
- 2.2 This decision is proposed in accordance with the delegations for the Cabinet Member for Education, Skills and University exercising delegated authority under paragraph 3.4.6 and 3.4.8 (a) of Part 3 of the constitution in accordance with the terms of their portfolio at paragraph (b).

4. DETAILS OF DECISION REQUIRED

- 4.1 Due to Kier Construction Ltd's extensive knowledge of the Nene Park Academy site and buildings, having delivered the original Academy scheme, it is proposed that Kier Construction Ltd are directly appointed using the London Housing Corporation Framework to design and build the new and remodelled accommodation.
- 4.2 Schools and Community Buildings Framework allows Local Authorities to run a mini competition from the Framework to select a construction partner, or to use a direct selection and award process without re-opening competition. The Council is permitted to use this Framework. The Council has previously used the Framework to procure school new build and extension projects. The use of the Framework is significantly advantageous in terms of speed to financial and commercial close and to starting on site with a proven contractor and schemes demonstrated as being value for money. The LHC Schools and Community Buildings Framework (SCB1) was procured in accordance with the Public Contracts Regs 2006 and is an EU compliant framework arrangement that provides five main contractors. appointed on a regional basis, to deliver fast and flexible procurement for new build extensions, alterations and refurbishment works for all primary and secondary schools or other educational buildings. The Schools and Community Buildings Framework (SCB1) was effective from 1 July 2013 and has been extended to 30 June 2017. In view of the very successful experience of Kier delivering on previous schemes, as well as their extensive knowledge of the site and buildings from delivering the original Academy scheme, it is proposed to use the LHC Schools and Community Buildings Framework (SCB1) to select Kier Construction Ltd.

- 4.3 It is also proposed to enter into an Early Works Agreement with Kier Construction Ltd to undertake internal remodelling works during the 2017 summer break, and to provide the additional pupil 'drop-off' area, to take advantage of the school being empty during this time.
- 4.4 A budget of £8m has been set for this project. These funds are allocated against the Medium Term Financial Plan for the period 2017-2022.
- 4.5 The programme of works is scheduled to complete by September 2018, when the two additional forms of entry join the Academy.
- 4.6 The planning application was submitted on 13th March 2017 and, if required, is scheduled to be heard at Planning Committee on 12th June 2017.
- 4.7 In order to keep to the overall programme timescale, careful consideration has been given to the decisions that will be required to ensure probity in the process. The following milestones and dates should be noted:

5. CONSULTATION

- 5.1 The Principal, and the Academy Trust have been fully involved in the development of the specification and design for the proposed works.
- 5.2 A public consultation was held at the Academy on 15th February, where the designs for the extension and remodelling works were on display for the public, parents, pupils, staff and governors. The Ward Councillors were invited to the consultation. Although not well attended, the proposals were positively received by those who did attend.
- 5.3 Sport England was informally consulted during the early design stage and will be formally consulted through the planning application process.
- 5.4 The new buildings will be built upon hard and soft play areas, therefore consent is required from the Department for Education pursuant to Section 77 of the School Standards and Framework Act 1988. The application is being made by the Local Authority, as landowner, to the Department for Education.
- 5.5 Key stakeholder departments within the Council are fully briefed on the proposals. These include Planning Department, Strategic Finance and Legal Services.

6. ANTICIPATED OUTCOMES

- 6.1 Direct appointment of Kier Construction Ltd to design and build the extension and remodelling works at Nene Park Academy.
- 6.2 The programme anticipates completion of the works by September 2018, when the two additional forms of entry join the school.

7. REASONS FOR RECOMMENDATIONS AND ANY RELEVANT BACKGROUND INFORMATION

- 7.1 The impact of significant growth in primary age children is now putting pressure on the Council's secondary schools. Pressure for Year 7 places started in 2015 and will be critical by 2018.
- 7.2 A key priority for the Council is to provide local school places for children, and the Council is monitoring very closely the demographic trends, along with the growth in housing developments. The Council has analysed the postcode data of children entering our schools to ensure expansions are taking place in the right parts of the City. This data was used to validate the assumption to expand Nene Park Academy, and confirmed that expansion is required if places are to continue to be made available to local children.
- 7.3 As a result of the above, Nene Park Academy needs to expand by two forms of entry. To accommodate additional pupils, the following work will be undertaken:
 - construction of a new 3-storey wing, linked to the existing school, partial demolition and internal remodelling of existing buildings to provide specialist technology provision to extend the curriculum into light engineering, graphics, product design and the use of modern making techniques. The additional building space provides the rooms required for the delivery of English, Mathematics, Humanities, modern foreign languages and the use of IT across the curriculum.
 - ancillary accommodation such as office space, toilets, lockers and storage.
 - improved PE facilities and a new netball court which can also extend community use of the Academy's sports facilities
 - additional on-site student 'drop-off' facilities

8. ALTERNATIVE OPTIONS CONSIDERED

The following options were considered and rejected:

- 8.1 To do nothing this option was rejected due to the demand for secondary school places in the area and the Local Authority's statutory duty to provide sufficient school places.
- 8.2 To tender to the construction market for a contractor this option was rejected due to the timescales and costs of the tender process and the risk of the project not being completed by September 2018.
- 8.3 To run a mini competition using the LHC Framework this option was rejected due to the timescales of the tender process, but also to take advantage of the significant knowledge that Kier Construction Ltd already have of the Nene Park Academy site and buildings, having been the contractor on the previous Academy scheme.

9. IMPLICATIONS

- 9.1 The legal and financial implications of this Cabinet Member Decision Notice are set out in the main body of the report.
- 9.2 Environmental The specification for the works in the new build will include a sustainable approach to ensure that the building envelope meets current building regulations in terms of air quality, air tightness and energy efficiency. An ecology survey has been undertaken to ascertain the presence of species on site which may require appropriate mitigation.
