1. PURPOSE AND REASON FOR REPORT

- 1.1 The purpose of this report is for Council to appoint a Chair to the Appeals and Planning Review Committee and Vice-Chair to the Adults and Health Scrutiny Committee for the remainder of the municipal year 2022/23.

- 2.1 At the Annual Council meeting it is common practice for all Chairs and Vice-Chairs to be appointed for the municipal year, other than those which the Council has decided should be appointed by the Committee itself.

 - Councillor Qayyum to the position of Vice-Chair of Adults and Health Scrutiny Committee.
