1. PURPOSE AND REASON FOR REPORT

- 1.1 The purpose of this report is to advise Council of changes made to the Executive Delegations by the Leader and for Council to note these changes.

2. CHANGES TO THE EXECUTIVE DELEGATIONS

- 2.2 On the 18 September 2023 the Leader updated the Cabinet meeting with changes to his scheme of delegation.
- 2.3 The Leader has therefore made the following changes to his Cabinet appointments and scheme of delegations:
- The deletion of Adults and Public Health from the Leader's portfolio.
 - The addition of a new Cabinet Member for the position of Adults and Public Health which has been taken by Councillor Ishfaq Hussain.
 - Removing the Children and Education function from the portfolio of the Cabinet Member for Education, Skills and Children, this now to read Cabinet Member for Skills and Further and Higher Education, including the University.
 - The addition of a new Cabinet Member for the position of Children's Services and Education, to be taken by Councillor Jackie Allen.
 - Councillor David Over to move from 'Cabinet Advisor for Public Health' to 'Cabinet Advisor for Children's Services and Education'.
 - The merging of the Cabinet Advisor posts, 'Cabinet Advisor for Public Health and Cabinet Advisor for Adults Services' to 'Cabinet Advisor for Adult Services and Public Health, creating a deletion of a Cabinet Advisor post.
 - The deletion of the following Cabinet Advisor posts:
 - Cabinet Advisor for Culture and Communities
 - Cabinet Advisor for Legal Services
 - Cabinet Advisor for Corporate Services
- 2.4 These changes have been agreed by the Monitoring Officer as the changes to the scheme of delegations is within the remit of the Leader.
