i. <u>Third Report of the Peterborough City Council Independent Improvement and</u> Assurance Panel

ii. Budget Simulator Launch

iv. <u>Award of contracts for respite care & accommodation services for adults with learning</u> disability/autism in Peterborough

Officers across Cambridgeshire and Peterborough have been working on the bid for several months and, latterly, have been seeking legal advice on the Delegation and Collaboration Agreement and advice from democratic services including on the governance requirements some of which has taken longer than anticipated. The decision to enter into the contract, should it be awarded, will be put before the Cabinet Member. Recent advice has suggested that there should also be a cabinet member decision to cover the submission of the bid. It has therefore been necessary to submit this request.
