## 91. Mayor's Announcements

- 1. The Medium-Term Financial Strategy 2024/27, outlined in **Appendix A**, which included the key financial assumptions, strategic direction, and estimated budget gaps in future years, be **approved.**
- 2. The Budget for 2024/25, outlined in **Appendix B**, which included:
  - a) Funding and Council Tax Summary, which included a proposed Council Tax increase of 4.99% in 2024/25, 2025/26 and 2026/27;
  - b) Detailed Revenue budgets and proposal detail;

#### Questions from members of the public

## 1. Question from Collette Francis

Councillor Hiller, Cabinet Member for Housing, Growth and Regeneration.

Thank you Mr Mayor, I just wanted to firstly apologise for reading off my phone, my printer died.

So, the question I am putting towards council, is how much money is available either in held funds or government funding for either a replacement of the pool or refurbishment of the pool?

Given the regional pool's age, the building is unfortunately coming to the end of its life. Would the funds for refurbishment not be better spent building a new one better suited for the growing population of Peterborough.

Peterborough City Council have a real unique opportunity here. Since the regional was built, there have been great advances in technology. Peterborough City Council have the opportunity to build a bigger and better family orientated pool, much similar to the ones in other places, with a shift to greener building and technology with the use of heat pumps, living roofs, solar panels and all that.

The opportunity is there to include a replacement to the lost and vital hydrotherapy pool in the plans. This pool does need to be bigger than the one previously proposed by the previous administration.

Peterborough is an ever-growing city with many open waterways, so water confidence s vital in our city. Not only this, but by building bigger and better will also encourage people from outside the city to visit too; bringing much needed trade to our city centre.

If the funding for refurbishment at the Regional Pool is there, why not build new that will ast longer and better rather than sticking a plaster over a building that may not be fit for purpose much longer.

Understandably, Peterborough will be without a pool for some time, regardless of the choice made. So, let's take this opportunity now and look to the future.

#### The Cabinet Member responded:

thank Miss Francis for her question, albeit not the question that was originally submitted. Nevertheless, you've padded it out particularly well, I think.

Mr Mayor, I think the established view is that a new pool would most likely be funded from a combination of grant and private sector funding. Although, a formal decision is yet to be made about the future of the existing building, this council and our Peterborough First administration, is wholly committed to ensuring there is a fit for purpose, future swimming provision, for our residents and visitors; and that it is provided as soon as is practicable.

If a new facility is indeed decided upon Miss Francis, the funding level required really rather depends on the specification, land acquisition and the necessary planning and contracting infrastructure required for this project to happen. So, I hope you'll understand with the complexities that this will involve, I don't imagine anybody would be able to give you a specific figure at this very early stage.

A report is being presented to Cabinet in March and I hope you will look at that with great interest, I'm sure you will, you are nodding, to determine the way forward; and our officers are already exploring potential funding opportunities with both Government and the private sector. Thank you, Miss Francis, thank you Mr Mayor.

# Supplementary question:

Just wanted to thank you for your response to that, it was very informative. Can I just ask, would agree that Peterborough does need a pool?
