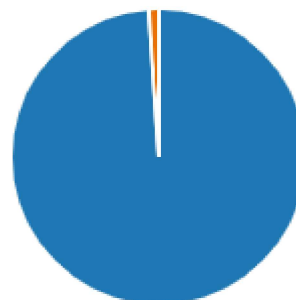

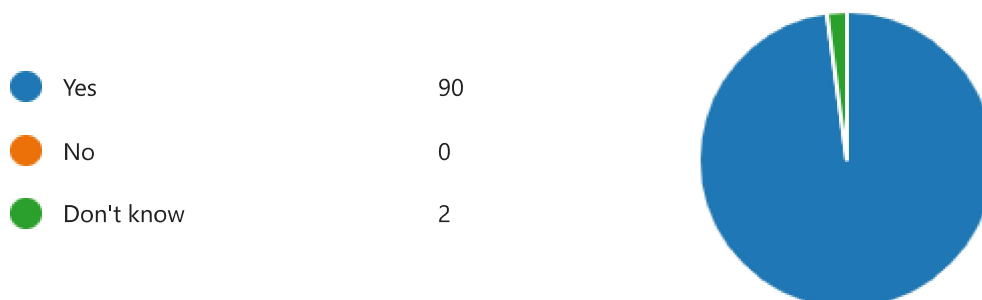

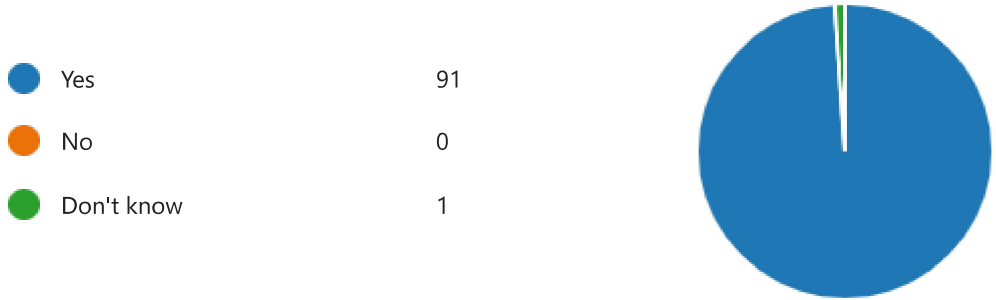
4. Do you support the use of the Millfield, New England, Eastfield & Embankment Public Spaces Protection Order to deter littering and spitting in the order area?



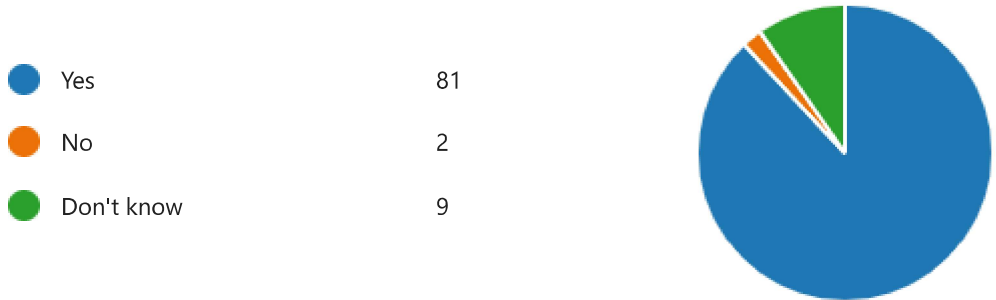

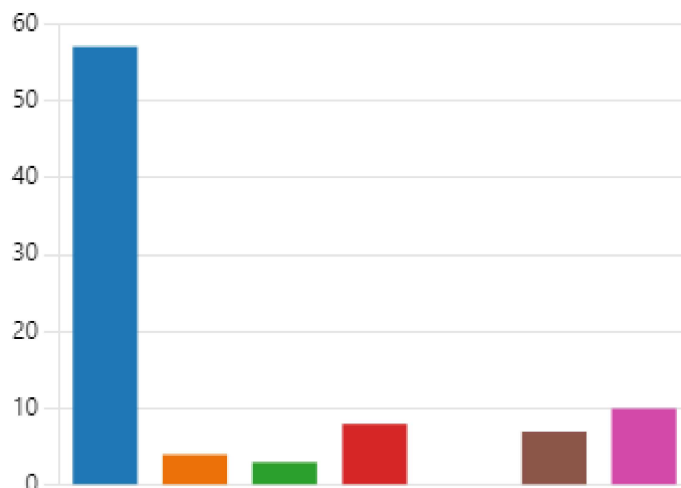
