## REPORT OF THE DEPUTY MONITORING OFFICER

# RECOMMENDATIONS

FROM : Deputy Monitoring Officer

That Committee Members:

- (1) Note and discuss the contents of this Report; and
- (2) Formulate any further recommendations as appropriate.

### 1. THE FORMAT OF THIS REPORT

- 1.1 This report contains the following item for consideration:
  - The majority agreement by Full Council on 26<sup>th</sup> July 2010 to move a motion and carry out actions and recommendations in relation to the future of the Standards Committee.

### 2. ITEMS FOR CONSIDERATION

- 2.1 At a Full Council Meeting on Monday 26<sup>th</sup> July 2010, Councillor Todd introduced the Annual Report of the Standards Committee on behalf of the Independent Chairman. The Report contained three Recommendations namely that Council:
  - (1) notes the work carried out by the Standards Committee and endorses and supports the priorities for the coming year.
  - (2) agrees to extend the maximum term of office to be served by any independent member to 3 successive terms; and
  - (3) agrees to extend the membership of the Standards Committee to include a further parish council substitute member and delegates authority to the Standards Committee to appoint to that position upon nomination by the Peterborough Association of Local Councils.
- 2.2 There were no movers of the recommendations in the Annual Report but instead Councillor Sanford moved recommendations that Council:
  - (1) Notes the work carried out by the Standards Committee;
  - (2) Agrees with Government's intention to abolish the current Standards Board Regime; and
  - (3) Agrees that the Standards Committee reduces its number of meetings so that it only meets to fulfil its statutory responsibilities until further legislation is passed.
- 2.3 Councillor Shaheed seconded the motion and following debate, a vote was taken and the recommendations from Councillor Sandford were carried, 31 in favour, 1 against and 6 abstentions.

- 2.4 The current statutory responsibilities of the Standards Committee are set out in the Local Government Act 2000 ("LGA 2000"). The following is of note.
- 2.4.1 Section 54(1) of the LGA 2000 sets out the general duties of the Standards Committee as follows:
  - (a) promoting and maintaining high standards of conduct by the members and co-opted members of the authority; and
  - (b) assisting members and co-opted members of the authority to observe the authority's code of conduct.
- 2.4.2 Section 54(2) of the LGA 2000 sets out the specific duties of the Standards Committee as follows:
  - (a) monitoring the operation of the authority's code of conduct;
  - (b) advising, training or arranging to train members and co-opted members of the authority on matters relating to the authority's code of conduct.
- 2.5 Members of the Standards Committee are invited to note and discuss the agreed recommendations of Full Council and having regard Section 54 of the LGA 2000 consider how to proceed.

### 3 IMPLICATIONS

3.1 There are no financial or legal implications, other than those contained within the body of the report.
