
- 3. A security alarm system will be fitted and maintained in working order.

- 6. Electronic shunt locks will be fitted to the shop door to enable staff to have control on who accesses the premises.
- 7. All spirits will be located behind the counter.


## **Public Safety**

8. Staff to receive training in fire safety and evacuation procedures and all staff to receive regular refresher training, which will be documented.

#### **Protection of Children from Harm**

- 9. Staff to receive full training in respect of age restricted sales and all staff to receive regular refresher training, which will be documented.
